**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 89,180/- only (Rupees Eighty Nine Thousand One Hundred Eighty Only) to National Law University Odisha towards **Third & Final Instalment** (towards cost of hard copies of Final Report, Courier Charges and travelling cost as claimed) out of the total project cost of Rs. 24,10,000/- (Rupees Twenty Four Lakh Ten Thousand Only) (non-recurring expenditure) for under taking research project titled "*A Comparative Analysis of Performance Appraisal Mechanisms and Schemes of Promotion in relation to the Judges of Subordinate judiciary in different States in India*" under the "*Scheme of Action Research and Studies on Judicial Reforms*" as per the terms of the agreement signed by National Law University Odisha and Department of Justice on 16<sup>th</sup> February, 2016. First instalment of Rs.4,82,000/- & Second Installment of Rs. 9,64,000/- were released to the National Law University Odisha, the implementing Agency *vide* this Department's sanction order of even no. dated 16<sup>th</sup> February, 2016 & 24<sup>th</sup> January, 2017 respectively.
