**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs.1,25,000/- (Rupees One Lakh Twenty Five Thousand Only) to Indian Institute of Management, Kashipur towards waiver of penalty (being 5% total project cost of Rs. 25,00,000/- deducted earlier for delays ) out of total project cost of Rs. 25,00,000/- (Rupees Twenty Five Lakhs Only) (non-recurring expenditure) for under taking research project titled "Performance indicators for subordinate courts and suggestive policy/procedural changes for reducing civil case pendency " under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by Indian Institute of Management, Kashipur with Department of Justice on 27<sup>th</sup> May, 2015. First instalment of Rs.5,00,000/-, Second Instalment of Rs. 10,00,000/- and Third Instalment of Rs. 8,75,000/- ( after deducting the above penalty of Rs. 1,25,000/-) was released to the Indian Institute of Management, Kashipur, the implementing Agency vide this Department's sanction orders of even no. dated 27<sup>th</sup> May, 2015, 21<sup>st</sup> June, 2016 and 14<sup>th</sup> March, 2018 respectively.

2. The expenditure involved is debit to Demand No. 61 during 2018-19 (Plan) under MH 2014-Administration of justice, 17-National Mission for Justice Delivery and Legal Reforms; 17.02-Action Research and Studies on Judicial Reforms, 17.02.50-Other Charges.
