
SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 10,00,000/- only (Rupees Ten Lakhs Only) to National Law University, Delhi towards **Second Installment** (being 40% out of the total project cost of Rs. 25,00,000/-) (non-recurring expenditure) for undertaking research project titled "Evaluation of functioning of Fast Track Courts in India- An Empirical Study " submitted by National Law University, Delhi vide Email dated 17.08.2018 (revised) under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by National Law University, Delhi and Department of Justice on 04th October, 2018.
