



SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs.6,00,000/- (Rupees Six Lakhs Only) to "Vidhi Centre for Legal Policy, New Delhi" towards Third Installment being 30% of total project cost of Rs. 20,00,000/- (Rupees Twenty Lakh only) for undertaking research project titled " Identifying the causes and finding solutions for delay in disposal of criminal appeals" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by Vidhi Centre for Legal Policy and Department of Justice on 28th October, 2020. First and Second installment of Rs.4,00,000/- (Rupees Four Lakh Only); Rs. 8,00,000/- (Rupees Eight Lakh only) respectively have been released to the implementing Agency vide Orders of even no. dated 28.10.2020 and 09.02.2021.
