We had released Rs. 150 lakh first installment to NJA, Bhopla during first quarter (April-June,2020) Current Financial year vide our sanction order dated 18.05.2020. Other request of the Academy, Rs. 300 lakh has also been released to NJA, Bhopal for the second quarter (July-September,2020) which were disbursed in three installments during during July, August and September Rs. 100.00 lakh in each month i.e. second, third and fourth installments. National Judicial Academy, Bhopla has requested for release of funds of Rs. 300.00 lakh, but IFD only concurred 100.00 lakh to the month of October, 2020 as fifth installement and 200.00 lakh as sixth installation to the month of November and December, 2020.
