The BE 2020-21 for grant in aid general to National Judicial Academy is Rs. 10 crores. Already a sum of Rs. 1.50 crores released in the first quarter for which a UC has been furnished by the Academy. The academy has sought for Rs. 3 crores now stating that it is for meeting essential committed expenditure which is reportedly Rs. 1.19 crores per month, basically for payment of salaries to staff including outsourced personnel, electricity charges, payment to service providers etc.

2. Since Rs. 3 crores sought will cover for about 3 months exp, we may advise DOJ to release Rs. 1 crore each for the months of July, August and Sept, 2020 as otherwise release of Rs. 3 crores would lead to parking of funds, which as per the MOF guidelines we have to avoid. The PFMS data may be monitored to ensure that the funds are properly utilised.
