


SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs.5,69,672/- (Rupees Five Lakh Sixty-Nine Thousand Six Hundred and Seventy-Two Only) to "National Law School of India University, Bengaluru" towards Final Instalment out of the total project cost of Rs.18,79,100/- (Rupees Eighteen Lakh Seventy Nine Thousand and One Hundred only) for undertaking research project titled "Study the impact of Litigation on Public Infrastructural Projects" being conducted by National Law School of India University, Bengaluru under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by National Law School of India University, Bengaluru with Department of Justice on 26<sup>th</sup> March, 2019. 1<sup>st</sup> instalment of Rs. 3,75,820/- (Rupees Three Lakh Seventy-Five Thousand Eight Hundred and Twenty Only) and 2<sup>nd</sup> instalment of Rs.7,51,640/- (Rupees Seven Lakh Fifty-One Thousand Six Hundred and Forty Only) were released to the implementing agency vide order of even no. dated 26.03.2019 and 23.12.2019 respectively.
