


SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs.2,04,000/- (Rupees Two Lakh & Four Thousand Only) to National Law University Delhi towards **Second Installment** (being 40% of total project cost of Rs. 5,10,000/- (Rupees Five Lakh Ten Thousand only) for undertaking research project titled "The Commercial Court Guide ( India) 2021" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by National Law University Delhi and Department of Justice on 7<sup>th</sup> June, 2021. 1<sup>st</sup> installment of Rs. 1,02,000/- (Rupees One Lakh Two Thousand Only) has been released to implementing agency vide order dated 11.06.2021. The implementing agency is requested to adhere to the timeline mentioned in the approved proposal and agreement dated 07.06.2021.
