*Dear Chief Secretary,*

As you are aware, the Department of Expenditure, Ministry of Finance, through Letter No.1(13)PFMS/FCD/2020 dated 23.03.2021, has notified a new procedure for release of funds under Centrally Sponsored Schemes (CSS).

2. As per the new procedure, the Central share of funds for a CSS, released by the Government of India to the Consolidated Fund of the State, should reach the Single Nodal Agency (SNA) account in 21 days. A check has been operationalized in PFMS that if a previous installment of Central share released by the Government of India has not reached from State Treasury to SNA's account, sanction order for subsequent installment of Central share will not be generated.

3. You would appreciate that integration of State Treasury with PFMS as per the new procedure is of utmost importance to correctly reflect the transfer of CSS funds from the State Treasury to the account of the SNA concerned. A lack of updation of information in PFMS by the State Treasury may result in display of incorrect picture in PFMS reports, leading to non-release of Central share of funds to the State. State-wise status of integration of State Treasuries with PFMS is attached.

4. Therefore, to ensure continuous and seamless transfer of Central share of CSS from Ministries/Departments to the State Treasury and smooth implementation of Schemes, you are requested to ensure full integration of State Treasury with PFMS as per the new procedure and updation of information from State Treasury to PFMS on a daily basis.


