Sir,

I am directed to convey the sanction of the President for the payment of Rs.32.50 lakh (Rupees Thirty Two Lakh and Fifty Thousand only) of fund for the FY 2022-23 as Central assistance to the Government of Maharashtra for continuation of one (01) Special Court set up for trial of criminal cases involving MPs and MLAs of Maharashtra.

2. The expenditure involved is debitable to Demand No. 65 during 2022-23 (Non-Scheme) Major Head 2052-Secretariat General Services-090-secretariat, 08-Department of Justice, 08.00.31-Grant-in-Aid.

3. The State Government is requested to utilize the amount for operational expenses of the Special Court in order to dispose of the criminal cases pending against the MPs/MLAs. The detail of the amount spent by the State Government alongwith audit certificate and utilization certificate in the prescribed format (GFR-19 A) duly signed by the competent authority may please be sent to this Department at the earliest by the end of the stipulated period in this regard. (The UCs with regard to the utilization of the earlier releases and this release shall be furnished to this Department within the stipulated time.)

4. The accounts of the State Government in respect of the fund being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts office of the Department of Justice, whenever the State Government is called upon to do so.

5. The Sanction has been entered in the Register of Grants at Serial No. 04 Page No- 01.

- ii. As per the above mentioned rule any Institution or Organisation seeking Grants-in-aid from Government will be required to submit an application which should clearly spell out the need for seeking Grant. This may please be provided.
- iii. Type of grant (recurring or non-recurring) may be mentioned.
- iv. The rule 230(1) also states that **The Institution or Organisation seeking Grants-in-aid should also certify that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.** "Such a certification may also be provided.
