Strength of Judges in the Supreme Court and High Courts

268. DR. NARENDRA JADHAV:

Will the Minister of **LAW AND JUSTICE** be pleased to state:

- (a) the details and number of vacancies of Judges in the Supreme Court and High Courts against the sanctioned strength, State-wise details of High Courts thereof;
- (b) the total number of SC/ST/OBC Judges in the Supreme Court and the percentage of representation of SCs/STs and OBCs; and
- (c) the details and number of SC/ST/OBC Judges in High Courts across the country, State-wise details thereof with percentage of SCs/STs and OBCs representation?

ANSWER

MINISTER OF LAW AND JUSTICE

(SHRI KIREN RIJIJU)

(a): As on 28.01.2022the number of vacancies of Judges in the Supreme Court and High Courts against the sanctioned strength, State-wise details of High Courts is provided at **ANNEXURE.**

(b) to (c): Appointment of Judges of the Supreme Court and High Courts are made under Article 124, 217 and 224 of the Constitution respectively. These Articles do not provide for reservation for any caste or class of person including women. Therefore, no caste or class-wise data of Judges is maintained. However, the Government is committed to social diversity in the appointment of Judges in the High Courts and has been requesting the Chief Justices of the High Courts that while sending proposals for appointment of Judges, due consideration be given to suitable candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Minorities and Women.
