Cases pending in Lok Adalats across the country

1067 Shri Mahesh Poddar:

Will the Minister of Law and Justice be pleased to state:

- (a) the total number of cases pending and resolved under Lok Adalats in different parts of the country, if so, the details thereof, State-wise, especially with respect to the State of Jharkhand;
- (b) the number of functioning Lok Adalats in the country, if so, State-wise details thereof; and
- (c) the steps being taken by Government to promote the establishment of more Lok Adalats in the country, the funds allocated and spent during the last three years, the details thereof?

ANSWER

MINISTER OF LAW & JUSTICE (SHRI KIREN RIJIJU)

(a) to (c) Lok Adalat is an important Alternative Disputes Resolution Mechanism available to common people. It is a forum where the disputes/cases pending in the court of law or at pre-litigation stage are settled/compromised amicably. Under the Legal Services Authorities (LSA) Act, 1987, an award made by a Lok Adalat is deemed to be a decree of a civil court and is final and binding on all parties and no appeal lies against thereto before any court. In order to reduce the pendency of cases in courts and also to settle the disputes at pre-litigation stage, Lok Adalats are organized by Legal Services Institutions at such intervals as it deems fit. Lok Adalat is not a permanent establishment. However, as per Section 19 of the LSA Act, Lok Adalats are organized by Legal Services Institutions as per requirement. National Lok Adalats are organized simultaneously in all Taluks, Districts and High Courts on a pre-fixed date. In addition, Section 22B of the LSA Act also provides for establishment of Permanent Lok Adalat by every State Authority to deal with cases of public utility services at pre-litigation stage. 357 Permanent Lok Adalats are functioning in various States & UTs. State-wise Permanent Lok Adalats and cases settled is at Annexure-A. State-wise cases settled (both at pre-litigative stage and pending cases) by State Lok Adalats and National Lok Adalats during the last three years is at Annexure B and C respectively.

To facilitate access to justice during COVID times, the Legal Services Authorities have ingeniously integrated technology into conventional methods of justice delivery and moved Lok Adalat to the Virtual Platform on 27.06.2020. From June, 2020 to December, 2021, more than 23.47 lakh cases have been disposed of by these E-Lok Adalats.

Allocation of funds to State/UT State Legal Services Authorities is made for all activities including expenses to be incurred in organization of Lok Adalat and E-Lok Adalat. Separate fund is not allocated for organization of Lok Adalat and E-Lok Adalat. The funds allocated by the Government and utilized by National Legal Services Authority (NALSA) during the last three financial years is as under:
