MIHEMTE THANEINA (RIGHTS) HUHBITNA DINGA ACT,1993 A KISEMDOH

(THE PROTECTION OF HUMAN RIGHTS ACT, 1993)

Thumakai: (Introduction)

Mihemte thaneina Huhbitna dinga Pakai kum 1993 a kisemdoh Act chu chepi thei dingin nisim 28 September, 1993 chun ahung umdohtan ahi. Hiche hin National Human Rights Commission, State Human Rights Commission leh Human Rights Courts chuleh hiche thu leh thilsoh akisamkai paho aphajo cheh'a huhbitna aumtheina dingin daan in aphalpeh cheh un ahi. Hiche Act hi Jammu leh Kashmir panna'a India gam pumpi a chepi ding ahi.

Doi Le Tup: (Aim and object)

16th. December, 1966 a United Nations General Assembly a kinoptona dunguija India gam hi International Covenant on Civil and Political Rights chuleh International Covenant on Economic, Social and Cultural Rights a kiloikhomna'a pang ahi. Hiche Covenants kiseiya hi mihem te thaneina hi daan in aveenbit ding ti panga ahi. Hinlah, hiche mihemte thaneina kiti chungchang'a hin gam tampi lungsung boina khat asodoh in ahi. Kiloikhomna sunga umdaan kikheel jing toh, khan gitlouna leh phat mona akhan jingtoh lungputna kikooya, Government in aphant leh thilsoh dunguija aphacheh aum theina dingin aumsa daan holeh thudih'a kivaipohna a daan ho veelvetna aneilha jingun ahi. Hiche chungchanga hin hop lentah'a kihou khomna leh seikhomna gamsunga munchom munchomma Chief Ministers' Conference chuleh political parties lamkai ho'n seminars chuleh kimuto'a kihou khomna anejingun ahi. Hiche kihoukhomna'a lunggel kipetoho chu alah khom uva Central Government in Mihemte Thaneina (Rights) Huhbitna dinga Act, 1993 hi daan a dinga ahinpoh doh u ahi. Hiche Act in adoi leh atup pipen chu mihem ho chunga khansetna (violations) ho veentupna ding hi ahipeenne. 'Mihemte Thaneina' kiti nahi hinna ding, chamlhatna, chan le vou va taanggolla kibang ding, mihem khat hina changvalla jana hohi International Covenants a kinoptona dunguija daan in ajui ding tihi ahi. Mihemte Thaneina kitih mihem jouse chamlhatna a thaneina tina ahi. Hiche thaneina kipohdoh lona hi mihem khat ahindan akhantou theina dingleh ama changvalla jong ami hina jong akhantou theina ding chuleh hiche thaneina hi apalkeh gohoa konna huhtup ding ti ahi.



National Human Rights Commission:

Hiche Act noiya hi ‘National Human Rights Commission (NHRC)’ hi Central Government natohma leh thajena aneiding ahi. Hiche Commission sunga hi Chairperson leh members sagi (7) umding ahi. Chairperson hi Supreme Court’ a Chief Justice tohmunna konna kichooldo mi hiding, members ni (2) hohi Supremeourt a Judge ahilouleh High Court’ a Chief Justice panmun na konna kichooldo ho hidiu ahi. Members ni (2) dinghi mihemte thaneina chungchanga tohmunna konleh hetna nei mi lah’ a kipansah ding ahi. Hitiho chungchonna Chairperson, National Commission for Minorities, National Commission for the Scheduled Castes, National Commission for the Scheduled Tribes chuleh National Commission for Women hohi hiche Commission a Ex-officio Members hidiu ahi.

- Commission sunga hi Secretary-General umding, amachu Commission a Chief Executive Officer hiding ahi.
- Hiche Commission headquarter hi Delhi hiding ahi. Hinlah Central Government noppehna noiya India gam munchom chomma jong office dangdang jong tundoh thei hiding ahi.
- Commissson a Chairperson leh members hohi Act in aphal dunguija Committee kisemdoh holeh India President pu in alhendiu ahi. Chief Justice of India toh kihoumatna jouteng lebou Supreme Court a Judge a pang khat ahilouleh Chief Justice of High Court hi lhenthei hiding ahi.
- Chairperson leh members ho phat hi kum nga (5) sung ahilouleh amaho kum somsagi (70) amasa johjoh hiding ahi. Member khat chu avella kum nga (5) dinga lhen kit thei ahi.
- Commission hi amahon phante ati bang uva chepi thei kisemna tha aneijun ahi.
- Central Government in Commission sunga Secretary General, police leh asungthu Kholtok na mi aumsah jingthei ahi. Central Government in Commission sunga angaichat dunguija kivaipohna lam hihen, technical leh scientific staff alhenji thei u ahi.

National Human Rights Commission (NHRC) Natoh leh Thaneina ho :

Hiche NHRC hin anoiya kipe hohi khat penpen hihen aboncha hijongleh abolthei u ahi:

- NHRC hohin amaho macham hihen, mihem khattou ahilouleh thakhella khattouvin ahilouleh



- Court thupeh dungjuiya anoiya kipeho banga lungcham kimlouna nei aum leh akholtoh theiyu ahi. mihemho thaneina kipalkeh ahilouleh khan gitlouna ho; ahilouleh japi lhacha'a pang khat in mihemho thaneina kipalkehna chunga nahnah louva kikoi;
- Mihemho thaneina chunga thildihlou chuleh Court'a achungthu khongaisotna chunga Court phalpehna dungjuija akhut'u athillut theiyu ahi;
- State Government vetsuina noiya um mihemho lamchom chomma kihenden – songkul hihen, damlou kijen, hinkho kisem phatna dinga kikooho hijongleh ahindaan'u leh achungthu u kholtob'a chuleh Government komma hiche chungchang thu'a thulhut aneitheiyu ahi;
- Mihemho thaneina huhtupna dinga Daanpi kisem holeh daan ho akichepi jing hohi avelvet uva asanga phacheh lampi amudoh ho apohdoh theiyu ahi;

- Mihemho thaneina chungchanga kholchilna gil nei leh vettupna neiding;
- Kiloikhomna jat chom chomma mihemho thaneina hetthemna thejalla chuleh hiche thaneina huhtupna aumtheiye ti thu jonghi lamchom chomma mipi hetna aumthei nadinga kholhang sapding ahi;
- Mihemho thaneina hongsunga natong jat chom chomleh N.G.O. (non-governmental organisations) ho kipeina hohi tilkhous ding;
- Mihemho thaneina huhtupna chungchanga ngaichat natoh ho jouse toh.

Kholchilna neina lamma Thaneina:

Hiche Act toh kisaiya lungkimlouna thulhut kholchilna lamma NHRC in civil court'a, Code of Civil Procedure, 1908 noiya adeh'a anoiya thu kipeho chungchanga hi thaneina lhingset anei ahi:

- achungthu hetoh'a pangho chungchang kitepna neisah achungthu kholtohna dinga kouna aneitheiyu ahi;
- lekha angaicha ho holdoh naleh pohdoh na jong neithe;
- photchetna lekhaho (affidavits) alahtheiyu;
- public record bu hihen, ipi court leh office hijongleh ngaichat dungjuiya amutheiyu;
- hettohsa a pangho leh lekha ho vetchilna dinga lekha pethei.



Achedaan (Procedure)

Mihemho thaneina palkeh'a aumma lunglhai louna thulhut aumteng NHRC in achungthu kholchilna aneiteng Central Government hihen State Government hihen itobang thaneina nei leh kiloikhomna amaho sanga dinmun nemjo hochu aphat teppeh sunga akou theiyu ahi. Hinlah aphat kah'a achungthu tandinga lom Government hihen thunei vaihomhon kikumlut jeh'a lunglhaina abaan ima bolkhoh angaitah louleh, hiche thu chu kisei talou ding chuleh alungkim lou mi chu ahidung juija hetsah ding ahi. Hinlah, aphat kiteppeh dungjuija ima thulhut akimu louva, chuleh ngaichat ahileh NHRC in hiche thu'a kholchilna amasot diu ahi.

Koi tobang hiche thu'a natkha leh ahina kitong khathei aumleh ama leh ama them akichan theina photchetna phat kipe ding ahi. Kholchilna dungjuija mihemho thaneina palkeh akimu dohtah leh, NHRC in hitobang mi ahilouleh miho chunga gotna pehding daan lampi apeh theiyu ahi. NHRC in lampi dihtah leh thupeh dihtah umtheina dinga Supreme Court hihen

High Court hijongleh ajot theiyu ahi. Hiche a thohgim thohho ahilouleh a-innsung mite apet petna hinkho oolna thei (relief) akisamkaipi Government henga angehtheiyu ahi. Hiche aki kholchilna thulhut lekha kibang chetkhat chu lungkim louva lekha septe ahilouleh ama/ho thakhelho chu pehding ahi. Hiche kholchilna thulhut lekha leh itilam dolla thutan lhahna umding ti hohi NHRC in akisamkaipi Government ahilouleh thuneiho jong lha khat sung ahilouleh akiphalpeh phat sunga apeh'u ngaiya ahi. Hiche lekha hohi NHRC in japi hetdinga aphonjal diu ahi.

Manchah Thahatna toh kisamkaiya Kholchilna (Inquiries involving Armed Forces)

Mihemho thaneina manchah choiho'n apalkehnau chungchange lunglhai louna thutoh kisamkai ahiteng, Commisssion hin amaho macham ahilouleh lekha hung kisep aumkhah leh, Central Government a konna thupeh athum diu ahi. Hiche thupeh amujou teng uleh lungkim louna jeh a lekha hung kisep chu chepi pai louva Central Government komma apeh lhah theiyu ahi. Lha thum sung ahilouleh Commission in aphalpeh dungjuija phat alah sao jep u jongleh ichangeiya atohdoh u tuhi NHRC komma thulhut aneidiu ngaiya ahi. Hitobang thulhut leh achungthu a na kitong hohi NHRC in japi masanga aphonjal diu ahi. Chujongleh lekha seppa ahilouleh thakhella um ho jong hiche thulhut hi apeh diu ahi.



State Human Rights Commission

- State Hunan Rights Commission sunga umding ho:
 - (a) Chairperson – High Court a Chief Justice a ana pangsa;

 - (i) State Human Rights Commission in kumlhun ahilouleh thuphon thupi aumleh State Government komma apeh jing ding ahi;
 - (ii) State Government in jong State Humnan Rights Commission ho thulhut chungchanga na kitong dohho ahilouleh akitohdoh louna ajeh hohi kumlhun ahilouleh atumbeh'a thulhut aneiji diu ahi.



Mihemho Thaneina Court ho (Human Rights Courts)

State Government in district jouse'a High Court a Chief Justice toh kinopto a Mihemho Thaneina aumkhahleh thutanna aumtheina dinga Mihemho Thaneina Court tia akoi diu ahi.

State Government in Mihemho Thaneina Court jouse'a thutan dinga : (i) Government thakhella daan toh kitoh'a thutan khat anganse ding, ahilouleh (ii) Ukil khat apansah ding ahi.

Lhahsamna phabepho (Limitations)

- NHRC in anoiya kipeho'a hin ipi thu hijongleh thaneina ajeplut thei pouve:
 - (a) phat masa'a ana kivochon ho
 - (i) State Human Rights Commission ahilouleh
 - (ii) ipi Commission hijongleh daan khat noiya phatecha ana kisei chai; chuleh
 - (b) hiche act hung kiphondoh a patna kum khat ahung valleh.

Atumbeh'a thukhol loihon phabep kitungdoh (Constitution of special investigation teams)

State Government in police offers ho panna in atumbeh'a thukhol loihon khat ahilouleh saanga tamjo tundohna tha anejun ahi. Hiche hohin aboldiu chu :

- (i) thukhol chilna chuleh
- (ii) mihemho thaneina palkeh ho gotna chansah ti ahi.



DANDIHLOU SUMKOLVEI (KHAMNA) DAN, 1956 [THE IMMORAL TRAFFIC (PREVENTION) ACT, 1956]

THUMAKAI:(Introduction)

Dandihlou Sumkolvei (Khamna) dan, 1956 hi abul'in Numei le Numei Chapang dandihlou sumkolvei suhnemna, 1956 (Suppression of Immoral Traffic in Women and Girls/SITA, 1956), anahin hiche hi International Committee (Khoppi), New York khopi'a Lhaphul 9th, 1950, a dandihlou sumkolvei khamna ding'a kilolna dunguija dan kisem juina chu ahi. Hiche 01-05-1958 in ahung kichepi panin ahi.

ADOI LE TUP: (Aim and object)

Gam themkhat nin, a dan uva dandihlou sumkolvei suhnem na natoh a lhungsoh in ahin adoi le tup kibol chu akibang sohpon chuleh saotah chepi jouna ahipoi. Gam tamtah'in chitobang'a dan semna/chepina aneipoi. Kibah sohna le lunglhah sohna ding jeh'in, India gam Danpi semna (Parliament) in Numei le Chapang dandihlou sumkolvei (Khamna) Dan, 1956, Immoral Traffic (Prevention) Act, 1956 ti in 1986 ana kisem pha in ahi. Hijongleh, amin put hi dandihlou mihem sumkolvei akiti vang hin, hiche hin aphal lou thil aum'e tichu kitimat dihlou sumkolvei ahilou leh numei kijoh chuleh koitobang hiche kitimat dihlou sumkolvei'a pang/akithopi ahi louleh numei kijoh'a hinkho mangho gotna ape in ahi. Koitobang hiche'a vangsetna toh ahi louleh akitongkha ho kisemthah/kisemphatna thei inmun a akivengbit sahdoh tundoh'a gam vaipo ahi louleh Sorkar in achalai ding ahi.

Hilchet ledohna: (Definition)

Hiche dan dijeh-

Numei phalou umna tichu in khat pou pou, in dan (Room), thilpo/mun (Place) insung'a mun khat, dansung'a munkhat ahiloule mun khat pou pouva dandihlou kitimatna mun na kibol ahi louleh mikhat kitongkha/kisukha ahi louleh mini chungtam kikah'a phatchomna mu numei kijoh ho, chule "Numei kijoh hina" hi kitimat dihlou/mi sumle pai dijeh'a le kitongkha ahin, mihem hiche jeh'a kitongkha/kisukha sum le pai phatchom na ding jeh hochu "Numei kijojoh" ahi.



Numei kijohna mun bolsah/thil le lo phaldoh jeh'a gotna kipeho" (Punishment for keeping a brothel or allowing premises to be allowed as brothel)

 - (b) dettah'a songkul tanna kumni (2) chunglang'a pat kum nga (5) chan gei chuleh dangka sangni (Rs. 2000/-) leosah na anina a akimatna leh abangkit langa kimatna ho
2. Mi koitobang in san'a um, inlo (House rent) mi, in a cheng ahiloule thil le lo vetup dinga kinganse hon aman/abol ahiloule henasa mansah/bolsah'a numei kijohna, koitobang thil le lo neipa/neinu gou san mi, ahi loule in neipa akiloipi hon, akiboi nao min'a ama hetna'a hitobang numei kijohna bolsah ahiloule asatah'a hiche kiloikhom na a panga absah jeh'a, ama jong gotna chu songkul tanna kumni chan chuleh leona panna dangka sangni (Rs. 2000/-) akimat masatna'a atoding chule songkul'a namdetna kum nga chuleh leona panna anivei kimatna leh abangkit na akimat na ho'a kipe ding ahi.

Hinna dinga Numei Kijohna bol'a natongho Gotna- (Punishment for living on the earnings of prostitution)

Mi koitobang kum 18 chung lam hi'a henasa'a na tong nga mikhat kihjoh/akijoh ho gotna chu songkul'a tanna kumni chan chule leona dangka sangkhat(Rs.1000) ahi louleh achunga kisei teni ani tah'a gotna kimat sahna. Hijongleh, hitobanga sumholna chu chapang akum lhomcha ahi khah le, hiche boldoh natong chu songkul tanna kum sagi (7 years) apat kum som (10 years) chan hiding, hiche'a hi koitobang kum 18 chunglam mi in

- (i) hinna'a aneija ahi loule ngaina'a numei kijoh ho akiloipi/akivoppi a,
- (ii) amaho lah'a na atoh, tha neina, puihoina leh goljona'a Numei kijoh ho sinsahna anei
- (iii) amaho'a dinga thil choipeh, chohsah chule atoh khompi di mi holpeh le hojong henasa'a numei kijoh na sumkolveina a pang phalou natohna a natong'a hinna nei'a kigel ding ahi. Ahin, hitobang lunggel chansahna chu akinel ahi loule akinom jipoi.



Mi holna, bolsahna leh kouna; Numei kijohna ding jeh- (Procuring, inducing or taking person for the sake of prostitution)

Mi koitobang hiche natoh nadinga mi holla chuleh bolsah'a numei kijoh theina, ahiloule apang, asodoh sah leh ajao sah a numei kijoh nathei ding bolmi hochu gotna kum thum (3) apat kum sagi (7) songkul'a tanna leh Leona dangka sangni. Engset dan sukhel na khat chunga asosah le, hiche thilgon neinu le neipa chu gotna kum sagi(7) apat kum 14 chan songkul'a tang dendi chuleh dangka sang ni (Rs. 2000) a kileosah ding ahi. Hiche vangsetna toh chu chapang ahile, dan sukhel nu/pa chu songkul'a kum sagi (7) apat ahinkho lhumkeija tangden ding ahi.

Numei kijohna immuna mi tangden. (Detaining a person where prostitution is carried on)

Mi koitobang in midangkhat Khamna/soldoh louna, hiche numei kijohna ahiloule hiche athilbolnao munkhat pou pouva aumle, amanu/amapa mi tandem sah chu songkul'a tandenna kum sagi (7 years) apat hinkho lhumkeija umdi; ahilouleh songkul'a kum som (10 years) tangding chuleh leuna panna abolding ahi.

Numei kijoh na mipi umnalah leh akom vella umna: (Prostitution in or in the vicinity of public places)

Koitobang mi numei kijohna boll eh koitobang akijoh hettheina munho ahilou le mipi umna tichu, mipi Pathen houna mun, themjilna, hostel (kijilna mun), hospital in (kijenna mun), nursinh home, le adang dang a kon'a metre 200 sunga aum khah le gotna songkulla tandenna lha 3 (three months) changing. Hichea thilsoh hoilou chu chapang le kum lhung lou ho chung ahileh songkulla kum 7 apat hinkho lhum keija tangding ahilouleh kum som (10 years) songkulla tanna leh leuna panna changding.

Mi koitobang mipi kititna umna ho ngansena change numei kijoh na dia phalna pe ahiloule amaho umsahden, mi in'a cheng, insanho, innum ho leh mi umnaho vetup le chinghoi hia numei kijoh umsah ahiloule thil le lo ho nei, in neipa le aki nganse pa in hiche dandihlou numei sumkolvei phalpeh leh amaho kiloikhom na'a alungcham ma panla michu gotna songkul'a tangdenna lha thum le Leona dangka jana toh hithading ahi. Tekah banga mipi kititna/umna chu Gena touna mun ahi khah leh, hiche in a Licence phalpehna lekha chu lha thum apat kumkhat chan kikah thei chuleh hiche thil hoilou chu chapang le kum lhunglou lai ho chunga asokhah leh amaho phalna lekha chu akum tonga dinga kikah lha pai pai ding ahi.



Mi kijoh leh kikouva numei kijoh sumkolveina ding hi dan sukhelna ahin hijeh'a chu gotna songkul'a tangdenna chu lha gup chan hithei ahilou le Leona chu dangka janga chan ahi. Hiche dan sukhelna chu Avella abol leh songkul'a tanna chu kum khat chan shuhsao be leh Leona umdi ahi.

Hiche dan sukeh'a chu numei ahileh, thu tanna in, ama nu chu songkul tanna sanga kisuh jangna leh kisemphatna in a kum ni apat kum nga suhsao bena thei thuphon anei thei ahi. Hijongleh, lha gup joule, Gam kivaipohna/state sorkar in amanu chu kijilna'a konna asoldoh thei ahi. Amahon alunghai uva, ama nun hinkho phalna leh khantou na natoh lampi neijinte tia agel diu ahi.

Numei kijohna mun le dan sukeh ho umna suhmang na thu: (Closure of brothel and eviction of offenders from the premises)

SPECIAL MARRIAGE ACT, 1954

(Deisah tah Kichen)

Special Marriage Act, 1954 (Deisah tah Kichen) hi India parliament in India a cheng mi ho hihen gamdanga (Foreign) cheng India mi ho koi hileh pao le ham kiba ng lou leh hou le bih kibanglou hijong leh khentum neilouva kicheng to thei hina ding gelkhoh na ‘a hiche dan hi kisem ahi. Hiche hi adeh a nam chom chom le Hou (religion) chhom choom ho in kichen to nathei dinga thilgon ahi. Hiche dan hi 01-01-1955 nikho a patna hung kichepi ahitai.

Aim and Object (Doi le tup)

Eiho society sunga hin nam chom, pao le ham kibanglou le hou kibanglou akichen ding hi koiman ajah nom beh lou ahi. Marriage Officer pan hiche nia pat na ni 30 chan sunga koi hijong leh hiche dan kitoh lou tichu- akicheng ding teni chu hiche Special Marriage dan noija kichengthei dinga lom ahipoi ti ahedoh aum leh doudalna (objection) abolthei ahi. Itiham khat na koitobang objection bol aum khah tah leh Marriage Officer pan akholchil ding chuleh ni 30 sunga thulhah na aneiding ahi. Ahin ima aboina amudoh lou vang leh kichenna kin chu chelh thei ding ahinai. Amavang boina ima umlouva kichenna kin chu lha 3 sunga akiboldoh lou khah tah a ahileh apha kiteppah phatchu kichai ding ahitai. Chuteng athah a hetsah na anei kit uva chunga kisei dan ho hi Avella ajuiphat kit diu ahitai. Hiche kichenna kinbol hi akichengte nin Marriage Officer pale witness 3 masanga hitia hi aseiding “ I (A) take the (B)- (Keima A in B) hi dan in aphal dungui jin Kajinu/kajipa in kasang tai” ati cheh hon ding ahi. Kichen’ a kin hi akibolchai teng leh Marriage Officer in Marriage Certificate Book sunga amin nu jihlut ding, akicheng teni leh ahettoh peh(witness) thum (3) hon khuthenna (sign) abol chhe diu ahi. Hiche a kichenna lekha (Marriage Certificate) hi hiche Act, noi ja kichenna ahitai ti aphot chet na ahitai.

PROCEDURE FOR REGISTRATION (Min khum na ding dan)

Hiche Juvenile Justice (Care and Protection of Children) Model Rules, 2016 hi phatah le kisuhtah a daan kisem achetoh theina dinga kisem ahi.

Juvenile Justice Act 1986 chu Central Government in India pumpia chesah na aneija chule chapang ho daan (children Acts) jong athah sem ahi. India government in Convention on the Rights of the Child, 11th Dec. 1992 anakibol chunga anopna aneijin chubannin Juvenile Justice Act 1986 chu akheldoh in tun Juvenile Justice (care and Protection of children) Act, 2000 tin akihei. Hiche Juvenile Justice (Care and Protection of Children) Act, 2000 hi 2006 le 2011 a chun deibangtah a alolhin theina dingin thahsem in aume.

for the Protection of Juveniles Deprived of their Liberty (1980), the Hague Convention on Protection of Children and Co-operation in Respect of Inter-country Adoption (1993), le adang dang vannoija kisem hitobang thaneina manchahho ahi.

JUVENILE JUSTICE BOARD (JJB)

State government in district jousea Juvenile Justice Board hi thaneina apeh a chule tohding kin ho tongdinga akoiding ahi. Hiche JJB hin Metropolitan Magistrate ahilouleh Judicial Magistrate of First Class (not being Chief Metropolitan Magistrate or Chief Judicial Magistrate) le japi natong (social worker) numei khat beh anei di ahi. Hiche Judicial member chu Principal Magistrate tia kikou ding ahi.

Powers, functions and responsibilities of the JJB (JJB thaneina le mopohna)

District sunga JJB kisemdoh ho chun hitobanga daan toh kitoh louva chapang hinkho mangho chungchang thua seina dinga thaneina aneidiu ahi.

JJB natoh le mopohna a hiche ho hi pangding ahi –

THE CHILD AND ADOLESCENT LABOUR (PROHIBITION AND REGULATION) ACT, 1986

(CHAPANG LE KHANGDONG NATOH (DOUDALNA LE THUPEH CHEPI), DAN, 1986)

THUMAKAI: (Introduction)
