



SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs.5,10,000/- (Rupees Five Lakh Ten Thousand Only) to University School of Law and Legal Studies, Guru Gobind Singh Indraprastha University, New Delhi towards Third Instalment (being 30% of total project cost of Rs. 17,00,000/- (Rupees Seventeen Lakhs only)) for undertaking research project titled "Access to Justice through Plea Bargaining as an alternative model to traditional Criminal Trial in India: A case study of select Indian States" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by University School of Law and Legal Studies, Guru Gobind Singh Indraprastha University, New Delhi and Department of Justice on 15<sup>th</sup> December, 2021. The 1<sup>st</sup> instalment and 2<sup>nd</sup> instalment(s) of Rs. 3,40,000/- and Rs.6,80,000/- was released to the Implementing Agency vide Sanction Order(s) dated 15.12.2021 and 01.08.2022 respectively.
