- The Fourteenth Meeting of the Project Sanctioning Committee (PSC) to consider requests for extension and review the progress of research/project proposals received under Scheme for Action Research and Studies on Judicial Reforms was held on 14th November, 2019 at Jaisalmer House, New Delhi under the Chairmanship of Secretary (Justice).

The PSC agreed to grant extension of 3 months i.e. upto 29.02.2020. Also, it was informed that DoJ can facilitate in getting access to Courts for collecting data. For this purpose, the implementing agency may write to DoJ with the details.
2	Delhi Judicial Academy	To identify the reasons for delay in disposal of cases and evaluate Capacity Gap to manage the Pendency of cases in District & Subordinate courts of Delhi	The PSC expressed displeasure at the slow progress of the project despite 2 extensions. While granting extension upto 31.01.2020, the PSC desired that involvement at the senior level at the Academy is required to ensure that the project is completed by 31.01.2020.
3	Rajiv Gandhi School of Intellectual Property Law, IIT Kharagpur	Court-referred mediation in the States of West Bengal and Jharkhand	The PSC agreed to grant extension upto 31.03.2020. It was suggested that the study may also include Mediation other than court annexed mediation and analyse its efficacy / shortcomings / challenges. Also, it was suggested that the districts of Deogarh and Dumka may also be covered in the study.
