Ki long ruh ki bym suid niew ne bym shim khia ia kaei kaei kaba pynthuh ia ka jinglong trai ne ka hok jong uno uno u biew lane jong kano kano ka jaitbynriew. Don bun ki biew hangne ha ri jong ngi kiba la nang la stad, hynrei ki bym tip eiei ia ki lad ki lynti ba dei ban shim haba ia ka hok jong ki la shah shim kabu lane la shah pynkhein ne ialeh pyrshah. Haba ngi peit bniah sha ka jinghikai shaphang ka ain ka kanun (legal literacy), kane ka jingthoh kan iarap shibun eh ha ka jingnang jongstad ha ka liang jong ka ain ka kanun, ban pyntrei kam kat kum ka ain, ban pyniar ia ki jingmut jingpyrkhat bad pynstad ia ki biew ha shnong ha thaw, ba kan iarap ruh ban pyllaitluid ia ka biew ka shnong ka thaw ka imlang ka sahlang na ka jingshahpyrkhang bad naka jingshah shim kabu ne ka jingshah niew bein, bad ban wanrah ia ka imlang sahlang kaba suk bad kaba iaryngkat dor. Da kane ka jingthoh ki nongpule, ki lah ban sngewthuh ia baroh ki bynta jong ka jingtrei bym hok bad ki lah ban ujor pyrshah ia ki katcum ka ain khnang ban ba kin ioh ia ka jingbishar ba hok. Ka jingthoh jong kane ka long ban pynkhreh lypa na ka bynta ki jingtip ba kongsan shaphang ki hok bad ki ain ba shong ain ba la pynkup bor ha ngi.

CHAPTER 1

KI HOK TYNRAI JONG KI NONGSHONG SHNONG KA RI INDIA

BACKGROUND (KA NONGRIM)

Ki hok tynrai ba donkam ha ka riti synshar ba la ai da ka Constitution jong ka ri India ia ki nongshong shnong jong ka ri baroh la khot ia ka ki fundamental rights. Kine ki hok tynrai ki dei na bynta jong baroh ki nongshongshnong ka ri ban ai mynsiem bad iarap ia iwei pa iwei I nongshong shnong ban ioh ia ki hok ki sot ha ka imlang sahlang khlem pyniapher iaka kyrdan, ka jait, ka niam ka rukom, la shynrang ne kynthei, ne jaka ba la kha, ban ialong lang kumjuh ha kano kano ka khyllipmat sha ka jingshong suk shongsain ha ka imlang sahlang. Ban pyndonkam ia ka hok tynrai (fundamental rights) lajong lane ban wanrah sha ka jingtip lane ujor sha ka High Court ne Supreme Court ia kano kano ka jingpynthut ne pynkhein iaka hok tynrai. Ki jingrai jong ka kachari ha ka khlieh duh (Supreme Court) ka long ban iada ia ka nongrim jong ka synshar paitbah (democracy) kat kum ka nongrim ba ngi la ioh naduh ka jinglaitluid (independence) bad kumjuh ruh ka jingiaryngkat dor hakhmat ka ain. Kine ki kyndon jong ka riti synshar ki long ki bynta ban iada ia ki paitbah na ki jingshahthombor, sha lehbein bad kine ki hok ki long kumjuh ia baroh ban ioh iaka nongrim jingiada bad burom ia baroh ban wanrah ia ka jingshongsuk shongsain.

KI JINGTHMU (OBJECTIVES)

Ban don ka jinglong ryngkat dor bad ban ai jinglaitluid ia I wei paiwei I nong shong shnong ba don ha kano kano ka kyrdan.

Ban ai jingiada da kaba leit sha kachari ban ioh jingbishar hok haba don ka jingpynkhein ia ki hok ki sot bad ban ioh ka jingsuk jingsain bad burom ha ka jingim jong ki.

Ban wanrah ia ka imlang sahlang kaba shai, kaba don jingmut bad kaba bit kaba biang ba kiew shaphrang.

KINEHARUM KI BATAI BNIAH IA KINE KI HOK TYNRAI:

1. Ka hok ban long ryngkat dor salonsar (Right to Equality)

Ka mut ba ka sorkar kan leh kumjuh ia iwei pa iwei i nongshong shnong ha kano kano ka khep lane ka jingshem i.e. ka mut ba iwei pa iwei kin ia ryngkat lang ha khmat ka ain bad ha ka imlang sahlang bad ka riti Synshar kannym don jingpyniapher ha ka liang ka kyrdan, ka niam, kajait ka kynjia, kynthei ne shynrang lane jaka kha.

Ka jingkyntait kur ne jait ka long kaba be-ain lane bakla hakhmat ka ain (Constitution) bad yn shah pynshitom kat kum ki kyndon ba la buh. Ban wanrah ka jingiaryngkat dor lang ia baroh,

ia ki kyrdan ne burom ba la buh da ka sorkar phareng ha ki por mynshua, kum 'Rai Bahadur' lane 'Sahib', la pynduh noh syndon ia ki..

2. Ka Hok Jinglaitluid (Right to Freedom)

Kane ka aiin ka ai jingshakri ba shkem ia ki nongshong shnong da:

- Ka jinglaitluit ban kren bad ai jingmut;
- Ka hok ban pynlong jingialang kaba jai jai khlem ki tiar pynmysaw;
- Ka hok ban seng ia ki seng bha lang lane ki seng treilang (co operative society);
- Ka hok ban leit ban wan ne ban shong ban sah katba mon hapoh ka ri India, lait noh tang ha Jammu bad Kashmir ba don jingpyrkhang;
- Ka hok ban trei kano kano ka kam ne bteng kano kano ka kam ne jingkhaii pateng.

Kane ka hok ruk ka pyngskhem iaka hok ban im janai kum ki biew ne ha kaba iadei ia ka long rynieng shimet. Kaba mut ka jingim kaba don burom ha ka imlang sahlang; lada shah thombor dei ban ioh jingiada na ka ain, ban iada naka jingsha kem khlem nongrim ne shah pharep hano hano.

3. Ka Hok Jingshahlehbein (Right against Exploitation)

Kane ka hok ka pynduh tynrai ia ka kam khaii ia ki biew, ban pyrshah bad iada na ki jingshah pyntrei jubor la ki dei ia ki shynrang ne kynthei ne ki khynnah. Lada leh pyrshah ne pynkhein ia kane kin shah pynshitom kat kum ki kyndon ba la buh da ka ain. Kane ka ain ka ai jingiada ruh ia ki khynnah ha kaba lah ban pynshitom da kaba tyngeh iano iano ki ba pyntrei kam ia ki khynnah hapoh 14 snem ka rta ha ki karkhana, ki par tih dewiong ne kiwei kiwei ki kam kiba eh bad ba khiah ban trei.

4. Ka Hok ban bud kano kano ka Niam (Right To Religious Freedom)

Kane ka hok ka ai lad ia baroh ki biew ha ri India ban bud kano kano ka niam kat kum ka jingkwah ne jingsngewthynnat jong ki; ban pylong jingialang niam, ban shna iingmane lane ki ing ban leh kam bha ne ai sngewbha ai jingiarap, ban thied ne don ia ki jaka ki puta, bad ban pyniaid ia ki kam niam bad long trai ha kine ki jaka. Ka sorkar thaw ain kam lah ban dawa ia ki liing niam ban siew khajana ne tax ha ka kyrteng niam ne jingpyniaid kam riewblei. Kano kano ka skul pule ba la thaw kam lah ban ai jingstad tang ia kawai ka niam lane ban pynbor ia ki khynnah ban bud tang ia kawai ka niam.



5. Ka hok ban ioh jingpule bad ka ba iadei bad ka riti ka dustur. (Rights related to Culture and Education)

Kane ka hok ka iada ia ki biew kiba lah shah jied kum ki minority lane ki ba rit paid ban ioh ban kren ka ktien bad ki jingthoh ha ki ktien lajong, bad ia ki riti ki dustur kumba ki la bud naduh hyndai. Kane ka ain ka ai ruh ia ka hok ban ioh ka jingnang jingstad ban pule ha kano kano ka skul ne college sorkar. Ki minorities lane ki rit paid ki lah ruh ban thaw ki liing skul pule



ban ai jinghikai ia ka riti ka dustur lajong bad ka sorkar kam lah ban buh kano kano ka jing pynrkhing ban pyniaid ia kine ki skul khamtam ha kaba iadei ban ai ki grants bapher bapher. Kine ki skul kin hap bud kat kum ki kyndon ba la buh ha constitution jong ka Ri India article 29 bad article 30.

Ka jing pynbeit ia ki hok haba lah shah knieh ne pynthut (Rights to Constitutional Remedies)

Haba ia kine ki hok kiba la ai da ka Constitution of India la shah pynthut da ka sorkar jylla/ sorkar pdeng lane ha uno uno u bries lah ban leit ujar ha ka Supreme Court lane High Court ban ioh kham klo iaka hok ba la shah knieh ne pynthut.

Ka High Court bad ka Supreme Court ha kane ka phang ka lah ban pynmih ia san tylli ki order ba la khot ki "Writs". ia kine la batai harum.

Habeas Corpus --- kane ka dei ka lad ka lynti ha kaba uno uno lane kano kano u/ka bries ba shah kem shah set phatok lane shah pynjynjar ia kano kano ka kam sniew ba u/ka khlem leh lane shah pynbudnam ban wanrah sha ka jingtip jong ka ain. Ka court ka lah ban buh da ka jingkyllia uno uno / kano kano u/ka ophisar bad phah wanlam ia u/ka nongshah set phatok ha khmat ka ing bishar, bad ba ki bor (lane kino kino ki ophisar) kiba lah kem ne set phatok ia ki lada ki don ne em ka daw ba tikna ban kem bad ban set phatok, bad ka ing bishar kan pynshisha lada dei hok ne em ban buh ia u/ka bries ha phatok, lane dei ba ki shah pharep ba bakla.

Mandamus---ka jingiada haba ka Supreme Court /High Court ka ai da ka hukum sha ki bynta jong ki sorkar, court ba hapoh jong ki, corporation ne ki bor thaw ain jong ki paitbah ban leh ia kano kano ka kam ba dei hapoh ka ain bad na ka bynta ki paitbah.

Writ of prohibition--- Kane ka dei ha kaba ka Supreme Court lane ka High Court ka bthah lane khang ia kiwei ki court rit kum ki District Courts lane Tribunals ban rai ia ki case kiba kim don ka bor ban bishar.

Certiorari---Kane ka dei ka hukum, jingthoh lane shithi, ba lah ai da ka Supreme Court lane High Court ban bthah ia ki court rit kum ki District Court/Tribunal/Public Authority ban phah ia ki record lane jingkyntiew jong ka jingpyniaid jong ki case bapher, ban peit bniah lada ki biang ne em.

Quo Warranto---kane ka dei ka hok ban buh jingkylli ia uno uno u bries ban pyni ba u don ne em ka bor lane ka kyrdan ban ai kano kano ka jingbishar lane ban leh kano kano ka kam, bad lada ym lah ban jubab um dei ban ioh ia ka shuki kaba u bad khlem don nongrim.

Shaei ki bries ki lah ban leit, lane, shano kin phai

Lada shah leh be-ain ne shah pynthut ia ka hok, u/ka bries u/ka lah ban phai sha ka Supreme Court lane High Count ban ioh jingiarap lyngba ki nongiasaitnia (lawyers)

Lada kiba shah leh be-ain ki don hok ban ioh jingiarap ei na ka ing bishar ki lah ban kyrapad da ka jingthoh na District Legal Services Authority / High Court Legal Services Committee / Supreme Court legal services Committee.

CHAPTER 2

KA JINGIARAP EI BAN PYN IASAID AIN (FREE LEGAL AID)

KI JINGIARAP LANE KI KAM AI JINGSHAKRI AIN

Ka Nongrim

La pynlong ain ia ka Legal Services Authorities Act, 1987, ban pyn saphriang ia ki bor treikam ain ha Ri India. Hapoh kane ka Act, la seng ia ka National Legal Services Authority, ka bor khliehduh ha Ri India (central level) ban rai ia ki ain trei kam bad ki jingpyntreikam bapher ha ka Ri India pyllun. La seng ia ka State Legal Services Authority ha ka jylla state (state level) ban pyntrei ia ki ain pyntreinkam jong ka Ri India pyllun bad ban shna ki programme na ka bynta ka Jylla state bad ban pyntreikam, ban pyni lynti bad ban khmih bniah ia ki rukom treikam ha ki seng lane ki committee ain jong ka district bad ha block. Kine ki seng ki ai jingiarap ei ia kiba duk ba duna ha ki kam ain. Mano mano ba kwah ia ka jingiarap ha kaba iadei bad ka ain, ki lah ban leit sha ka Legal Services Authority (LSA) kaba don ha Sub district/Taluk/Tehsil.

Kie kiba kynthup ha ka jingai shakri ei ia ki paidbah ha ki kam ba iadei bad ka ain?

Ka kynthup ia ka jingshakri ei ia kiba duk ki bym lah ban siew bai muktiar na ka bynta ki mukotduma jong ki ha iingshari.

Ki Thong

- Ban ai ka jinghshakri ei ka ba biang bad tikna ia kiba duk ba duna jong ka jaitbynriew. Ka Legal Aid kamut ka jingai jingshakri ei sha kiba duk bad kiba duna, kiba donkam ka jingiarap hynrei bym lah ban siew ia u nongsaidain na ka bynta ki case jong ki ha iingshari, tribunal lane Judicial authority.
- Ban pyntikna ba baroh kin ioh ia ka lad ban ioh ia ka hok, ym dei ban kyntait iano iano, na ka daw jong ka ioh ka kot, jingdon jingem lane kiwei kiwei ki jingduna.
- Ban pynlong da ki Lok Adalats ban pyntikna ba ka jingpyntrei kam jong ka ain kan kyntiew ia ka hok ha ka nongrim ba ka jingioh lad kan long mar kumjuh ia baroh ha khmat ka ain.

Ki kyndon lane kino ki ban ioh jingiarap ia ki kam ain

- Ki kynthei bad ki khynnah
- Kiba dei ki SC/ST
- Kiba trei ha ki karkhana
- Kiba shahthombor, shah be-ijot, lane ki nongkhrong
- Kiba shah ktah ha kum kino kino ki jingjia ba shyrkei, kiba shah mynsaw, jingshlei um, jingrang tyrkhang, jumai, jingjia ba shyrkei ha ki jaka trei bad kiwei kiwei.
- Kiba don jingduna ha ki dkhotmet
- Kiba shah set patok

- Kiba ka kamai kam palat ia ka Rs. 1,00,000/- tyngka. (ha Supreme Court ka jingioh kam palat ia ka Rs. 1,25,000/-, don ki jylla kiba buh tang Rs. 50,000/-)

Shano lane Hangno ban leit?

- Ban ioh jingiarap ei ha ka ain, dei ban leit sha ki seng lane ki bor nongiarap ain ba hap hapoh Tehsil/Sub District / District Legal Services Authority. Kine ki seng lane ki bor nongiarap ain ki don ha ki Taluk Court lane ha ki ing treikam jong ka District Court.
- Ban ioh jingiarap lane jingtip kham bniah lah ruh ban leit sha ka CSC Center kaba jan tam.

LOK ADALAT

Ka nongrim

Ka Lok Adalat ka mutka Ingbishar U Paidbah lane ka 'People's Court'. Ki mukotduma (tang ki ba lah ban iasuk hapdeng jong ki ba ia khun case lane Compoundable bad ki jingia kajia ba rit ba ria) kiba dang sah kut ha ki iingbishar, lah ban pynpoi noh sha ka jingiasuk baroh ar liang ha Lok Adalats. Ki Lok Adalats ki mih ban weng ia ki cases ba lah sahkut slem ba lah pynkit khia ia ki iingbishar bad khamtam ban pynioh khamklo ka jingbishar ia ki baroh arliang mamla.

Ki Thong

- Ban pynklo ban ioh ia ka hok ia baroh kiba duk ba duna ha ka imlang ka sahlang.
- Ban pyni lane pynshai paidbah ia ka rukom pyniasuk ha ki arliang mamla bad ka jingkhuid rukom bishar ka Lok Adalat
- Ban nang pynshlur bad pynkiew ka rukom pynlong ki Lok Adalat
- Ban pynshlur ia ki briew ban iasuk ia ki jingiakajia jong ki shabar ka iingbishar.
- Ban aibor ia ki briew, khamtam ia ki kynthei, ban iashimbynta lang ha ka jingshakri ia ka ain ka hok.

Ki kyndon ban poi sha ki Lok Adalats

- Ka Case (tang ki compoundable bad kiba rit baria) kiba dang sahkut ha iingbishar.
- Ki jingiakajia ki bym shym pat wanrah sha kano kano ka court, bad kiba lah ban poi sha ka iingbishar.



Ki cases lane ki jingia-kajia kiba lah ban leit sha ki Lok Adalats

- Ki jingiakajia jaka puta
- Ki jingshongkha shongman (kum ka jingsumar ing, ka jingiakhlad lok, bad kiwei kiwei)
- Ba ia dei bad ka Insurance
- Kiwei kiwei ki jingiakajia (kum ka jingaksiden kali, ka jingshah ram, ki kam bank bad kiwei kiwei)
- Ki Compoundable criminal cases lane ki case be-ain ba lah ban pyniasuk²

Ki rukom bad kyndon ban rah ia ki case sha ki Lok Adalat

• Ki case kiba sahkut ha ki iingbishar bapher:

- Lada ki ar liang ki kloj ban iasuk ia ka jingiakajia jong ki ha Lok Adalat
- Iwei na kita ar liang ki lah ban ai ka application sha ka court

¹Ki jingpynkhein ain kiba khamrit. Ha kum kine ki case ki complainant (lane kito kiba ujar lane kiba shah ktah shah leh be-ain) ki ia poi noh ha ka jingiasuk, bad ki ia munjur ban weng noh ia kino kino ki jingkynnoh.

² Compoundable Offences- Kine ki dei ki jingpynkhein ain kiba kham duna, kum ka jingkren da ka jingmut sniew, ban niewbien ia ka jingngieit jong kiwei, lane ban pynmysaw; ban leh ki kam sniew, ban rung jubor ha iing jong kiwei; ka jingpynmysaw da ki tiar ba pynmysaw, ka jingbymiasam hok ia ki jaka puta, bad kiwei kiwei.

- Nangta ka court kan sa bishar lada kata ka jingiakajia ka bit ne em ban pyniasuk ha Lok Adalat.

- **Kino kino ki jingiakajia ha ka pre-litigative stage³**

Ka State Legal Services Authority lane District Legal Services Authority, hadien ba lah ioh shimti ia ka application na iwei na kita ki liang ba dang don ha ka pre-litigation stage, lane ka kyndon ha shua ban shimti ka ingbishar, ki lah ban phah sha ka Lok Adalat ban pyn poi sha ka jingiasuk.

Ka Rai (Decision)

- Man ki rai jong ka Lok Adalat la khein kum ka rai jong ka Civil Court. Te haba ki ar liang mamlia ki la poi sha ka jingiasuk, ka Lok Adalat ka ai noh ka Court fee ba la siew da ki nongmudui.
- Baroh ki rai ba la rai da ka Lok adalat ki long ki rai ba khadduh, haba ki arliang mamlia ki poi ha ka jingiasuk bad ym lah shuh ban appeal pyrshah lane ban ialeh ban pynphai biang ia ka rai ha kano kano ka Court. Kane ka ain ka ai bor bad pynskhem ia ka rai khadduh ong ki Lok Adalats.

Ki mat ba donkam ban kynmaw ban ioh ia ka jingshakri.

- Ban long kiba lah ban ioh jingmyntoi ia ka jingai ei ka ing bishar : la ki nongiasaid nia la thung da ka Legal Service Authority ban ai ka jingiarap ei (khlem jingsiew) na ka bynta jong kino kino ki brielv ki ba ioh kane ka jingshakri. Ki nongiasaid nia ki ioh ka bai said ain na ka Legal Service Authority. Lada u nongiasaid ain u mang pisa dei ban wanrah iakane sha ki bor ba dei peit, haba bun ki jaka, u dei u District Judge.
- Baroh ki jinglut jingsep ha por ka jingiaid jong ka kam ain, ym lah ban mang pisa na ki brielv ba shim ia kane ka jingshakri (ka Court fees ruh kin num donkam siew ha ki Legal Aid case)
- Lada u nongiasaid ain ba la thung da ka Legal Service Authority um lah ban kyrshan ne pynleit jingmut sha ka case, te donkam ba kin wanrah ia kane sha ka jingtip jong ki bor peit (Authority) (lada dei ka DLSA- te dei ban pyntip sha u Chairperson jong ka DLSA, katta u District Judge). Bad yn lah ban pan noh da uwei u nongsaid ain u ba khambiang.

Yn leh kumno haba ioh notice na ka Lok Adalat?

- Ym donkam ban khuslai. Ka ju long kaba tieng ban ioh court notice, hynrei peit pynban kum ka lad ban poi sha ka jingiasuk.
- Leit sha ka Lok Adalat ha ka tarik ba lah buh lane phah da u nongsaid ain.
- Kren beit ha u chairman lane ki dkhot jong ka bench
- Ai jingpynshai shaphang ka case, da batai bniah de.

Ki kynthei barobor ki dei kiba shah niewbein bad shah ibein ha ka imlang sah lang. Ki bun bha ki ain kiba iada ia ki, hynrei bun na ki kym tip shapong ki hok lajong. Ha kum kine ki khep ki briel hapoh ka ri ki dang sah hapoh ka jingbieit bad jingsahdien ha kaba ia dei bad ki ain ba long salonsar bad kim tip ia ki lad shano ban leit ujor ne mudui kaba pynlong ia ki ban sah ha ka jingeh bad kordit ka jingmut jingpyrkhat.


A. KAEI KA EJAHAR (F.I.R)?

Ka ejahar ka dei ka jingleit ujor ne mudui da kiba shah ban bein ne da kiwei pat na ka bynta jong ki sha ki pulit. Ia ka ekjahar la pynrung hapoh ka section 154 jong ka Code of Criminal Procedure, 1973. Hapoh kane ka ain ka kamram jong ki nongshong shong ba ki dei ban leit pyntip sha ki thanat ba hajan lada don ka jing jia hapoh shnong . Ki pulit hadien ba ki lah dep ioh jingtip ki dei ban pynrung ha ka ekjahar ban iaid katkum ka ain.

Ka ejahar ka long ka kyndon kaba nyngkong shuwa ban wad jingtip ia ki kam sinew bad ka long ruh kaba donkam bha.

Mano Ba Lah register ia ka Ekjahar?

- Mano mano ki ba don jingtip shaphang ki ain ki kanun kiba ia dei bad ki jingpynthut kiba jur ne wat kiba malu mala, ki lah ban long kito kiba shah pynthut ne kito kiba sakhi markhmat ia ka jingshah pynthut.
- U pulit ophisar lada u ne ka, ki ioh jingtip shaphang ki jingjia ki lah ban pynrung ejahar.

- Hadien ba la dep ujor, buh jingthoh bad soi, ki pulit ki dei ban ai kopi sha ki nongujor. Haba ujor ejahar ym donkam pisa.Ka ekjahar ka iarap ia ki pulit ban wad bad thwet kham kloi ia ki nongleh kam sniew ba la shah ujor.

Ki Jingpynthut ne jingleh pyrshah ia ka ain (Offence)

Kino Kino ki jingleh palat kiba ktah ia ka hok longbriew man brieuw ne kiba long ka daw ka jingshitom ia kiwei pat ne kiba lah ban ktah ia ka imlang sahlang baroh kawei la kdew ba ka dei ka jingpynthut kaba dei ban hap hapoh ka jingbishar jong ka ain.

Ia ka rukom pynthut lah ban long kaba lah ban ioh jamin(Bailable offence) lane ka bym lah ban ioh jamin (Non bailable offence).

B. KA JAMIN

Ka jamin ka dei ka jing ai jingbit ia u nongleh kam sniew ne nongpynthut ban pyllait na thanat ne na along ki pulit ryngkat bad ka jingmynjur ia ki kyndon jong ki ain. Ban ioh ia ka jamin u nongleh kam sniew u hap ban kohnguh ne bah khlieh ba u dei ban wan mih haba donkam ki pulit ne ka iing bishar. Ka jing ioh jamin ka dei ka jingpyllait ba tang shipor ia u nongleh kam sniew.

Mano ba lah ban ioh Jamin?

U nongleh kam sniew u lah ban ioh jamin, ha ka jingsngewthuh jong ka iing bishar kaba peit bad bishar bha ba u nongleh kam sniew um dei ban bakla biang. Ka iing bishar ka peit ruh lada don kino kino ki kam sniew u la dep leh shwa ban shah kem, lada pyllait ruh kan peit ryngkat ban ai jingiada kaba biang ia kito kiba lah shah pynthut. Lah ban ioh jamin tang ha ki jingpynthut kiba malu mala ne ki bym da jur ha kaba ka iing bishar ka pdiang ia ka jamin katkum ki kyndon jong ka ain.

Ki Jingpynthut kiba lah ban ioh bah jamin(bailable offences)

Ki jingpynthuht kiba lah ban ioh jamin ki dei ki jingpynthut kiba malu mala ne ki bym da jur ha kaba ka iing bishar ka pdiang ia ka jamin katkum ki kyndon jong ka ain.Kum kine ki jingpynthut ki kynthup ia ka bamsap, ka jingpynwit ia kiba trei kam paibah, ban ieng sakhi lamler bad kiwei kiwei. Katto katne ki kyndonna ka bynta ki nongleh kam sniew ba dei ban ioh jamin ki long:

- La khang ban kynriah iing ne kynriah jaka bad ban leit jingleit shabar.
- Donkam ban leit mih sha thanat ne katkum ka por ba la buh.
- La mana ban ia jan bad kiba shah ban bein ne bad kito kiba sakhi markhmat.
- La Khang ban mushlia ha ki kam kaba ia dei bad ki sakhi.

Ki Jingpynthut ki bym lah ban ioh jamin (non bailable offences)

Ki jingpynthut ki bym lah ban ioh jamin ki dei kiba lah kham jur bad iaba ki nongleh kam sniew kim dei ban ioh jamin katkum ki kyndon.

Kine ki jingleh kam bymman ki kynthup kum ka jingbyrngem ia ki briew na ka bynta ban sakhi lamler, ka jingpyniap briew, ka jingkynshoit ban pynkhih win bad kiwei kiwei. Kum kine dei ka iing bishar kaba lah ban kyntait ia ka jamin.

Kumno ban ioh jamin (procedures to get bail)

Uba sha kem u dei ban thoh da ka application sha ka court ban pan iaka jamin dalade lane lyngba u plidar.

C. KA JINGSHAH KEM (ARREST)

Ban kem ka mut ban rah da u pulit ia ki nongleh bakla bymman bad ban pynshong ia ki ha thanat.

U ba shah kem u don kine ki hok:

- Ka hok ban tip ha kano ka kyndon la kem.
- Ka hok ban wad jingip kumno ban ioh jamin.
- Ka hok ban phah peit ha ki doktor.
- Ka hok ban sngap jar.
- Ka hok ban ialam ha khmat u Magistrate khlem da pynslem.
- Ka hok bym dei ban pynshong hapoh thanat palat 24 kynta khlem wad jingtip.
- Ka hok ban iakren bad u nongiasaid ain.
- Ka hok ban don nongiasaidna ka Legal cell.
- Ka hok ban khot sakhi.

Ki Kyndon ban kem (arrest procedure)

Lah ban kem da ki briew paitbah (lada u nongleh kam sniew u pyrshang ban phet kat haduh ba ki pulit kim pat poi), ki pulit longheh ne u Magistrate. U pulit u dei ban ioh ki pyntip bniah iaki bynta u nongleh kam sniew u ba la shah kem. Shuh shuh , ki kam jong u ne ka nongleh kam sniew lada ki dei ban ioh jamin ne ym dei ban ioh ruh dei ban da iathuh.

CHAPTER 5

KA HOK BAN DON IA KA JINGNANG JINGSTAD, 2009 (RIGHT TO EDUCATION)

KA JINGSDANG LANE TYNRAI

Ka ka hok jong ka pule puthi la pynlong ain ha ka 4 tarik u August 2009. Kane ka ain ka pynthikna ba dei ban ai jingpule khlem jingsiew na ka bynta ki kynnah kiba naduh 6 snem haduh 14 snem (kata naduh klas I haduh klas VIII). La pynmih khnang ia kane ka ain ka bynta ki khynnah kiba duk bad kito ki bym ioh lad ban pule.

Ki Jingthmu

- Baroh ki khynnah kiba hapdeng ka ryta 6 haduh 14 ki don ka hok ban ioh jingnang jingstad ei haduh ba kin da lah ban pyndep ia ka jingsdang jong ka jingpule ha ki skul ba marjan.
- Ym dei ban pyntsah klas ia ki khynnah, ne shah beh bad ki dei ban pas ia ka board eksam haduh ba kin da lah ban pyndep ia ka bynta jong ka jingpule.

Ka Jingthmu (OBJECTIVES)

Ka Jingthmu jong kane ka aiñ ka long ban pynbiang ia ka bam ka long banpynioh tikna ia ka bhah bad ka jingbam kaba biang ka dor kaba lah ban thied ki briew ban ioh ban im ka jingjim kaba ia ryngkat bad ki briew baroh.

Shaphang Ka Ain

Ka National Food Security Act (NFSA) jong ka sorkar India ka dei kata ka nongweng ne nongialeh pyrshah ia ka jingduk bad jingai bam ka bym tei. Ka thmu ban pynbiang ia ki jingbam ha ka dor ba duna ia ka dor iew sha ki 75% ki nong kyndong bad 50% ki nong sor ha ri India kat kum ka jingkhein ka Census 2011. CHAPTER 7

SCS/STS PREVENTION OF ATROCITIES ACT 1989 .(KA ACT BAN IADA IA KA JINGSHAH LEHBIEN KI SCS/STS,1989)

KA NONGRIM
