
SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs.6,60,000/- (Rupees Six Lakhs Sixty Thousand Only) to DAKSH, Bengaluru towards of Third Instalment (being 30% of total project cost of Rs. 22,00,000/- (Rupees Twenty two lakh only) for undertaking research project titled "Ideation and Implementation of the Phase III of the eCourts Mission Mode Project" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by DAKSH and Department of Justice on 25th November, 2020. 1st instalment and 2nd instalment of Rs.4,40,000/- and Rs. 8,80,000/- has been released to the Implementing Agency vide Order dated 09.12.2020 and 25.02.2022 respectively.
