SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 7,49,400/- (Rupees Seven Lakhs Forty-nine thousand and four hundred only) to Chanakya National Law University, Patna towards Third Instalment out of the total project cost of Rs. 24,98,000/- (Rupees Twenty Four Lakh Ninety Eight thousand only) for undertaking research project titled "Impact Assessment of Commercial Courts Act, 2015 with reference to Commercial litigations pending in State of Bihar & Jharkhand" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed between Chanakya National Law University, Patna and Department of Justice on 6th November, 2019. 1st instalment of Rs. 4,99,600/- (Rupees Four Lakh Ninety-Nine Thousand Six Hundred only) and 2nd instalment of Rs. 9,99,200/- (Rupees Nine Lakh Ninety-Nine Thousand Two Hundred only) were released to the implementing agency vide order of even no. dated 11.11.2019 and 15.06.2021 respectively.
