


**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. Rs.9,99,428/- (Rupees Nine Lakh Ninety Nine Thousand Four Hundred and Twenty Eight Only) to KIIT University towards Second Instalment (being 40% of total project cost of Rs. Rs. 24,98,570/- (Rupees Twenty Four Lakh Ninety Eight Thousand Five Hundred and Seventy only) for undertaking research project titled "Mapping Global Best Practices in Pendency Reduction to Indian Judicial System and Tracing the Way Forward: An In-depth Empirical Engagement with Select Courts of India" under the Scheme of Action Research and Studies on Judicial Reforms as per the terms of the agreement signed between KIIT University and Department of Justice on 25<sup>th</sup> July, 2023. 1<sup>st</sup> instalment of Rs. 4,99,714/- (Rupees Four Lakh Ninety Nine Thousand Seven Hundred and Fourteen Only) was released to the Implementing Agency vide Sanction Order of even no. dated 28.07.2023.
