SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs 4,02,943/- (Rupees Four Lakh Two Thousand Nine Hundred and Forty-Three Only) to Delhi Judicial Academy, New Delhi towards Third Instalment (being 30% of total project cost of Rs. 13,43,143/- (Rupees Thirteen Lakh Forty Three Thousand One Hundred and Forty Three only) for undertaking research project titled "To identify the 'Reasons' for delay in disposal of cases and evaluate 'Capacity Gap' to manage the Pendency of cases in District & Subordinate Courts of Delhi" under the Scheme of Action Research and Studies on Judicial Reforms as per the terms of the agreement signed between Delhi Judicial Academy, New Delhi and Department of Justice on 28th February, 2018. 1st instalment of Rs. 4,52,919/- and 2nd instalment of Rs.3,52,967 was released to the Implementing Agency vide Sanction Order of even no. dated 28.02.2018 and 29.05.2019 respectively.
