
Madam/Sir,

However, it is crucial to note that the nature of these recommendations primarily pertains to the qualification of counsellors and adjustments in the conciliation process within the framework of Family Courts. Referring to the relevant legal provisions, specifically Section 23 (b) of the Family Courts Act, 1984, it is evident that the rule-making authority concerning the terms and conditions of association of counsellors and the terms and conditions of service of officers and other employees falls within the purview of the State Government. Additionally, under Section 21 (2) (c) of the Family Courts Act, 1984, the High Court holds the authority to establish rules concerning efforts and procedures guiding Family Courts in facilitating settlements.

3. In view of the foregoing, I respectfully request your esteemed office to consider the said suggestions/recommendations and take appropriate action as deemed fit.

EFFECTIVE COUNSELLING IS THE SOLUTION TO RESOLVE MATRIMONIAL DISPUTES AND NOT ADJUDICATION

The dispute resolution Process be initiated by a "Petition For Reconciliation Through State-Counselling"(RCRts) and not a petition for divorce or Restitution of Conjugal Rights. Following are changes that we are suggesting in the procedure for appointing counsellors and the procedures:

Procedure for 1. appointment of marriage counsellors (MC) and 2. time bound counselling	Justification	Present situation: ie where adjudication dominates does not stand the test of law on following grounds




