

- Q.11 Whether the cases filed by Senior Citizen are being taken up on priority basis as per the instructions of supreme court, if not, what steps are being taken to follow the instructions of supreme court.
- Q.12 Whether the Judicial authority is considering action against person suo-moto (under CPC/CrPC) who have filed wrong affidavits/statements before any Court thereby consuming of crucial time of the Court, if not, reasons for the silence in this aspect
- Q.13 Whether the above issues raised are relevant to various Courts and Tribunals, when the circumstances are one and the same in disposing of the cases at all levels.
