However, since only 6 months of this year are remaining, these figures have been re-worked after discussion with e-Committee and the Hon'ble Chief Justice of India and now an estimate of Rs. 1039.17 crore has been prepared for the Revised Estimate (RE) 2023-24.

4. In view of above, we request that a Revised Estimate (RE) of Rs. 1039.17 crore be allocated for the fiscal year 2023-24 for Phase III of the eCourts Project. Further, to kick start the project immediately by taking care of the immediate as well as committed liabilities, an allocation from the Contingency Fund of Rs. 225 crore may please be dispersed to the Department to ensure the seamless execution of Phase III of the eCourts Project.

It also eliminates physical presence of offender/violator in the court. It reduces the number of judges performing judicial work in adjudicating traffic challans. Electronic traffic challans are automatically filed in virtual court for adjudication. A Judge can access the Virtual Court application from anywhere or any part of the state, view the cases and adjudicate the cases online. Virtual Court can be administered by a Judge over a virtual electronic platform whose jurisdiction may extend to the entire State and function 24X7. Neither litigant nor Judge would have to physically visit a court for effective adjudication and resolution. Communication would only be in electronic form and sentencing and a further payment of fine or compensation would also be accomplished online. **The virtual courts initiative has enabled adjudication of only traffic violation cases on a virtual platform.**

Please refer your RTI application dated 07.02.2024 and to say that with regard to point no. 2 regarding pendency of cases in the Courts you may kindly visit the website <https://njdg.ecourts.gov.in/njdenew/index.php>.

2. With regard to point no. 4, 8 and 12. It is to be stated that disposal of pending cases in courts is within the domain of the judiciary. No time frame has been prescribed for disposal of various kinds of cases by the respective courts. Government has no direct role in disposal of cases in courts. Timely disposal of cases in courts depends on several factors which, inter-alia, include availability of adequate number of judges and judicial officers, supporting court staff and physical infrastructure, complexity of facts involved, nature of evidence, co-operation of stake holders viz. bar, investigation agencies, witnesses and litigants and proper application of rules and procedures. There are several factors which may lead to delay in disposal of cases. These, inter-alia, include vacancies of judges, frequent adjournments and lack of adequate arrangement to monitor, track and bunch cases for hearing. The Central Government is fully committed to speedy disposal of cases in accordance with Article 21 of the Constitution and reducing pendency.

3. With regard to point no. 6, the primary responsibility for development of infrastructure facilities for judiciary rests with the State Governments. To supplement the resources of the State Governments/UTs, the Union Government has been implementing a Centrally Sponsored Scheme (CSS) for the Development of Infrastructure Facilities for the Judiciary since 1993-94 by providing financial assistance to them in the prescribed fund-sharing pattern between the Centre and States.

The scheme initially covered the construction of court buildings and residential accommodations for judicial officers of district and subordinate judiciary. From the year 2021, three new components viz., of digital computer room, lawyers' halls and toilet complexes were additionally brought under the ambit of the above CSS.

As on date (15.02.2024) sum of Rs. 2321.19 crore has been sanctioned to States/UTs under the Scheme since 2021. The detailed Budget Statement may be get from Ministry of Finance, Government of India website.

4. Further, point no. 3,5,6,7,9,10 and 11 does not pertain to the CPIO and the same has been transferred to the concerned CPIO to provide you the desired information.
