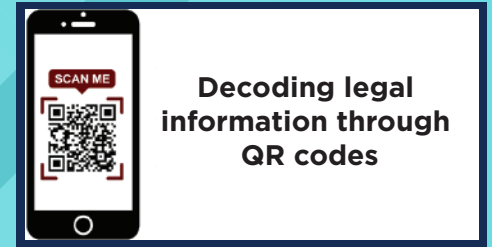

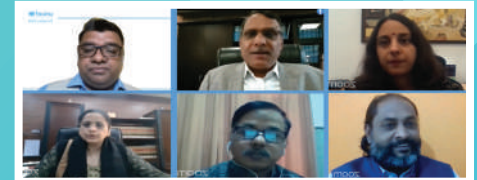
# WEBINARS ON SOCIO-LEGAL ISSUES

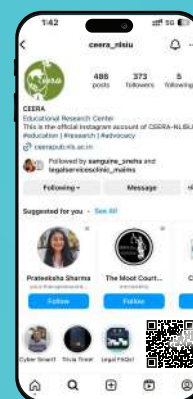
