- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

#### 3. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

## 4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- 4. Character and antecedents and Medical Fitness certificate of engaged staff mu st be verified by the bidder agency from the concerned police station/ medical a uthorities and report thereof should be submitted immediately to CRC Davanag ere.
- 5. Payment will be made upon submission of invoice/bills in original on monthly b asis to the agency through electronic transfer. The following documentary evide nce shall be furnished along with the bills.
  - EPF staff-wise contribution & challan proof (EPF contribution is to paid by the contractor upto the maximum wage ceiling of Rs.15,000/- per month, as amended from time to time)
  - ESI staff-wise contribution & challan proof (ceiling of Rs.21,000/- per month as amended from time to time)
  - GST Remittance challans/receipts
  - · Payslips of all staff indicating all emolument and deductions
  - · Agency's Bank statement proof indicating salary disbursement
- 6. The contractor shall ensure that they deploy only qualified personnel at site as per requirement. The contractor must provide ESI Card, Suitable uniform, ID Card / Badge, Shoes and Safety equipment at their own cost, for safety and shall ensure their proper maintenance.
- 7. Number of manpower per shift may increase/decrease as per the need of the o rganization, and may be assigned other jobs for the interest of the CRC Davana gere and Persons with Disabilities (PwDs)
- 8. Before undertaking the contract, the bidder should furnish the details of manp ower to be employed by them.
- 9. Behavior of the manpower deployed by the contractor shall in no way be detri mental to the administration. The contractor shall provide those who are good, soft character, physically fit, efficient, well behaved and skillful in their duties.
- 10. CRC Davanagere is dealing with Persons with Disabilities. As the manpowers ar e part of it & while on duty, they should deal the PwDs with at most care and re spect.
- 11. The desirable behavior/ attitude / respect of the Manpower is great concern for CRC, Davanagere when they are on duty. In case the behavior of the deployed manpower are found to be non-satisfactory/ adamant/ argumentative/ disrespe ctful/ non obedient/ non reliable, towards officials/ staff/ PwDs/ Visitors at any p oint of time, the same manpower should be immediately removed/ replaced by the agency as per instruction of CRC Davanagere.
- 12. The deployed staff/manpower must be on uniform, and expected highly respect decorum discipline towards the officials/ staff/ PwDs/ Visitors of CRC Davangere.
- 13. In case, any unforeseen /untoward incident occurred at CRC Premises due to d eployed manpower / or due to negligence/ sleeping when they are on duty, if an y damage/ theft is occurred to the CRC, Davanagere, the Agency is responsible the same will be recovered from the Agency only.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
