Introduction

The Department of Food and Civil Supplies was established in March 1965 by separating the Supply Department from the Agriculture, Food, and Cooperation Department. In December 1977, the management of weights and measures was transferred from the Department of Industries, Energy, and Labor to the control of the Civil Supplies Department. This department primarily manages the demand and supply of essential commodities in open trade and controls matters related to the Public Distribution System. The department's main responsibility is to stabilize prices by implementing various control orders under the Essential Commodities Act, 1955, and to enforce the Food Security Act.

Main Objectives of the Supply Department:

1. Strengthen the targeted Public Distribution System.
2. Ensure the availability of essential commodities at reasonable prices.
3. Create storage capacities for the Public Distribution System.
4. Protect and promote consumer interests by implementing the Consumer Protection Act, 2019.

The operations of the Supply Department are mainly governed by the following rules/acts:

1. Essential Commodities Act, 1955
2. Food Security Act, 2013
3. The Prevention of Black Marketing and Maintenance of Supplies of Essential Commodities Act, 1980

At the level of the Deputy Commissioner (Supply), operations related to appeals/review petitions are conducted under the following control orders issued under the Essential Commodities Act:

1. Retail Kerosene – Maharashtra Scheduled Commodities Retail Dealers Licensing Order, 1979
2. Wholesale and Hawkers Kerosene – Maharashtra Kerosene Dealers Licensing Order, 1966
3. Fair Price Shop – Maharashtra Scheduled Commodity (Regulation of Distribution) Order, 1975
4. Open Market Grain (Pulses, Rice, Oilseeds, and Oil) – Maharashtra Scheduled Commodity Wholesale Trade Licensing Order, 1998
