14	It was brought to the notice of State Officers that Railway's portion of works for ROBs at Niphad and Lasalgaon has already been completed, and work of road approaches, land acquisition by State PWD is pending since long.  Divisional Commissioner, Nashik advised PWD Officials to expedite the PWD works at these ROBs. These works need to be completed on priority by PWD for safety of Rail and Road users. 15	There is requirement of 6 to 7 Stabling lines at Odha and Nashik station for stabling of rakes during the Kumbh Mela period. For provision of these lines, MSEB land acquisition is essential. The division should process the proposal immediately for this purpose. At the same time, possibility of sparing some lines in Nashik MSEB Yard during Kumbh Mela period should also be explored. 16	State Authority had organized a PPT Presentation on proposed Multimodel Transport Hub at Nashik. M/s. Ingrain, Architectural Agency showed their PPT presentation with proposed plan of integration of Railway, Metro and Bus services involving commercial exploitation of land and new semi-highspeed railway line between Nashik Road-Pune. The proposed Metro line is crossing the entire existing Railway station. It was brought to the notice of State Officials and Architectural Agency that all these issues need to be suitably addressed and all technical clearances of Railway have to be obtained first. It was also advised to submit all the documents to Central Railway HQs/CAO(RSP) and discuss the issue.
