**Kind Attention: The candidates who are willing to participate in the Final Stray Vacancy Round of AACCC-UG Counseling, 2021.**

The AACCC, M/o Ayush is receiving lot of queries from the candidates, regarding seat allotment in the Final Stray Vacancy Round of AACCC-UG counseling, 2021.

In this regard, it is informed that, those candidates who have not been allotted any seat under All India Quota (AIQ) as well as under State/UT/Institutional /Central Pool Quota will be considered for seat allotment in the Final Stray Vacancy Round. The details of eligibility conditions, procedure & time schedule of the Final Stray Vacancy Round are as under:

• **Eligibility condition for the Final Stray vacancy Round:**

All the registered candidates who were not allotted any seat in the previous rounds of AACCC-UG counseling, 2021 as well as in State/UT/Institutional/ Central Pool Quota Counseling are eligible for the Final Stray Vacancy Round.

• **Procedure of participation in the Final Stray Vacancy Round of AACCC-UG counseling:**

- All the eligible candidates for the Final Stray Vacancy Round are advised to submit their willingness for participation in the Final Stray Vacancy Round of AACCC-UG Counseling, 2021 by logging in to the AACCC portal/website ([www.aaccc.gov.in](http://www.aaccc.gov.in)).

- The seats will be allotted to only those candidates who will submit their willingness on AACCC portal/website ([www.aaccc.gov.in](http://www.aaccc.gov.in)) for participation in the Final Stray Vacancy Round during the scheduled period as mentioned below.
- There will be no fresh registration & choice filling in the Final Stray Vacancy Round.
- The seats remain vacant (Govt./Govt. Aided/ CU/NI) after the 3<sup>rd</sup>/Mop-up Round of AACCC-UG counseling (if any), will be allotted to the candidates as per merit & choices submitted by them during the 3<sup>rd</sup>/Mop-up Round of AACCC-UG counseling, 2021.

Further, if candidate get allotted a seat in the Final Stray Vacancy Round, he/she must join the allotted seat. In case, he/she fail to join then he/she will be ineligible for the State/UT/Institutional/ Central Pool Quota counseling & security money will be forfeited.
