**Sub: Decision on counseling for 50% DUQ PG seats and the fate of vacant internal quota (DUQ) seats of Postgraduate-ASU Courses under Delhi University after the completion of Round-2 of AACCC-PG Counseling for the academic year 2022-23:reg.**

**Sir,**

With reference to the subject cited above, I am directed to say, that the Ministry of Ayush, has decided to conduct counseling for admission to 50% Internal quota seats (Delhi University Quota -DUQ) under Delhi University, along with 50% All India Quota seats, through AACCC-PG portal, only for the academic year 2022-23.

2. Further it was also decided that the seats that remain vacant after completion of Round-2 of AACCC-PG counseling, will be reverted to Delhi University, for conducting further counseling at the University level, because the Conversion Algorithm of Delhi University is not compatible with the AACCC-PG portal, which is made on the basis of Centrally Approved Conversion Algorithm and is applied during 3rd /Mop-up Round of AACCC-PG Counseling.

3. The details of vacant DUQ-PG seats are attached herewith (**Annexure -I**) for the conduction of further counseling at the University level.
