	Conditions	Instructions to the candidate
Condition 1	Candidates who have been allotted seats in Round 2 and wish to retain the allotted seat	Join the institute within the stipulated reporting period
Condition 2	Candidates who have been allotted/upgraded seats in Round 2 and do not wish to retain the seat	FREE EXIT (no need to join the allotted institute)
Condition 3	Candidates whose seats have been upgraded from R-1 to R-2	Get an online-generated relieving letter from the previous R-1 joined institute and report to the R-2 allotted institute physically.
Condition 4	Candidates whose seats have been upgraded from R-1 to R-2 and do not wish to retain the seat	Get an online-generated relieving letter from the previous R-1 joined institute and not to report to the R-2 allotted institute.
Condition 5	Candidates whose seats have not been upgraded from R-1 to R-2 and do not wish to retain the R-1 joined seat	Avail free exit within five days after the publication of the R-2 result without forfeiture of security money (i.e. from 11:00 AM of 27.09.2023 to 06:00 PM of 01.10.2023)
Condition 6	Candidates who joined R-2 allotted/upgraded seat and do	Can exit three days prior to commencement of R-3 (i.e. on or

	not wish to retain the joined seat	before 6:00 PM of 08.10.2023) with forfeiture of security money to become eligible for further Ayush-UG Counseling (Central/State/ UTs)
Condition 7	R-2 seat allotted Candidates who wish to upgrade their seats in R-3	Report to the R-2 allotted institute physically and submit willingness for upgradation at the time of admission.
Condition 8	R-1 admitted candidate not upgraded in R-2 and want to participate in the R-3	Candidate can participate in the R-3 by filling fresh choices
Condition 9	Candidates who withdraw/ surrender their R-2 joined seat after 08.10.2023	Ineligible for further Ayush -UG Counseling (Central/State/ UTs)

NOTE

- All candidates are advised to ensure that the admission process is made by the allotted college through online mode only by generating the “**Provisional Admission Letter**” from the AACCC UG portal. Any **admission made through offline mode shall be treated as null & void.**
- Candidates are also advised to ensure that their seat “Surrender/Withdrawal letters “ are generated online through the AACCC-UG portal by the allotted institutes.
- All participating institutes are instructed to facilitate the admission/reporting of students even on holidays, if necessary.
