Kind Attention: All candidates participating in Stray vacancy Round of AACCC-PG Counseling for the A.Y. 2023-24.

Eligibility Criteria for candidates participating in the Stray Vacancy Round for AIQ seats under Govt./Govt. Aided / Central Universities/National Institutes

- 1. Registered candidates who have not been admitted to any seats during any Round of AACCC-PG counseling or State/ UTs Ayush PG counseling for the A.Y. 2023-24.
- Candidates must submit a willingness in the AACCC-PG portal to participate in the Stray Vacancy Round with an undertaking that they are not holding any PG (ASU&H) seats allotted through AACCC-PG counseling or State/ UTs Ayush PG counseling for the A.Y. 2023-24.
- Those candidates whose name is in the list of ineligible candidates published by AACCC,
 M/o Ayush vide notice dated 18.11.2023 are not eligible to participate in the Stray Vacancy Round of AACCC-PG Counseling 2023.

NO FRESH REGISTRATION and NO UPGRADATION during Stray Vacancy Round

Admission Rules for the Stray Vacancy Round

1. If Candidates get **allotted a seat in the Stray Vacancy** Round, they **must join the allotted institute**. If candidates **do not join the allotted seats**, their **security money will be forfeited**, and **they will become ineligible for further AYUSH-PG counseling 2023**. (Central/State/UT). 2. Further, if a candidate has participated in the Stray Vacancy Round by hiding the information that he/she is holding a seat allotted through any round of State/UT-Ayush PG Counseling and he/she has been allotted a seat in the Stray Vacancy Round, in that case appropriate action shall be initiated against the candidate for violating the directions of counseling issued by GoI/State/UT.
