First allotment phase (SVR-I)- for AIQ Registration & Choice filling available seats of Govt./Govt. Aided/CU/NI No upgradation available from previous rounds The vacant/ not reported/withdrawn seats available after the reporting period of SVR-I will be considered during the second allotment for those candidates who have not been allotted any seats through SVR-I. The second allotment will be purely based on the choices locked by the candidates/locked as per server time during the choice-filling period of the First allotment phase- SVR I. NOTE: Eligible candidates who wish to participate in SVR-I & II need to make a calculative decision before participating, as once they are allotted a seat in SVR-I & II of AACCC-PG Counseling, they must join the SVR-I & II allotted institute and their admitted seat / earlier allotted/ seat allotted after SVR-I or SVR-II result through any rounds of State/UT-Ayush PG Counseling 2024, if any, shall stand cancelled.

Eligibility Criteria For candidates participating in the Stray Vacancy Round (SVR-I&II) for AIQ seats under Govt./Govt. Aided / Central Universities/National Institutes	
1.	Only AIAPGET-2024 qualified candidates who have registered in the 1 st /2 nd /3 rd Round of AACCC-PG counseling are eligible to participate, provided that,-
	i. Candidates who have not been admitted to any of the seats through 1 st and 2 nd rounds AACCC-PG counseling or counseling conducted by State/UTs
	ii. Candidates who have not been allotted any seats through 3 rd round AACCC-PG counseling
2.	Candidates who have not registered in the AACCC-PG counseling and have not
	been admitted to any of the seats through State/UTs counseling are eligible to
	participate after registering on the AACCC-PG Portal during SVR-I.
3.	Round-1 non-joined/joined candidate who availed of Free Exit.

Stray Vacancy Round (SVR) for AIQ seats under Deemed Universities

As per the AACCC-PG counseling scheme 2024, AACCC, M/o Ayush will forward the list of registered eligible and ineligible candidates to the respective Deemed Universities for smooth counseling & admission process in the online Stray Vacancy round (SVR-DU) through the AACCC-PG portal. Only registered candidates who opt for 'Deemed Universities' in the 'Selection of Counseling' on the AACCC-PG portal are eligible for the Stray Vacancy Round (SVR-DU) and not registered in the AACCC-PG counseling are not eligible to participate in the SVR-DU. Therefore, candidates who registered for the AACCC-PG counseling and wish to take admission in the seats under Deemed Universities are advised to contact the respective Deemed Universities to participate in the Stray Vacancy Round (SVR-DU).
