<u>Kind Attention: All candidates participating in the Stray Vacancy Round for Deemed</u> <u>Universities of AACCC-UG Counseling for the A.Y. 2024-25</u>

In view of the **extension Cut-off date of admission** to ASU&H-UG courses for the A.Y 2024-25 till 31.12.2024 (*decision of NCISM/NCH enclosed*) and requests of various Deemed Universities, it has been decided to open Registration and Reporting facilities on the AACCC-UG Counseling portal for candidates who are seeking admission to seats under Deemed Universities. The schedule for the same is as follows:

Note: Cut-off date of admission to UG courses is 31.12.2024, as notified by NCISM/NCH

Eligibility for Participation

- 1. Candidates who are not registered/registered on the AACCC-UG portal and have not secured any seat allotted through State/UT counseling.
- 2. Candidates who have not been allotted any seats through Central/State/UTcounseling for the A.Y 2024-25.
- 3. Candidates whose names have not been reflected in the ineligible list published by AACCC-MoA on 23.12.2024 on the AACCC-UG portal


IMPORTANT NOTE

- Candidates seeking admission to the Deemed Universities are advised to opt for 'selection of counseling' as 'Deemed Universities' on the portal during this registration unlocking period.

- The Registration facility is available as ONE TIME MEASURE. After availing the said facility once, no further request in this regard will be entertained by the AACCC, M/o Ayush.
