

## **Revised Letter**

### Sub: - Application for Letter of Permission for functioning of Shalintai Meghe Homoeopathy Hospital College and Research Center, Wanadongri, Hingna, Nagpur, Maharashtra 441110 for Admission in I BHMS Course with intake capacity of 100 seats for the session 2024-25 regarding.

Sir,

Medical Assessment and Rating Board for Homoeopathy has received an application for starting new Shalintai Meghe Homoeopathy Hospital College and Research Center, Wanadongri, Hingna, Nagpur, Maharashtra 441110 with intake capacity of 100 seats in undergraduate course (BHMS) for academic year 2024-25.

2. After considering the report of inspection carried out by Medical Assessment and Rating Board on 4/06/2024 and 5/06/2024 and compliance and affidavits submitted after LOI, the competent authority has decided to issue Letter of permission to Start new Homoeopathic Medical College namely Shalintai Meghe Homoeopathy Hospital College and Research Center, Wanadongri, Hingna, Nagpur, Maharashtra 441110 with intake capacity of 100 seats in undergraduate course (BHMS) for academic year 2024-25, under NCH Act 2020 and its relevant regulations subject to the condition that following shortfalls shall be fulfilled.

The College shall appoint full time teachers and Guest Faculties as per Minimum Standards Requirements and Infrastructure and teaching & training facilities as specified in 'Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospital) Regulations 2013, as amended up to 2019.

#### a) Teaching departments: -

- 1. Department of pharmacy: -
  - Thin layer chromatography apparatus-not available (i)
  - (ii) Chemical balance 05 available against the requirement of 10.
- b) The College shall maintain genuinely functional hospital with required average number of patients in OPD and IPD with required bed occupancy etc.
- c) IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, and Phone Numbers etc. Case record shall be with complete case history analysis, evaluation and repertorisation.
- d) Diagnosis shall be written as per ICD 11 Criteria.
- e) All OPD and IPD case record shall be made available in the medical records room for academic purpose of students and follow up attendance of the patients.
- The applicant shall fulfil all the relevant provisions of Regulations namely 'Establishment of New f) Medical College (opening of new higher course of study or training and increase of admission

capacity by a medical college) Regulations 2011' (as amended up to 2018) and Homoeopathy (Degree Course) BHMS Regulations 1983, (as amended up to 2019), for considering issuance of letter of permission.

g) Aadhar Enabled Biometric Attendance System (AEBAS) shall be implemented within 30 days.

After considering the provisions of NCH Act,2020 and its relevant regulations conditional permission of the Medical Assessment and Rating Board is issued to Shalintai Meghe Homoeopathy Hospital College and Research Center, Wanadongri, Hingna, Nagpur, Maharashtra 441110 with intake capacity of 100 seats in undergraduate course (BHMS) for academic year 2024-25.

The letter issued by Medical Assessment and Rating Board for Homoeopathy vide letter no. 4-7/2024-25/NCH (MARBH)(115-73)/5567 dated: 24/12/2024 will be treated null and void.

Since it is constituent college of deemed university, it is further to mention that all admission shall be made from NEET qualified candidates only. It is further informed that minimum 100% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counselling for seats under all India quotas shall be conducted by respective Counselling Authority of State/UT govt. as designated by Central Government.

The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

The college has to comply with the full requirements as per NCH Act, 2020 for conducting the course. All deficiencies observed has to be rectified within 30 days' time from issue of this permission letter. The compliance report shall be submitted by the college to the Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online /Physical inspection for verification of compliance.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
