

DISCLAIMER

- a) It is assumed that every participating candidate of AACCC-PG Counseling has read, agreed, and accepted the Scheme and terms & conditions of the AACCC-PG counseling-2025.
- b) All Frequently Asked Questions (FAQs) are mandatory and not optional. Candidates are advised to review compulsorily all Frequently Asked Questions (FAQs) before registering on the AACCC website (https://aaccc.gov.in)
- c) The candidate shall fill out the application form online (https://aaccc.gov.in), preferably on their own, for AACCC-PG Counseling-2025. Application submitted through any other mode shall be summarily rejected.
- **d)** While registering on the AACCC-PG portal, all candidates are advised to use the same mobile number/e-mail ID they submitted during registration for the AIAPGET-2025 examination.
- The candidate should ensure that all the information filled in during the online registration/application form is correct and factual. The data entered by the candidate during registration on the NTA portal for AIAPGET 2025 will be pre-populated, and the same data is used for AACCC-counseling purposes. The AACCC, NCISM shall not entertain, under any circumstances, any request to change/modify/edit/alter the information provided by the candidates.
- f) Candidates can submit the AACCC-PG counseling registration/application form only once. Candidates who submit more than one registration/application form shall be debarred, and further action as deemed appropriate by the AACCC shall be taken.
- g) Registration facility shall be available at the beginning of the 1st Round, 2nd Round, 3rd Round & Stray Vacancy Round (SVR-I) as specified in the Counseling Schedule. Further, any request (for any reason) for registration shall not be entertained after the closing of registration. Fresh registration is available during the Stray Vacancy Round (SVR-I) for the A.Y. 2025-26.
- h) The Security Deposit will be forfeited if a candidate who has been allotted a seat in the Second Round or subsequent rounds and does not join the respective institution. The breakdown of the same is as follows-
 - (i) R-2 non-joined/joined candidates who avail exit with forfeiture.


- (ii) Candidate does not join the allotted seat in the 3rd Round/ Stray Vacancy Round (SVR-I & SVR-II)
- (iii) Candidate does not join the upgraded seat from Round-1, and Round-2 admitted seats.
- (iv) If the candidate gives wrong information at the time of registration based on which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.
- (v) Not upgraded candidate of Round-1 resigns from his joined seat after the announcement of the R-2 final result
- (vi) Candidate resigns his/her joined seat through offline mode after the completion of counseling.
- (vii) Non-compliance with the AACCC-PG counseling scheme 2025.
- (viii) Candidates withdraw their admitted seats allotted through Round- 2nd/3rd/SVR- 1/ SVR- 2.
- i) A candidate, if used a false/fake/incorrect information/document either at the time of registration/during admission, then such candidate shall be excluded from all admission processes and in case, such candidate has already been given admission, the admission shall stand cancelled.
 - j) In case, the joined candidates of R-1 whose seats have not been upgraded in R-2 OR joined (allotted/upgraded) candidates of R-2 decided to exit from the institute, in that case:
 - i. If they withdraw the seat till 3 days prior to the commencement of 3rd Round, the counseling fee will be forfeited.
 - ii. If they withdraw the seat between 3 days prior to the commencement of 3rd Round and till the R-3 final result announcement (excluding the result date), the counseling fee will be forfeited and become ineligible for AACCC-PG counseling for the A.Y 2025-26.
 - iii. If they withdraw the seat from the date announcement of R-3 final result, the counseling fee will be forfeited, and they become ineligible for any AYUSH PG counseling (Central/State/UT) for the A.Y 2025-26.
 - k) The reserved vacant (virtual and provisional seat matrix) AIQ (Govt. /Govt. Aided /CU/NI) seats that published before 3rd Round will be converted during the 3rd Round of counseling as per the algorithm placed at Chapter-4 only if the reserved seats are not opted by any candidates/non- availability of candidates of that particular category in the 3rd Round. Further, unreserved category candidates cannot claim the reserved seats shown to them as a virtual vacancy if the candidate of that particular category chooses the same seat.
 - l) Once a candidate is allotted a seat in the 3rd Round or Stray Vacancy Round (1st/2nd Allotment), he/she will not be allowed to exit from the admitted/allotted seat. If the

- candidate does so, he/she will not be eligible for any Ayush-PG counseling (Central/State/UT), and the counseling fees of such candidates will be forfeited. Further, a list of such ineligible candidates will be circulated to concerned State/UT counseling authorities, National Institutes/ Central Universities/ Deemed Universities to prohibit them from participating in other Ayush-PG counseling.
- m) Candidate may kindly note that merely registering for AACCC-PG Counseling-2025 does not confer automatic rights to secure a Postgraduate [MD/MS] seat. AACCC does not allot any seat either on nomination basis or manually. The selection and admission in any of ASU & H Institutions, recognized for running PG courses as per NCISM/NCH Act, 2020, is subject to the fulfillment of the merit, admission criteria, eligibility as prescribed by the respective Universities, medical institution, State/Central Government., NCISM, NCH, Central/State Government. AACCC shall not approve any admissions in contravention of the eligibility criteria specified for the courses.
- n) The information placed on the AACCC portal regarding fee structure/stipend/bond amount/rendering of service in rural or tribal areas/ hostel/ food/ other conditions has been provided by concerned Ayurveda /Siddha/ Unani/ Homoeopathy Colleges. The AACCC shall not take responsibility for the information provided by the participating institutes. Hence, Candidates are advised to visit the College website or contact the College Authorities directly for any query regarding the above information before filling choices. Once locked, the choices cannot be modified, and any request regarding tinkering choices will not be entertained by AACCC.
- o) Candidates are advised to confirm the fee structure/ any other additional fee from the colleges especially Deemed Universities, before filling up the choices. Some colleges/institutes might have a high fee structure; therefore, accurate information about the fee should be made beforehand. The AACCC takes no responsibility for the fee structure of the colleges.
- p) Counseling for All India Quota-PG (MD/MS) seats of Private ASU&H Institutes will be conducted by respective State/UT counseling authority; hence, the candidates are required to contact the concerned State-UT Counseling/Admission Authority for the same.
- **q)** Candidates are advised to visit the AACCC website (https://aaccc.gov.in) regularly for updates on Schedule / Results / Notices / Refund of security money etc.
- r) All admissions will be made through online mode only; therefore, candidates are advised to ask for an online-generated 'Provisional Admission Letter' at the time of physical reporting at the allotted institute to ensure that the college has admitted him/her through online mode.


- s) The AACCC will not entertain the admission/relieving/withdrawal/ cancellation made through offline mode by the college under any circumstances. If such action is noticed, it will be considered non-compliance with the AACCC-Counseling scheme 2025, and appropriate action shall be taken. Hence, all candidates are advised to ensure their admission/relieving/withdrawal/ cancellation is made through AACCC-Portal only.
- t) Some institutes reserved all their seats of permitted intake capacity for any special category students, then only that respective category students are eligible for admission to such institutes.
- u) The AACCC has no role in Counseling for Central Government Nominee (CGN) seats and Foreign Quota seats of ASU&H colleges.
- v) The role of AACCC is limited to the allotment of seats to the registered candidates, as per their merit and choices, based on the data/Information of qualified candidates received from the National Testing Agency (NTA), i.e. the AIAPGET-2025 examination conducting body.
- w) The security amount will be refunded to the bank account/credit card from which the payment has been made by the candidates on the AACCC-PG portal.
 - Candidates eligible for refund of the security deposite are strictly advised to keep their bank account/credit card active and functional until they receive the refund.
- x) The AACCC reserves its absolute right to alter, amend, modify or apply any or some of the instructions/ guidelines contained in this information bulletin. In case of any ambiguity in interpretation of any of the instructions/ terms/ rules/criteria regarding the determination of eligibility/conduct of counseling/ registration of candidates/ any information contained herein, the interpretation of the AACCC shall be final and binding in nature.
- y) Court cases w.r.t. counseling must be in Delhi jurisdictions area.

CHAPTER-1 INTRODUCTION

Ayush Admissions Central Counseling Committee (AACCC), National Commission for Indian System of Medicine, Ministry of Ayush, Govt. of India, New Delhi is conducting Online Counseling for the allotment of AIQ-Post Graduate (MD/MS) seats of Ayurveda /Siddha /Unani /Homoeopathy under Govt. /Govt. Aided /Central Universities /National Institutes /Deemed Universities (100%) and Institutional seats of BHU to AIAPGET qualified eligible candidates since 2019. The allotment of seats to the candidates is based on the candidate's merit in AIAPGET 2025 examination conducted by the National Testing Agency (NTA).

The AIQ-PG seats under AACCC-PG Counseling 2025 are as follows *:

- 15% All India Quota PG (MD/MS) Seats of Govt./Govt. Aided institute of all States/UTs
- 100% PG (AIQ and Institutional Quota) Ayurveda Seats of BHU, Varanasi, Uttar Pradesh ii.
- iii. 100% PG (Ayurved) seats of ITRA, Jamnagar, Gujarat (except nominated seats)
- 100% PG (Homoeopathy) seats of NIH, Kolkata, West Bengal (except nominated seats) iv.
- 100% PG (Homoeopathy) seats of NIH, Narela, Delhi v.
- 100% PG (Homoeopathy) seats of NHRIMH, Kottayam, Kerala vi.
- vii. 50% PG (Homoeopathy) seats of NEIAH, Shillong
- viii. 100% PG (Unani) seats of NIUM, Bangalore, Karnataka (except nominated seats)
- 100% PG (Unani) seats of NIUM, Ghaziabad ix.
- 100% PG (Unani) seats of NRIUMSD, Hyderabad, Telangana (except nominated seats) х.
- 100% PG (Unani) seats of RRIUM, Srinagar, Kashmir (except nominated seats) xi.

CHAPTER-2 COUNSELING TYPES & ROUNDS

15% AIQ OF GOVT./GOVT.AIDED ASU & H COLLEGES

- The AACCC will conduct four rounds of counseling for admission to 15% All India Quota seats through online mode: i.e. 1st Round, 2nd Round, 3rd Round, and Stray Vacancy Round (SVR-I & II).
- The seats that remain vacant after 3rd Round will continue to be filled in the online Stray Vacancy Round (SVR-I & SVR-II) of AACCC-PG counseling.


AIQ-CENTRAL UNIVERSITIES / NATIONAL INSTITUTES

- The AACCC will conduct four rounds of counseling for admission to AIQ seats under Central Universities and National Institutes through online mode: i.e. 1st Round, 2nd Round, 3rd Round, and Stray Vacancy Round (SVR-I & II).
- The seats that remain vacant after 3rd Round will continue to be filled in the online Stray Vacancy Round (SVR-I & SVR-II) of AACCC-PG counseling

100% AIQ of AU & H DEEMED UNIVERSITY

- The AACCC will conduct four rounds of counseling for admission to AIQ seats under Deemed Universities through online mode: i.e. 1st Round, 2nd Round, 3rd Round, and Stray Vacancy Round (SVR-I & II).
- There might be reservation for Jain Minority or Muslim Minority, etc. in certain Deemed universities. Candidates are requested to verify their eligibility for the same before applying under the said category.
- > All PG seats of Deemed Universities are domicile-free and un-reserved, i.e. reservation policy of Central Govt. is not applicable.

Distribution of PG Seats

- ➤ 50% of Seats of Ayurveda PG courses under BHU are deemed to be All India Quota, for which candidates from across the country shall be eligible.
- > 50% of Institutional quota seats of Ayurveda PG courses under BHU are reserved for candidates who have completed their undergraduate degree (BAMS) course from BHU.

Roster:

The roster on the 50% AIQ-PG seats and 50% Institutional Quota-PG seats of BHU shall be applied by the AACCC, NCISM.

Eligibility Condition for BHU Institutional seats:

The Institutional quota is allocated for only those students who have passed the BAMS fourth professional examination held in 2023 & 2024 in the Faculty of Ayurveda, IMS, BHU, and completed the internship in 2025 (i.e., by 31st July, 2025) provided the candidate has appeared and qualified in the AIAPGET-2025 examination. (BHU provides the eligibility condition for Institutional quota and tentative seat matrix for institutional quota. AACCC, NCISM has no role to play in this regard)

CHAPTER-5 RESERVATION POLICY

Reservation Policy of the Central Government for counseling & admission to All India Quota seats of ASU &H streams under Govt./Govt. Aided/National Institutes/Central Universities is as follows:

- ➤ S.C.- 15%
- > S.T.- 7.5%

The benefit of reservation will be given only to those castes and tribes that are mentioned in the respective central list of corresponding states published by the Government of India. (Websites: https://socialjustice.gov.in and https://ncst.nic.in).

- ➤ OBC-NCL- 27% (Non-Creamy Layer as per the current updated central list of OBCs http://www.ncbc.nic.in; OBCs present in the state list but not covered in the Central list of OBCs are NOT eligible to claim the reservation under All India Quota. The criteria for the Non-Creamy Layer (OBC-NCL) will be as per the notification of the Government of India).
 - Candidates belonging to the **Creamy Layer** of OBC are **NOT** entitled to reservation. Such candidates are treated as belonging to the general (GEN), i.e. unreserved category, and they will be eligible only for the OPEN seats the seats for which all candidates are eligible.
- ➤ GEN-EWS- 10% (The benefit of reservation will be given only to those General category candidates who satisfy the conditions prescribed in the prevailing norms and/or notifications issued by the Ministry of Social Justice and Empowerment/Govt. of India.)
- ➤ PwBD- 5% (as per relevant Regulations under NCISM/NCH/ITRA Act 2020). Candidates who want to avail of 5% PwBD reservation in AIQ-PG seats of Govt./Govt. Aided/Central/National ASU & H institutions should obtain a Disability Certificate as per 21 Benchmark Disabilities given under RPwD Act 2016 from the designated Disability Centers as per the list enclosed in ANNEXURE- II. The format of the PwBD certificate is attached in Annexure-I. The certificate issued by any other hospital/ board will not be accepted.

The category of candidates as provided by NTA in the AIAPGET-2025 result database is used for the AACCC-PG counseling process.

Candidates must note that the benefit of reservation will be given to them subject to verification of documents. If it is found at any stage that a candidate has used a false / fake / incorrect document, or has furnished false, incorrect or incomplete information, in order to avail the benefit of reservation, then such a candidate shall be excluded from all admission processes. In case such a candidate has already been given admission, the admission shall stand cancelled.

The reserved All India Quota vacant (virtual & Provisional) seats of ASU &H streams under Govt./Govt. Aided/National Institutes/Central Universities that published after the 2nd Round will be converted during the 3rd Round of counseling as per the following centrally approved conversion algorithm, only if the reserved seat is not opted by any candidate/non-availability of candidate of that particular category in 3rd Round. Further, candidates of the unreserved category cannot claim the reserved seats shown to them as a virtual vacancy if the same seat is opted by the candidate of that particular category. The NRI quota seats under Deemed Universities also shall be converted to Management Quota seats during 3rd round, if the Deemed Universities inform their willingness for the same in advance. The said conversion will be done only when the eligible Candidates belonging to the said Conversion Category have exhausted.

CHAPTER-6 COUNSELING SCHEME-2025

IMPORTANT

- ❖ AIAPGET-2025 Qualified candidates are required to register on the AACCC website (https://aaccc.gov.in) to participate in the AACCC-PG counseling 2025.
- ❖ Candidates are advised to use the same e-mail Address and Mobile Number for registration on the AACCC-PG portal for counseling which was submitted during Registration for AIAPGET- 2025.
- ❖ All the information/communication will be sent by AACCC on the registered E-mail address or registered Mobile Number only.
- Any request regarding change of registered mobile number or email address shall not be entertained by the AACCC under any circumstances.
- ❖ Candidates are advised to use a Laptop or Computer with the latest registered version of Chrome/Internet Explorer/Firefox/Windows/IOS during the Registration and Choice-Filling process to avoid any technical glitches.
- * Be extremely careful while registering in the AACCC-PG Portal as allotment of seats strictly will be as per the information provided by the candidate at the time of registration.
- * Candidates are advised to download 'Sandes App' for getting OTP on your registered phone number for registration.
- The AACCC, NCISM reserves its absolute right to alter, amend, modify or apply any or some of the instructions/ guidelines contained in this information bulletin. Eligibility:

Only AIAPGET-2025 qualified candidates are eligible to apply/register for the AACCC-PG counseling.

Process:

- **Step 1**: **Registration** for all AIAPGET-2025 qualified candidates who wish to participate in AACCC-PG Counseling for admission to ASU&H-AIQ seats under Govt/Govt.Aided/ Central Universities/National Institutes/ Deemed Universities.
- **Step 2**: **Payment of Counseling Fee** (Non-Refundable Registration Fee + Refundable Security money) as per the candidate's preference on the 'selection of counseling' in the AACCC-PG Portal i.e., (i) AIQ-

Govt (ii) Central Universities-National Institutes (iii) AIQ- Govt. Aided and (iv) Deemed Universities

Step 3: Choice filling is as per the candidate's preference on streams and Institute. (Candidates can lock their choices as per schedule; if the candidate cannot lock the choices in time, it will automatically be locked as per server time)

Step 4: Processing of Seat allotment as per candidate's merit and choices on streams & institutes locked by the candidate/locked as per server time on portal.

Step 5: Publication of provisional result on the AACCC-PG portal: If there are any queries on the allotment, candidates must mail to counseling-ayush@gov.in within the specified time before publishing the final result. Requests/queries on allotment after publishing the final result shall not be entertained.

Step 6: Publication of final Seat allotment list (final result): Candidates can download the provisional allotment letter from the AACCC-PG portal.

Step 7: Physical Reporting to the allotted college/institute with all original documents (Refer FAQ No. 25 to 30) within the stipulated time as per schedule.

Note: The registration unlocking facility schedule is available "as a one-time measure" for all candidates who have not locked their choices to edit/modify their registration details on the portal if they fill in any wrong information.

The choices filled during the 1st & 2nd Round become null & void (candidates can lock their choices as per schedule; if the candidate cannot lock the choices in time, it will automatically be locked as per server time)
- **Step 4: Processing of seat allotment** as per candidate's merit and choices on streams and institutes locked by the candidate/locked as per server time on the portal.
- **Step 5: Publication of provisional result** on the AACCC-PG portal; if any queries on the allotment, candidates must mail to counseling-ayush@gov.in within the specified time before publishing the final result. Requests/queries on allotment after publishing the final result shall not be entertained.
- **Step 6: Publication of final Seat allotment list** (final result): Candidates can download the provisional allotment letter from the AACCC-PG portal.
- **Step 7**: Publication of list of candidates who secured their AIQ-PG seats through R-1/R-2 till the date of announcement of R-3 final result and who have been allotted seats in R-3 are ineligible for any Ayush-PG Counseling 2025 (Central/State-UT). STRAY VACANCY ROUND FOR GOVT./GOVT.AIDED/CU/NI/DEEMED

➤ The ASU&H - Govt./Govt. Aided Colleges/Central Universities(CU)/National Institutes(NI)/ Deemed Universities seats remain vacant (not joined/withdrawn) after the 3rd Round of AACCC-PG Counseling will continue to be filled through the online Stray Vacancy Round conducted by the AACCC.

Note:- For Academic Year 2025-26, after 3rd Round, the counseling for admission to vacant seats under deemed university will be conducted along with online Stray Vacancy Round for under Govt./ Govt. Aided colleges/CU-NI. There will be two phase allotment for Stray Vacancy Round (SVR-I and II). That means there will not be any separate Stray Vacancy Round available for Deemed Universities. There will not be any institutional level counseling for Stray Vacancy Round.

Vide Court order dated 30.11.2023 in SCA No. 19485/2023 at the High Court of Gujarat, to comply with the direction of the court, AACCC, NCISM has decided to conduct two-phase allotments in the Stray Vacancy Round for seats under Govt./ Govt. aided/CU/NI in the name of SVR-I and SVR-II. However, it is stated that Stray Vacancy Round Phase—II is not mandatory and it will be conducted only if seats are vacant after Stray Vacancy Round Phase-I.

Eligibility for participation:

- a) Only AIAPGET-2025 qualified candidates who have registered in the 1st/2nd / 3rd Round of AACCC-PG counseling are eligible to participate, provided that,
 - i. Candidates who have not been admitted to any of the seats through AACCC-PG counseling or counseling conducted by State/UTs.
- **b)** Candidates who have not registered in the AACCC-PG counseling and have not been admitted to any of the seats through State/UTs counseling are eligible to participate after registration on the AACCC-PG Portal.
- c) Round-1 non-joined candidate availed of Free Exit.
- **d**) Round 1 admitted Candidates who availed of Free Exit till the date of announcement of the R-2 final result (**excluding final result date**).
- e) Round 1 admitted candidates but not upgraded during R-2 and availed of exit with forfeiture 3 days prior to the commencement of R-3 can participate with full payment of counseling fees.
- **f**) Round 2 non-joined candidates who availed of exit with forfeiture of counseling fees can participate with full payment of counseling fees.

Ans: The Online seat allotment process will start as per the Schedule of the AACCC-PG Counseling for the Academic Year 2025-26. Please See the Schedule and notices uploaded on the AACCC website (https://aaccc.gov.in/) from time to time.

Q.No.2. How do I register on the AACCC website/Portal, and how do I fill in Choices?

Ans: Candidates must log on to the website (https://aaccc.gov.in) to register and fill in choices. Before choice filling/locking for each round, candidates are advised to make a tentative list of colleges or courses as per preference after going through the provisional seat matrix uploaded in the "Current events" section of the AACCC website.

IMPORTANT

The registration facility will be available at the beginning of the 1st Round, 2nd Round, 3rd Round and Stray Vacancy Round (SVR-I)

Q.No.3. How and when do I have to make the payment for AACCC-PG counseling?

Ans: After registration, the payment page appears automatically. Candidates can only make online payments by Net Banking /Credit card/ Debit card (preferably from Nationalised Banks), or UPI. After the successful completion of payment, the candidate can proceed with choice filling.

Q.No.4. Do I have to report to any counseling centre for registration or choice filling?

Ans: No, Online registration and choice filling can be done from a place of convenience (including home) using a laptop/computer with an uninterrupted internet facility.

Q.No.5. Do I need to upload any documents to register on the AACCC-PG portal?

Ans: There is no need to upload any academic documents on the portal. However, you need to fill up the similar information which you gave at the time of registration for the AIAPGET-2025 examination on the NTA website.

IMPORTANT

During registration on the AACCC portal, you have to fill in exactly the same credentials (spelling, numbers, etc.) which candidates had already filled at the time of registration for the AIAPGET-2025 examination on the NTA website.

Q.No.6. How do I get the password for logging in?

Ans: During the process of online registration, you have to create your unique password. Candidates are advised to keep the password confidential till the end of the counseling process. The candidate can change the password as per convenience. Sharing of password can result in its misuse by somebody else, leading to even exclusion of genuine candidates from the online allotment process. (*Please see the password policy uploaded in the AACCC portal*)

Q.No.7. Difficulty in login; what may be the problem(s)?

Ans: Follow the instructions about the use of the browser (latest registered version of Chrome/Internet Explorer/Firefox/Windows/IOS), as it is difficult to log in from other browsers. Use similar spellings and the similar format of the date as in the online application form submitted at the time of registration of the AIAPGET-2025 examination on the NTA website. The internet connection should be uninterrupted. If an interruption in the internet connection occurs, the IP address being monitored will change, and the session expired message will be displayed.

Q.No.8. I have difficulty in creating a Password; what may be the problem(s)?

Ans: Create a password as per the password policy uploaded on the website. Please use the internet browser as suggested above (Q.No.7) while creating a password. Use the 'Shift' key instead of the 'Caps Lock' key.

Q.No.9. If I forgot the password, how to retrieve it?

Ans: To retrieve the forgotten password, the software system facilitates the following process:

Reset password using a reset link via registered E-mail

Candidate has to enter their AIAPGET-2025 examination Roll No. If entered data (Roll No.) matches with the backend database, then the system will send a reset password link to the registered email-id. After clicking the received link in the mail-inbox, candidates must follow the online instructions to reset the New Password.

OR

Reset password using an OTP via SMS

Candidate has to enter their AIAPGET-2025 examination Roll No. If entered data (Roll No.) matches with the backend database, then the system will send a verification code through SMS to the registered mobile no. Candidates are required to enter a verification code, and if the verification code matches with the database, the system will prompt resetting New Password.

IMPORTANT

It is strongly recommended that the OTP sent to the applicant for any activity like reset password etc. must not be shared with anyone. This OTP is confidential and to be used by the applicant only. Neither AACCC nor NIC will be responsible for violation or misuse of the password/OTP.

Q.No.10. Can I edit/modify the registration details if I fill in the wrong information during registration on the AACCC-PG portal?

Ans. Yes. You can edit/modify the registration details by availing registration unlocking facility under tab 'Available Services' on the portal. Candidates can avail this facility before choice locking, and it is available as a 'one-time measure' in time bound manner. Candidates can make following changes on the portal by availing this facility:

- i) Edit/modify the registration details and choices submitted by the candidate.
- ii) Edit the 'selection of counseling'.

Q.No.11. When I try to log in for choice filling, it says wrong roll number/password; what may be the problem(s)?

Ans: Password is case-sensitive; therefore, use exactly the same password created earlier. In case the password is forgotten, try to retrieve it using the process mentioned in **Q.No.9** above.

Q.No.12. Is there any restriction for filling up the number of choices of Institutions and courses?

Ans: Candidate can give as many choices as he/she wish during online choice filling. However, the candidate must fill in the choices of colleges/courses in the order of his/her preference (higher to lower). There will be common counseling platform (https://aaccc.gov.in) for Govt./ Govt. Aided/ National Institutes/ Deemed & Central Universities/institutional Quota seats of BHU for filling up choices.

Q.No.13. Can I know the seat I will likely get at my rank?

Ans: Candidate can have some idea on the selection of college/course from the following facts uploaded on the AACCC-PG portal:

- ➤ AACCC uploads the 'List of Admitted Candidates through AACCC-PG Counseling for the Academic Year 2024-25' in ASU&H-PG courses in the "Current Events" section under the "PG Counseling tab" on the AACCC- website (https://aaccc.gov.in/).
- ➤ Before registering on the AACCC-PG portal, all candidates are advised to review this information for a better idea on the allotment of seats for the A.Y. 2024-25. This will

only be indicative, and the admission pattern for the current Academic Year may vary depending on the availability of PG seats in ASU&H courses.

Q.No.14. How do I know about the availability of seats in participating institutes during 1st Round of AACCC-PG counseling?

Ans. AACCC will upload the data on the Provisional seat matrix in the "Current Events" Section on the AACCC-PG portal during each round of counseling. The information on the vacant seats in the participating institutes will be available on the Provisional seat matrix.

Q.No.15. Is filling up and locking of choices necessary to get the seat allotted? Or will I be allotted a seat automatically from leftover seats?

Ans: After online registration, you must fill in the choices of colleges/courses in order of your preference (higher to lower) and lock it before the server time during each round of counseling as per schedule. The submitted/ filled choices can be modified before locking. If candidates do not lock the choices submitted by them, it will automatically be locked as per schedule/ Server time. You will not be allotted any seats if you don't fill in choices even after registering on the AACCC portal. Candidates can download/print out the locked choices for future reference.

Q.No.16. Is it necessary to download the duly filled registration form for AACCC-PG Counseling from the AACCC- portal?

Ans: Yes, it is necessary to download the duly filled registration form for AACCC-PG Counseling from the AACCC-PG portal. Some universities instruct the candidates to submit the same to complete the admission process.

Q.No.17. Can I modify my choices during the choice submission period for counseling?

Ans: Yes, you can modify, add or delete your choices during the choice Filling period. Further, it is advised to do the same before locking the choices by yourself or the System as per schedule/ Server time.

Q.No.18. What will happen to my choices if I have not locked my choices before the time specified in the counseling schedule on the last date of choice locking?

Ans: The choices submitted and saved will be locked automatically on the last date of choice filling/locking period as per server time.

Q.No.19. How can I get a printout of my choices?

Ans: Candidates are requested to login to the AACCC-PG portal and take a printout of their choices that they have locked during the choice filling /Locking period or after the specified time of the last date of choice locking.

Q.No.20. Is it possible to modify/edit my choices after the choice locking?

Ans: Once the choices are locked, it is impossible to unlock the same, even from the AACCC end. Hence, the candidates are advised to verify all choices before locking in. The Choices, once locked, cannot be modified, and any request to the AACCC, regarding tinkering of choices will not be entertained.

IMPORTANT

Don't wait till the last minute to Register and filling choices on the AACCC-PG portal. Please go through your selected/submitted choices before locking, as once you lock the choices it cannot be modified or changed. It may result in the allotment of a seat which you never wanted. (Please note that the choices once locked cannot be unlocked even from the AACCC end)

Q.No.21. What about the Stipend/ fee structure/ bond amount / accommodation / hostel/ food/ rendering of service in rural/ tribal areas/other conditions for the allotted course/college?

Ans: Stipend/Fee structure/bond amount/accommodation/hostel/food/rendering of service in rural areas/tribal areas/other conditions, etc., may vary amongst States/Universities/Institutes. The allotment made through the online Counseling process will be firm and final. Therefore, the candidates should be aware of these points before opting for a seat of ASU & H Colleges. The AACCC shall neither be responsible nor entertain any cases on the above grounds.

The information received from the participating ASU&H-PG Colleges has been made available on the Counseling website. However, before filling the choices, candidates are advised to visit the College website or contact the College Authorities directly for any query regarding the above information.

IMPORTANT

AACCC has no role in the fixation of Fee Structure/Stipend/Bond of ASU & H Colleges. Therefore, the AACCC will not entertain any request or complaint regarding Fee Structure/Stipend.

Q.No.22. How much time will be given to join the allotted course/Institute?

Ans: Candidates who have been allotted seats are advised to join the allotted College/Course as per the schedule and reporting rules for that round. However, candidates are advised to join as early as possible and not to wait till the last day of joining due to the different holiday/working hours schedules in various ASU & H Colleges. Some colleges may take 2 to 3 days to complete the admission formalities due to the institute's different holiday/working hour schedules.

Q.No.23. Whether my admission is valid if the college admitted me to the allotted seat through offline mode?

Ans: No, the AACCC will not approve the admission made through offline mode by the college under any circumstances. Therefore, candidates are advised to ask for an online generated 'Provisional Admission Letter' through the AACCC-PG portal at the time of admission to ensure that the college has admitted him/her through online mode.

Q.No.24. What will be the fate of the seat at which the college makes offline admission?

Ans: If a candidate is admitted through offline mode at the allotted seat, the seat occupancy will be shown as 'vacant' in the PG-admitted/reported list in the AACCC-Portal; further, this vacant seat will be filled in the subsequent round of AACCC-PG counseling. Therefore, the offline admitted candidate will lose his/her allotted seat in the respective round of the AACCC-PG counseling.

Q.No.25. What documents are required at the time of joining in allotted ASU&H College?

Ans: Original documents (along with attested photocopies, preferably 02 sets of documents) required at the time of joining the allotted ASU&H College are as mentioned below:

- i. Provisional Allotment Letter issued by AACCC
- ii. AIAPGET-2025 Admit Card issued by NTA
- iii. AIAPGET-2025 Score Card issued by NTA
- iv. Class 10th Pass Certificate and Marks sheet
- v. Higher Secondary Certificate and Marks sheet
- vi. Mark Sheets of BAMS/BUMS/BHMS/BSMS 1st, 2nd& 3rd Professional Examinations or 1st, 2nd, 3rd & 4th Professional Examinations (as applicable).
- vii. BAMS/BUMS/BHMS/BSMS Degree Certificate or Provisional Degree Certificate (MQRL-Under Graduate -Medical Qualification should be duly recognized by NCISM/NCH).
- viii. Twelve months Compulsory Rotatory Internship Completion Certificate.
- ix. Permanent Registration Certificate at time of course commencement.
- x. Permanent Registration Certificate issued by NCISM/ NCH/ CCIM/ CCH /State Ayurveda/Siddha/Unani/Homoeopathy Board
- xi. Date of Birth Certificate. [If the 10th Certificate does not bear the same.]
- xii. Eight (8) Passport size photographs. (Same as affixed on the AIAPGET-2025/AACCC-PG counseling-2025 online application form).
- xiii. Candidates must carry one of the identification proofs (ID Proof) to the allotted

- college at the time of admission (i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
- xiv. Medical Fitness Certificate issued by Registered Medical Practitioner in the prescribed format is attached as (Annexure-VI).
- xv. Transfer Certificate/College Leaving Certificate from the last studied institution.
- xvi. The Candidate should also bring the following certificate, if applicable:
- a) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act, 2016, will be accepted. The format of the Certificate of Disability is attached as (Annexure-I). No other PwD certificate issued by any other Authorities/ Hospital will be accepted. (The qualified candidates with Benchmark Disability (PwBD)-should get themselves certified at one of the Disability Assessment Boards, constituted in various States/UTs. The list of authorized designated Centers that will issue Disability Certificates as per 21 Benchmark Disabilities given under RPwD Act-2016 is attached as (Annexure-II).
- b) SC/ST Certificate issued by the competent authority, and it should be either in English or Hindi. Sub-caste should be mentioned in the certificate and tally with the respective central list of corresponding states published by the Government of India (https://socialjustice.gov.in/common/76750) and (https://tribal.nic.in/Knowledge Hub.aspx).

The certificate should be as per the prescribed format of the Government of India (Annexure -III).

- c) OBC-NCL certificate issued by the Competent Authority (issued on or after 1 April 2025) as per the prescribed format of the Government of India. The sub-caste in the OBC-NCL certificate should tally with the updated Central List of OBC http://www.ncbc.nic.in. The OBC-NCL certificate format is attached as (Annexure-IV).
- d) Economically Weaker Section (GEN-EWS) certificate issued on or after 1 April 2025 by the Competent Authority. (Annexure-V)

IMPORTANT

Candidates without original certificates/documents shall not be allowed to take admission to the allotted ASU&H College. Candidates who have deposited their original documents in any other Institute/College/University and come for admission with a certificate/undertaking stating that "original certificates are deposited with the Institute/College/University" or bring colored photo copy of original documents shall not be allowed to take admission in allotted ASU & H College.

Q.No.26. I joined the BAMS course before 2010 and graduated with 6 months internship, am I eligible to participate in the AACCC-PG counseling?

Ans. Yes. The candidates who joined BAMS courses before 2010 and graduated with 6 months' internship are eligible to participate in the AACCC-PG counseling. (Refer: CCIM Regulations 1989)

Q.No.27. Is it necessary to submit Domicile Certificate for admission to AIQ-PG seats under the ASU & H stream?

Ans. No. It is not necessary to submit Domicile Certificate for AIQ-PG seats at the time of admission to the allotted institute as the AIQ seats are domicile-free, vide Ministry's letter L-18020/2/2023-EP-I dated 26.05.2023.

Q. No.28 Should I submit any other certificate (e.g. Caste validity certificate) to complete the admission process?

Ans. Candidates are advised to confirm with the allotted Colleges regarding any requirement of certificates other than that mentioned in **FAQ No.25**. If so, the candidates are instructed to bring such required certificates (e.g. Caste validity certificate) at the time of reporting at the allotted seats.

Q.No.29. In which format should I submit the certificates; if I do not submit certificates in the prescribed format, what will happen to my allotted seat?

What are the instructions regarding GEN-EWS, OBC, SC, ST & PwBD certificates and Reservations?

Ans. Candidates need to submit the relevant certificates issued by the competent authority in the prescribed format of the Government of India, as mentioned in annexures. If the candidate fails to produce the Caste, EWS and PwBD certificate in the prescribed format at the allotted ASU & H College, then he/she will not be permitted to take admission.

Q.No.30. From where will I get the details of the reservation and certificates?

Ans. You must read the AIAPGET-2025 Bulletin/Prospectus carefully regarding Caste, GEN-EWS and PwBD Reservation/Certificate. Please click on the link to see the AIAPGET-2025 Information Bulletin.

Q.No.31. Is there any upper age limit for the candidates seeking admission to ASU &H-PG courses for the academic year 2025-26?

Ans: There is no upper age limit for admission to ASU & H-PG courses.

Q.No.32. If I have a Birth Certificate/Caste Certificate/other certificates (s) in the regional language, will it be acceptable at the time of reporting/joining?

Ans: Certificates issued by the Competent Authority shall preferably be in Hindi or English language. In case the certificate is issued in regional language (other than Hindi or English), candidates are advised to carry a certified (attested) Copy of the Hindi/English version of the original certificate along with the original certificate.

Q.No.33. What can I do if there is a spelling discrepancy between the documents and the application form?

Ans: If there is a discrepancy in spelling in documents, the candidate must carry an affidavit/undertaking to prove that the documents belong to the same person.

Q.No.34. At the time of admission, will my original certificates be retained by the allotted college/institution?

Ans: **Yes,** all participating colleges/institutions have been instructed to retain the original certificates of admitted students and release them only after the seat has been upgraded or the candidate withdraws/cancels the seat.

Q.No.35. Whether candidate's category will be changed during admission at the allotted institute if a category candidate (OBC-NCL/EWS...etc.) gets allotted a seat under the UR category?

Ans: No, if the candidate has a valid category certificate (OBC-NCL/EWS...etc.), the candidate's category (OBC-NCL/EWS...etc.) will not be changed to the allotted UR category during admission at the allotted institute. But, if the candidate fails to produce a valid category certificate (OBC-NCL/EWS...etc.), the college has to change the candidate's category to the allotted category on the portal while verifying documents after getting consent from the candidate for completing the admission process.

Q.No.36. What happens if the college/institute changes the category (e.g. OBC-NCL/EWS) of the candidate to the allotted category (UR) during admission if the candidate gets allotted a UR category seat?

Ans. Suppose the college changes the candidate's category (e.g. OBC-NCL/EWS) to the allotted UR category on the portal during admission for any reason; in that case, the candidate will be considered as a UR candidate in subsequent rounds of counseling, and they are not eligible for allotment of the seat of their category (e.g. OBC-NCL/EWS). Hence, candidates are advised to be aware of this category change during choice filling for the subsequent rounds.

Q.No.37. Is NRI (Non-Resident Indian)/OCI (Overseas citizens of India)/PIO (Person of Indian Origin) candidate eligible for admission to ASU & H PG courses?

Ans. Yes. NRI/OCI/PIO candidates are eligible for admission to ASU & H- PG courses after qualifying for the AIAPGET-2025 examination. Such candidates have to submit the original certificate from the concerned Indian Diplomatic Mission in the country of their residence at the time of admission to the allotted institute. Further, for OCI/PIO candidates need to produce citizenship certificate/ card number at the time of admission.

Q.No.38. What is the procedure for admission at foreign quota seats in ASU & H PG courses?

Ans. Foreign nationals need not qualify for the AIAPGET 2025 examination for admission to ASU&H-PG courses. Further, AACCC has no role in counseling for foreign quota seats.

Q.No.39. What are the documents mandatorily required for NRI quota admission?

Ans. Following certificates are mandatorily required for NRI quota admission

- a) Passport/ Visa copy of sponsorer,
- b) Embassy certificate of the Sponsorer (Certificate from the Consulate).
- c) Sponsorship affidavit (stating that sponsorer is ready to bear the expenses for the whole duration of study)
- **d**) Relationship Affidavit (Relation of Candidate with the sponsorer)
- e) AIAPGET 2025 Score Card of the candidate.

Q.No.40. Where will I get NRI quota admission for Ayurveda, Unani and Homoeopathy postgraduate courses through AACCC-PG counseling?

Ans. The NRI quota seats are available at Deemed Universities participating in the AACCC-PG counseling. The details of the seat availability will uploaded in the provisional seat matrix of Deemed Universities under the 'Currents Events' section on the AACCC-PG portal during each round of counseling.

Q.No.41. If I joined a PG course/subject under ASU & H stream during R-1/R-2, am I eligible for other PG course/subject in that particular stream during subsequent rounds?

Ans. Yes. You are eligible for allotment to other PG Course/subject in that particular stream during subsequent rounds. However, eligible candidates are advised to submit their willingness for up-gradation during reporting at the R-1/R-2 allotted institute and submit fresh choices of their preferred course/subject in the subsequent rounds (R-2/R-3). Upgradation is available upto Round-3.

IMPORTANT

Please note that, in case, you have joined the course/college allotted in the 1^{st} Round and not submitted the option for up-gradation in the 2^{nd} Round, you will not be considered eligible for up-gradation in the 2^{nd} Round/ 3^{rd} Round.

ROUND-2 (FAQs)

Q.No.42. I have registered in the 1^{st} Round; should I register again for the 2^{nd} Round?

Ans: Only candidates who have not registered in the 1^{st} Round need to register afresh for the 2^{nd} Round.

Q.No.43. I have submitted willingness for up-gradation in the 2nd Round while joining the 1st Round allotted seat. Later changed my decision and wanted to retain the 1st Round joined seat; how it is possible?

Ans: The candidate does not need to fill any fresh choices for the 2nd Round, so the earlier R-1 joined seat will be retained. If the seat gets upgraded on submission of fresh choices during R-2, the earlier R-1 joined seat will be cancelled. Further, the candidate needs to join the Round-2 upgraded seat as per the R-2 reporting rules of Counseling Scheme 2025.

Q.No.44. Is it necessary to join the allotted ASU&H College of Round-1 to get a chance to participate in the 2nd Round?

Ans: No. If the candidate is not interested in the 1st Round allotted seat, he/she can avail free exit without reporting/joining the allotted college; further, he/she can participate in the 2nd Round with fresh choices. However, if he/she wants to hold the Round-1 allotted seat, he/she should join the allotted College physically and submit willingness for up-gradation for the 2nd Round.

Q.No.45. Who is eligible for the 2nd Round of allotment?

Ans: Candidates eligible for seat allotment in the 2nd Round would be from one of the following groups:

Group–I: Newly registered candidate for R-2

Group-II: Registered candidates who got no seats in the R-1.

Group–III: Candidates who have reported at the R-1 allotted institute and submitted willingness for 2nd Round up-gradation.

Group-IV: Candidates who have been allotted seats in the 1st Round but availed of 'free exit'.

Group-V: Candidates who have resigned/availed free exit from the R-1 joined seats before the commencement of R-2 and filled choices till the last day of the choice-filling period for R-2.

Q.No.46. What is the procedure for 2nd Round?

Ans: All eligible candidates who wish to participate in the 2nd Round of online allotment will have to submit fresh choices and lock the choices during the choice-filling/locking period. All choices will be published as provisional and virtual seat matrices on the portal. The virtual vacancies are seats likely to be get vacated during up-gradation. Eligible candidates will be allotted seats based on their merit and choices.

Choices submitted during R-1 will become null and void. In the case of candidates who have submitted willingness for up-gradation in R-2, their remaining choices submitted during R1 would be initialized (i.e., the choices remaining after allotment of seats in Round-1 will stand cancelled); hence, all candidates are required to submit fresh choices for up-gradation to the 2nd Round.

Q.No.47. Do I have to fill up the choice of courses and Colleges to participate in the 2nd Round of the online allotment process?

Ans: Yes, eligible candidates must submit fresh choice(s) of college(s)/course(s) for online seat allotment during the 2nd Round. In case a candidate does not fill in fresh choice(s) during the choice-filling period, the candidate will not be considered for seat allotment during the 2nd Round and will retain the already joined seat in the 1st Round, if any.

IMPORTANT

If candidate want to upgrade his/her admitted seats of 1st and 2nd Round, need to fill in fresh choices during 2nd and 3rd Round.

Q.No.48. Is it necessary to join the R-2 allotted college/seat that upgraded from R-1?

Ans: Yes. If the candidate gets upgraded a seat during R-2, the R-1 joined seat will be cancelled automatically (i.e., that seat will be allotted to somebody else). Upgraded candidates of R-2 are advised to join the college/seat as per the reporting rules after obtaining an online-generated relieving letter from the R-1 joined college. If R-1 joined candidates upgraded in R-2 and do not wish to join the upgraded college/seat, they can avail of exit with forfeiture of counseling fees.

Seats can also be upgraded in the same college (same course) by change of category (i.e.ST/SC/OBC to UR or PwD to non-PwD) during R-2; in such a case, the candidate has to take fresh admission on the upgraded seat of R-2 by taking online generated '*Relieving letter*' from the R-1 Joined seat.

O.No.49. Is it necessary to join the R-2 allotted college/seat?

Ans: If candidates get allotted a seat in R-2 and wish to join, they are advised to join the allotted seat as per schedule, otherwise, they can avail of exit with forfeiture of counseling fees.

Q.No.50. What is the time period for the free exit for R-1 admitted candidates?

Ans: R-1 admitted candidates who wish to resign the R-1 seat can avail of free exit till the date of announcement of the R-2 final result. After this stipulated time, R-1 joined candidates are treated as R-2 joined candidates, and R-2 rules will apply to them.

Q.No.51. If my R-1 seat is not upgraded in R-2, and I wish to withdraw R-1 joined seat, will I be eligible to participate in further rounds of AACCC-PG Counseling?

Ans: After the announcement of the R-2 result, R-1 joined candidates who have not been upgraded in Round 2 are treated as R-2 joined candidates, and R-2 rules apply to them. If such candidates wish to withdraw their R-1 joined seat, they can exit with forfeiture of counseling fees till three days prior to the commencement of R-3, then they will be eligible to participate in AACCC/State/UT-PG counseling. If the candidate withdraws the seat beyond the stipulated period, he will be ineligible for AACCC-PG Counseling. (But eligible for State/UTs Ayush counseling. For more details, refer counseling scheme for R-2)

Q.No.52. I opted for up-gradation in the 2nd Round/3rd Round of counseling when reporting to the 1st Round/2nd Round allotted college. Will my earlier joined R-1/R-2 seat be cancelled?

Ans: Yes, once the seat is upgraded during the 2nd Round/ 3rd Round, the earlier R-1/R-2 joined seat will automatically be cancelled, respectively, and the same will be allotted to another candidate. Therefore, you are advised to fill in only higher choices or choices which you prefer over the earlier joined seat.

Q.No.53. Can I join the college directly if my seat gets upgraded during the 2nd Round/3rd Round from the 1st Round/2nd Round of AACCC-PG counseling?

Ans: No, You must get an online-generated relieving letter from the earlier R-1/R-2 joined institute/college before joining the R-2/R-3 upgraded seat/college. The candidate will not be permitted to join the upgraded seats without a relieving letter from earlier admitted institutes and original documents

Q.No.54. If I get an upgraded seat in the same college because of a change of category (e.g. from SC/ST/OBC to UR category), do I have to take admission on the upgraded seat again?

Ans: Yes, you have to proceed as follows:

Step-1: Get an **online-generated relieving letter** through the AACCC portal from the institute for the earlier joined seat.

Step-2: You must join the upgraded category seat and get an online-generated **Provisional Admission Letter** through the AACCC portal for the upgraded category seat (your earlier joined seat would be cancelled and allotted to another candidate).

Q.No.55. Is it necessary to join the 2^{nd} Round allotted/upgraded seat to participate in the 3^{rd} Round?

Ans: If a candidate gets allotted/ upgraded a seat in R-2, following rules he must follow to participate in 3rd Round:

- ➤ If a candidate wishes to hold the R-2 allotted/upgraded seat, he/she needs to join the college physically and give up-gradation willingness for the 3rd Round at the time of admission to the 2nd Round allotted/upgraded college.
- ➤ If a candidate does not wish to hold the R-2 allotted/upgraded seat, he can avail of exit with forfeiture of counseling fees as per the reporting schedule for R-2 (need to pay complete fees again to participate in subsequent rounds as per the eligibility criteria fixed for that round.)
- ➤ If a candidate wants to resign the Round-2 joined seat, can withdraw the seat 3 days prior to the commencement of the 3rd Round with forfeiture of counseling fees; then he/she will be eligible to participate in further AACCC/State/UT- PG counseling. If a candidate fails to do so, he/she shall become ineligible for AACCC-PG counseling.

IMPORTANT

In case, candidates have not submitted willingness for up-gradation in the 3^{rd} Round at the time of joining/reporting to 1^{st} / 2^{nd} Round allotted College, he/she will not be considered eligible for up-gradation in the 3^{rd} Round.

Q.No.56. If I joined the Round-2 allotted seat but later changed my decision and wanted to exit, can I participate in further AYUSH counseling (AACCC/State/UT)?

Ans: Conditions to participate in further AYUSH counseling (AACCC/State/UT) is as follows:

- ➤ Round-2 joined candidates who withdraw/surrender their seats three days prior the commencement of the 3rd Round with forfeiture of counseling fees can participate in further AACCC/State/UT- PG counseling.
- ➤ R-2 joined candidates who withdraw their admitted seat with forfeiture of counseling fees between the period of 3 days before the commencement of R-3 and till the date of announcement of R-3 final result (excluding the final result date) will be **eligible** for State/UT counseling but **ineligible** for further rounds of AACCC-PG Counseling.

➤ R-2 joined candidates who withdraw their admitted seat with forfeiture of counseling fees from the date of announcement of R-3 final result will become **ineligible** for AACCC/State-UT-PG Counseling.

Q.No.57. Is there a free exit available in Round 2?

Ans: There is no free exit available in R-2. Candidates who get allotted/ upgraded a seat in R-2 are advised to join the R-2 allotted/upgraded seat as per the reporting schedule. Otherwise, their counseling fees will be forfeited.

Q.No.58. Am I eligible for further AYUSH-PG counseling if I resign from joined institute/course allotted in the 2nd Round?

Ans: Yes. Candidate shall be eligible for further AACCC/State/UT AYUSH-PG counseling if he/she withdraws the R-2 joined institute/ course three days prior to the commencement of registration for the 3rd Round with forfeiture of counseling fees, otherwise ineligible as mentioned in the **FAQ No 56.**

Q.No.59. Who will be eligible for the "Exit with Forfeiture" option in the 2nd Round?

Ans: Following candidates will be eligible for 'Exit with Forfeiture'

- ➤ Candidates who do not wish to join the R-2 allotted seat can avail of exit with forfeiture within the reporting schedule as per the AACCC-PG counseling scheme.
- ➤ Candidates who wish to withdraw the R-2 joined seat can avail of exit with forfeiture three days before the commencement of the 3rd Round so that he/she will be eligible for AACCC/State/UT/Central pool quota Ayush-PG counseling. If the candidate fails to do so within the stipulated period, he/she will be **ineligible as mentioned in FAQ.**No. 56.
- ➤ R-1 joined candidates whose seat has not been upgraded in R-2 can avail of exit with forfeiture three days before the commencement of the 3rd Round so that he/she will be eligible for AACCC/State/UT/ Central pool quota Ayush-PG counseling. If the candidate fails to do so within the stipulated period, he/she will be ineligible, as mentioned in FAQ. No. 56.

Q.No.60. Am I eligible for Central Pool Quota Counseling if I join the R-2 allotted seat of AACCC-PG counseling?

Ans: R-2 joined candidates can participate in the Central Pool Quota Counseling; however, once he/she gets allotted a seat through Central Pool Quota counseling, he/she needs to withdraw the Round-2 joined seat till the date of announcement of R-3 final result (excluding the final result date) with Forfeiture of counseling fees. If the candidate fails to

do so within the stipulated time, he/she shall be ineligible for Central Pool Quota counseling. Further, the AACCC has no role in the Counseling for Central Pool Quota seats

Q.No.61. If I withdraw the R-1/R-2 joined seat on or after the announcement of the R-3 final result, will I be eligible for Ayush-PG counseling?

Ans: No. If the candidates withdraw the R-1/R-2 joined seats on or after the announcement of the R-3 final result with forfeiture of counseling fees, they will be ineligible for AACCC/State/UT/Central pool quota Ayush-PG counseling

ROUND-3 (FAQs)

IMPORTANT

Candidates are advised to take a calculated decision to participate in 3rd round as they would not be permitted to resign from 3rd round allotted seat. They will also not be allowed to participate in any AYUSH-PG Counseling for this year once a seat is allotted in 3rd round.

Q.No.62. I have registered in the 1st and 2nd Round; should I register again for the 3rd Round?

Ans: Only candidates who have not registered in the 1st Round and 2nd Round need to register afresh for the 3rd Round. Further, candidates who avail of exit with forfeiture of counseling fees need to pay complete fees again to participate in the 3rd Round as per the eligibility criteria for R-3.

Q.No.63. Who will be eligible for the 3rd Round of AACCC-PG Counseling?

Ans: The following categories of candidates are eligible for the 3rd Round:

Group I: Candidates who are registering for the first time.

Group II: Registered candidates who have not been allotted seats in Round 1 & 2.

Group III: Round 1 allotted candidate who availed of free exit.

Group IV: Round 1 joined candidates who opted for up-gradation but did not participate in the 2nd Round of counseling (with fresh choice filling).

Group V: Round 1 joined candidates who availed of free exit till the date of announcement of the R-2 final result (**excluding final result date**) and did not participate in the 2nd Round.

Group VI: Round 1 joined candidates but not upgraded during R-2.

Group VII: Round 1 admitted candidates but not upgraded during R-2 and availed of exit with forfeiture of counseling fees 3 days prior to the commencement of R-3 can participate with full payment of counseling fees.

Group VIII: Round 2 allotted/upgraded candidates who avail of exit with forfeiture can participate with full payment of counseling fees.

Group IX: Round 2 joined candidates who submitted willingness for up gradation at the time of reporting to the R-2 allotted institute.

Group X: Round 2 joined candidates who avail of exit with forfeiture of counseling fees 3 days prior to the commencement of R-3 can participate with full payment of counseling fees.

Q.No.64. What is the procedure for the 3rd Round of Counseling?

Ans: Eligible candidates may submit fresh Choices during the 3rd Round choice filling period and will be allotted seats based on merit and choices locked by the candidate/as per server time.

The provisional and virtual seat matrix for vacant seats will be published on the AACCC portal. Candidates will be shown all available choices against actual and virtual vacancies. (Virtual vacancies are likely to be available when the seats get vacated during up-gradation and the seat conversion as per the following algorithm).

The reserved vacant AIQ-ASU& H (Govt. /Govt. Aided /CU/NI) seats published before 3rd Round will be converted during the 3rd Round of counseling as per the following algorithm, only if the reserved seat is not opted by any candidate/non-availability of candidate of that particular category in 3rd Round.

IMPORTANT

During 3rd Round, conversion algorithm will be applied on those reserved category seats which are not opted by any candidate (or may be due to non-availability of candidate of that particular category) and such converted seats are exhibited as virtual vacancies during choice filling for Round-3 on the portal. Candidates cannot claim for such virtual vacancies because such seats will be allotted to them only if the same seats are not opted by the candidate of the reserved category.

Q.No.65. Is the Up-gradation allowed from the $1^{st}/2^{nd}$ Round to the 3^{rd} Round of the AACCC-PG counseling?

Ans: Yes. Up-gradation is allowed from the 1st /2nd Round to the 3rd Round of AACCC counseling for the candidates who submitted willingness for upgradation at the time of reporting to the R-1/R-2 allotted institute. However, the candidates must join the R-3 allotted seat that upgraded from 1st & 2nd Round admitted seats as their earlier joined R-1/R-2 seat stands cancelled. If such candidates do not join the upgraded seats in Round-3, their counseling fees will be forfeited, and they will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota).

Q.No.66. Should I be eligible for State/UT/Central Pool Quota Counseling if I am allotted/upgraded a seat in the 3rd Round of AACCC-PG counseling?

Ans: No. The candidates must join their upgraded/allotted seats in the 3rd Round. If such candidates do not join their upgraded/allotted seats, their counseling fees will be forfeited, and they will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota).

The names of all ineligible candidates will be circulated to all Central/State counseling authorities to prohibit them from participating in any AYUSH-PG counseling (Central/State/UT/ Central Pool Quota).

Q.No.67. What will happen if a candidate does not join the 3rd Round allotted/upgraded seat?

सत्यमव जय

Ans: If a candidate does not join the 3rd Round allotted/upgraded seat as per schedule, the candidate's admission will be cancelled with forfeiture of counseling fees. Further, he/she will become ineligible for any other AYUSH-PG counseling. (Central/State/UT/Central Pool Quota).

Q.No.68. I joined the R-1 allotted seat and submitted my willingness to upgrade the seat; for some reason, I could not participate in the 2nd Round. Will I be eligible to participate in R-3?

OR

I joined the R-1 allotted seat but was not upgraded during R-2. Will I be eligible to participate in R-3?

Ans: Yes. You are eligible to participate in R-3 of AACCC-PG Counseling as per the eligibility criteria fixed for Round 3.

Q.No.69. What will happen to vacant seats after the completion of the 3rd Round?

Ans: All India Quota (AIQ) seats of Govt./Govt. Aided/CU/NI institutions that remain vacant after the completion of the 3rd Round will continue to be allotted during the online Stray Vacancy Round (SVR-I & SVR-II) conducted by the AACCC.

Q. No.70. How does AACCC prohibit ineligible candidates from participating in further Ayush-PG Counseling (AACCC/State/UT/Central pool quota)?

Ans:

• Ineligibility for AACCC-PG Counseling

Candidates who withdrew their seats between the period from 3 days before the commencement of R-3 to the date of announcement of the R-3 final result (excluding the final result date) or did not comply with the AACCC-PG counseling scheme 2025 the date of announcement of the R-3 final result are ineligible to participate in AACCC-PG counseling, which means the AACCC PG portal will block the candidature of the applicant from participating in further rounds of AACCC-PG Counseling.

Ineligibility for AACCC/State/UT/Central pool Quota-PG Counseling

Candidates who secured their AIQ-PG seats through R-1/R-2 till the date of announcement of the R-3 final result or who have been allotted seats in R-3/SVR-I/SVR-II or who did not comply with the AACCC-PG Counseling scheme and withdraw their seats beyond the period mentioned for each round as per the counseling scheme are ineligible to participate in AACCC/State/UT/Central pool Quota-PG Counseling. The list of such candidates will be circulated to all State/UT Counseling authorities/ National Institutes/Central Universities/Deemed Universities to prohibit them from participating in further Ayush-PG Counseling.

Q. No.71. When will the AACCC publish the list of ineligible candidates for further Ayush-PG Counseling (Central/State/UT/Central pool quota)?

Ans: AACCC will publish the list of ineligible candidates at the following level:

- On the date of the announcement of the R-3 final result.
- On the date of the announcement of the SVR-I final result.
- On the date of the announcement of the SVR-II final result.

Further, the AACCC will direct the State/UT counseling authorities to prohibit the ineligible candidates from participating in the Ayush-PG counseling for the A.Y 2025-26.

STRAY VACANCY ROUND (FAOs)

NOTE

The seats remain vacant (not joined/withdrawn) after the 3rd Round of AACCC-PG Counseling of Govt./Govt. Aided colleges/CU/NI will continue to be filled through the online Stray Vacancy Round conducted by the AACCC, NCISM. Further, for seat allotment under Deemed Universities during the Stray Vacancy Round, candidates need to report to the respective Deemed Universities to complete their admission process through the centralized AACCC-UG counseling portal.

Q.No.72. What is the peculiarity of the Stray Vacancy round?

Q.No.73: Is registration available in the Stray vacancy round of AACCC-PG counseling?

Ans: Yes. Fresh registration is **available** in the Stray vacancy round (SVR-I) of AACCC-PG counseling. Candidates who wish to participate in the Stray Vacancy Round (SVR-I & II)- for Govt./ Govt. Aided/CU/NI/Deemed Universities are advised to register during SVR-I as per eligibility criteria fixed for SVR.

Q.No.74. Is choice filling available in the Stray vacancy round of AACCC-PG counseling?

Ans: Yes. The choice filling is available in the Stray vacancy round (SVR-I) of AACCC-PG counseling for allotment of seats under Govt./ Govt. Aided/CU/NI/ Deemed Universities; however, the choice filling is **not available** during SVR-II of AACCC-PG counseling.

Q.No.75. Is there any separate registration option for counseling and admission at Deemed Universities during the Stray Vacancy Round (SVR-DU)?

Ans: There is no separate registration option for counseling and admission at Deemed Universities. There shall be a common Stray Vacancy Round (SVR-I&II) for Govt./Govt. Aided /CU/NI/Deemed University. Non registered candidates till R-3 who wish to participate in SVR can register on the AACCC-PG portal during SVR-I.

Q.No.76 Is there any institutional-level counseling for seat allotment under Deemed Universities during SVR-DU?

Ans: No. there will not be any institutional-level counseling for seat allotment under Deemed Universities during SVR. There shall be an online Stray Vacancy Round (SVR-I&II) for vacant seats under Govt./Govt. Aided /CU/NI/Deemed University after 3rd Round.

Q.No.77. Should I submit any willingness to participate in the SVR for Govt./Govt. Aided./CU/NI/Deemed Universities (SVR-I & II)?

Ans. To participate in the Stray Vacancy Round (SVR-I & II), candidates must submit willingness cum undertaking on the AACCC-PG portal that they are not holding any PG (ASU&H) seats allotted through any rounds of AACCC-PG counseling/State-UTs Counseling.

Q.No.78. Is any Up-gradation allowed from the 1st/2nd/3rd Round to the Stray Vacancy Round of the AACCC-PG counseling?

Ans: No. Up-gradation is not allowed from the 1st/2nd/3rd Round to the Stray Vacancy Round of the AACCC-PG counseling.

Q.No.79. Is any Up-gradation allowed from SVR-I to SVR-II (Govt./Govt Aided/CU-NI/ Deemed Universities) of the AACCC-PG counseling?

Ans: No. Up-gradation is not allowed from SVR-I to SVR-II of the AACCC-PG counseling.

Q.No.80. Who is Eligible for the Stray Vacancy Round (SVR-I & II) for Govt./Govt. Aided/ CU/NI/ Deemed Universities?

Ans. Group I: Candidates who are registering for the first time. (Need to register afresh on the portal during SVR-I)

Group II: Registered candidates who do not hold any seats through previous rounds of AACCC-PG Counseling or State/UTs counseling.

Group III: Round 1 non-joined candidate availed of Free Exit.

Group IV: Round 1 allotted candidate availed of free exit but did not participate in R-2/R-3 of AACCC-PG Counseling.

Group V: Round 1 joined Candidates who availed of Free Exit till the date of announcement of the R-2 final result (**excluding the final result date**).

Group VI: Round 1 joined candidates not upgraded during R-2 who availed of exit with forfeiture 3 days prior to the commencement of R-3 and not registered in R-3 can register afresh with full payment of counseling fees to participate in SVR.

Group VII: Round 2 non-joined candidates who availed of exit with forfeiture and not registered in R-3 can register afresh with full payment of counseling fees to participate in SVR.

Group VIII: Round 2 joined candidates who availed of exit with forfeiture 3 days prior to the commencement of R-3 and not registered in R-3 can register afresh with full payment of counseling fees to participate in SVR.

IMPORTANT

There will be data sharing between State and Centre and if any candidate has its name in the list of admitted candidates (State/Central lists), then such candidates shall be ineligible for AACCC- Stray Vacancy Round.

Q.No.81. Who is ineligible for the Stray Vacancy Round (SVR-I & II) for Govt./ Govt. Aided/ CU/NI/ Deemed Universities?

Ans:

Group I: Candidates who have been admitted through any previous rounds of AACCC-PG Counseling and State/UT counseling

Group II: R-1/R-2 admitted candidates who secured their AIQ-PG seats till the date of announcement of the R-3 final result.

Group III: Candidates who withdraw their seats from 3 days before the commencement of R-3.

Group IV: Candidates who have been allotted seats in R-3

Group V: Candidates who did not comply with the AACCC-PG Counseling scheme 2025.

Further, candidates who have been allotted seats in SVR-I will not be considered for seat allotment during SVR-II.

IMPORTANT

Further, candidates who have been allotted seats in SVR-I will not be considered for seat allotment during SVR-II.

Q.No.82. Will I be eligible for State/UT/Central Pool Quota Counseling if I am allotted a seat in the Stray Vacancy Round (SVR-I & II) of the AACCC-PG counseling?

Ans: No, if a candidate has been allotted a seat in the Stray Vacancy Round (SVR-I & II), he/she will not be eligible for further AYUSH-PG Counseling.

Further, the candidates must join their allotted seats in the Stray Vacancy Round (SVR-I & II). If such candidates do not join the allotted seats, their counseling fees will be forfeited, and they will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota) for that particular year.

Q.No.83. What will happen if I do not join the seat allotted through the Stray Vacancy Round (SVR-I/SVR-II) of the AACCC-PG counseling?

Ans: Candidate must join the seat allotted through the Stray Vacancy Round (**SVR-I/SVR-II**), otherwise, the admission will be cancelled and become ineligible for other AYUSH counseling (Central/State/UT/ Central Pool Quota) with forfeiture of counseling fees.

Q.No.84. What will happen if I withdraw the joined seat of SVR?

Ans: If a candidate withdraws the joined seat of SVR,

- i) Counseling fees will be forfeited
- ii) Ineligible for further Ayush-PG Counseling
- **iii)** Refund of admission fees/bond amount, etc., remitted during admission is in accordance with the rules/norms of the respective College/University. AACCC has no role to play in this regard.

Q.No.85. Should the Security money be refunded if a candidate is not allotted a seat through any round of AACCC-PG counseling?

Ans: Yes. If the candidate is not allotted any seat during AACCC-PG counseling, the security money will be refunded to the bank account/credit card provided by the candidate at the time of registration on the portal.

Note:- Candidate eligible for refund of security money are strictly advised to keep their bank account/credit card active/ functional till they received the refund.

Q.No.86: What will be the eligibility criteria for admission to 50% Institutional Quota seats of Banaras Hindu University (BHU) as the AACCC conduct the counseling for the same?

Ans: The eligibility conditions for admission to 50% Institutional Quota seats of the Banaras Hindu University (BHU) will be as per the eligibility criteria given by the respective University at the time of counseling. As informed by the University, the Institutional quota is allocated for only those students who have passed the BAMS fourth professional examination held in 2023 & 2024 in the Faculty of Ayurveda, IMS, BHU, and completed the internship in 2025 (i.e., by 31st July, 2025) provided the candidate has appeared and qualified in the AIAPGET-2025 examination. For additional information, please contact the concerned University

Q.No.87. Whether there will be separate counseling for AIQ seats and 50% Institutional Quota seats of BHU, on separate days and on separate platform?

Ans: No, there is a common counseling software for AIQ of Govt./Govt. aided/ Central University/ National Institutes/Deemed Universities as well as for 50% Institutional Quota seats of Banaras Hindu University (BHU). Hence, those candidates, who are eligible for 50% Institutional Quota seats of Banaras Hindu University (BHU), should opt the choices in order of preference between AIQ and 50% Institutional Quota seats of Banaras Hindu University (BHU). The computer software will allot the seat in order of choice and merit of the candidate. It is important to note that preference should be given to the Internal/Institutional candidates as per the eligibility criteria provided by the respective University for the current academic year.



CHAPTER-7 REGISTRATION FEE & SECURITY MONEY

FEES RELATED FAQ's

Q.No.1. Who is the Financial Custodian?

Ans: The National Commission for Indian System of Medicine (NCISM), a statutory body under the Ministry of Ayush, is the Financial Custodian for AACCC-PG counseling-2025. The National Commission for Indian System of Medicine (NCISM) will collect non-refundable Registration Fees and refundable security money from the candidates. After completion of the AACCC-PG counseling, the National Commission for Indian System of Medicine (NCISM) will refund the security money to the candidates.

Q. No. 2: What are the various fees to be paid at the time of registration?

Ans: At the time of registration, students must pay two kinds of fee

- 1. Any candidate opting for Deemed University will have to pay an amount of Rs.55,000/- at the time of registration (i.e., Rs.5000/- Non-Refundable Registration fee + Rs.50,000/- Refundable Security money)
- 2. Any UR/EWS/OBC-NCL candidate opting for AIQ- Govt./Govt. Aided/CU/NI seat only will have to pay an amount of Rs.22,000/- at the time of registration (i.e., **Rs. 2,000**/- Non-Refundable Registration fee + Rs.20,000/- Refundable Security money)

3. Any SC/ ST/ PwBD candidate opting for AIQ- Govt./Govt. Aided/CU/NI Seat only will have to pay an amount of Rs.21,000/- at the time of registration (i.e., Rs.1000/- Non-Refundable Registration fee + Rs.20,000/- Refundable Security money)

Q. No. 3: If a candidate wishes to apply for both AIQ-Govt/AIQ-Govt.Aided/CU-NI and Deemed University, how much fee should he pay?

Ans: In such case, the candidate has to pay only the higher fee i.e. of Deemed University Rs. 5,000/- (Registration fee) plus Rs. 50,000/- (security money).

Q.No. 4: If I selected AIQ-Govt as the counseling type and paid counseling fees during registration, and later decided to participate in Deemed University counseling, what procedure should I follow?

Ans: In such cases, the candidate should do the following procedure:

Condition I (Candidate wants to change counseling type during the same round): By availing registration unlocking facility, the candidate can modify their counseling type and pay counseling fees again as per Deemed University counseling type on the portal. This facility is available for those candidates who have not locked their choices as per schedule.

Condition II (Candidate wants to change counseling type during the subsequent rounds): By availing registration unlocking facility, the candidate can modify their counseling type and pay counseling fees again as per Deemed University counseling type on the portal. This facility is available for those candidates who have not locked their choices as per schedule.

REFUND RELATED FAQ's

Q.No.1. When will the Refundable security money be refunded if I am eligible as per the Refund Policy?

Ans. Refunds will be initiated only after all AACCC-PG Counseling rounds are completed.

Q.No.2. Where will the security money be refunded?

Ans:

- a) The security money will be refunded to the bank account/credit card from which the payment of counseling fees has been made.
- b) The candidates are advised to keep their **bank account/credit card active** till the refund process is completed.

Q.No. 3 In which bank account the security money will be refunded, (if at all candidate is eligible for refund)?

Ans: The security money will be refunded to the bank account/credit card from which payment of counseling fees has been made (through Net banking/Credit card/Debit card/UPI) while registering at AACCC-PG portal. It is strongly advised to keep that particular bank account/credit card

ACTIVE (and keep checking the refund status) till the whole process of refund is completed by Financial custodian for A.Y. 2025-26. For example:

Eg.1: If the security amount was deposited through Card#1234XXXXXXXX6789, then the refund will go to Card #1234XXXXXXXX679 only.

Eg.2: If the security amount was deposited from account # 123456789012 of State Bank of India IFSC Code SBIN0001234 then the refund will go to account#123456789012 of State Bank of India IFSC Code SBIN0001234 only.

Hence, the candidate must keep their card/bank account ACTIVE till refund process is completed. If card/bank account is closed before the completion of refund, the bankers will not be able to complete the refund process. The bankers will take long time to identify & return the failed refunds to Financial Custodian and lot of legal formalities are to be complied for initiating refund to different bank account. Hence the refund to new bank account will take very long time. Neither Financial Custodian nor AACCC will be responsible for such delay.

Q.No.4. What happens if the candidate, by mistake, makes more than one payment for the same Roll #?

Ans: The Financial custodian will refund the excess payment, if any, as per the refund policy..

Q.No.5. Is the Security money refundable in all the cases?

Ans: No. Security Money along with registration fee shall be forfeited in the following conditions:

- a) R-2 non-joined/joined candidates who avail exit with forfeiture.
- b) Candidate does not join the allotted seat in the 3rd Round/ Stray Vacancy Round (SVR-I & SVR-II)
- c) Candidate does not join the upgraded seat from Round-1, and Round-2 admitted seats.
- **d**) If the candidate gives wrong information at the time of registration based on which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.
- e) Not upgraded candidate of Round-1 resigns from his joined seat after the announcement of the R-2 final result
- f) Candidate resigns his/her joined seat through offline mode after the completion of counseling.
- g) Non-compliance with the AACCC-PG counseling scheme 2025.
- h) Candidates withdraw their admitted seats allotted through R-2/R-3/SVR-I&II.

Q.No.6: What are the norms for forfeiture of counseling fee during AACCC-PG counseling?

Ans. Following forfeiture norms are in the AACCC-PG counseling: If the candidate does not comply with the AACCC-PG counseling scheme 2025, the full counseling fee will be forfeited irrespective of the category of seat (e.g. AIQ-Govt or Deemed University) allotted/ irrespective of the type of counseling selected on the portal in multiple attempts by using registration unlocking facility. The following examples are placed for reference:

a) if a general category candidate selected 'Govt/Govt. Aided' as counseling type on the portal during registration for the first round and paid 22000/Rs; further, during the second round, he selected 'Deemed University' as counseling type by availing registration unlocking and paid **55000/Rs**, and later he not complied with the counseling scheme, in that case his full counseling fee will be forfeited (i.e., 77000/Rs).

- **b)** If the GEN/EWS/OBC candidate or SC/ST/PwD candidate selected 'Govt/Govt. Aided/CU/NI' as counseling type on the portal and paid 22000/Rs and 21000/Rs, respectively; further, he has not complied with the AACCC-Counseling Scheme; in that case, his counseling fee (22000/Rs) for GEN/EWS/OBC candidate and 21000/Rs for SC/ST candidate will be forfeited.
- c) If a GEN/EWS/OBC candidate or SC/ST/PwD candidate selected 'Deemed University' as counseling type on the portal and paid 55000/Rs (same fees for both categories); further, he has not complied with the AACCC-Counseling Scheme; in that case, his counseling fee (55000/Rs) will be forfeited.

Q.No.7. Do I have to request the Financial Custodian to refund the security money? What is the schedule for the refund of the security money?

Ans:

- a) Candidate need not approach the Financial Custodian for refund of the security money.
- **b**) Once the Financial Custodian completes the refund, AACCC will publish the refund details along with the refund date & transaction # on the AACCC website (https://aaccc.gov.in). The refund will be credited, depending upon the level of digitalization of the candidate's bank, to the candidate's account between 02 to 15 days from the date of refund by the Financial Custodian.

Q.No.8. Can I initiate refund proceedings through chargeback claim through the card issuing bank?

Ans: No Candidates who have been allotted seats should not initiate refund proceedings through chargeback claim through the card issuing bank. If the chargeback claim is initiated, the Financial Custodian will not be in a position to initiate the direct refund, and thereby, the refund of the security amount will be delayed.

O.No.9. How do I contact the Financial Custodian?

Ans: The candidate can contact the Financial Custodian (finance-aaccc@aiia.gov.in) through a registered mail Id.

- a) The financial custodian will entertain only payment and refund-related queries through finance-aaccc@aiia.gov.in
- **b)** For other than financial-related queries, the candidates may contact AACCC through mail counseling-aaccc@aiia.gov.in

Note: Direct queries to AACCC, regarding payment/refund will not be entertained.

Q.No.10. Will AACCC bear the bank charges the candidate incurred while registering for counseling?

Ans: No. Bank Charges, if any, incurred by the candidates should be borne by themselves.

Q.No.11. Will the AACCC pay interest in the refundable security money?

Ans: No, AACCC will not pay interest on the refundable security money.

Q.No.12. Can the candidate remit the Registration Fee and Security money from the NRI Account?

Ans: No, As per Reserve Bank of India (RBI) Rules, AACCC cannot refund the security money to NRI Account. If the candidate wants to use the funds available in his/ her NRI Account for registering for counseling, he/she has to first transfer funds from NRI Account to NRO Account and from the NRO account to AACCC' Financial Custodian account. Further, the refund from AACCC will be credited to NRO Account only.


Q.No.13. If the candidate does not get payment confirmation from the payment gateway provider, whom should he/she contact for payment confirmation?

Ans: The candidate can approach the Financial Custodian (finance-aaccc@aiia.gov.in).

Q. NO.14: If the security deposit is remitted through unrelated card/bank account can the candidate request for refund to different card/bank account?

Ans: NO. AACCC will not entertain such requests. The security deposit will be refunded only to the account from where the security deposit was initially deposited. The candidates are advised to not use unrelated (eg. Agent/third party/cyber café owner) card/bank accounts for remitting security deposit.
