

## Salient features of Stray Vacancy Round for AIQ seats under Govt./Govt. Aided/CU/NI/Deemed Universities and B.Pharm (Ay)-ITRA, Jamnagar

First allotment phase (SVR-I)- for AIQ seats of Govt./Govt. Aided/CU/NI, Deemed Universities, B.Pharm (Ay) ITRA

- Registration & Choice filling available
- No upgradation available from previous rounds

The vacant/ not reported/withdrawn seats available after the reporting period of SVR-I will be considered during the second allotment for those candidates who have not been allotted any seats through SVR-I. The second allotment will be purely based on the choices locked by the candidates/locked as per server time during the choice-filling period of the First allotment phase- SVR I.

Eligibility Criteria For candidates participating in the Stray Vacancy Round (SVR-I&II) for AIQ seats under Govt./Govt. Aided / Central Universities/National Institutes/Deemed Universities, B.Pharm(Ay) and ITRA			
	Only NEET (UG)- 2025 qualified candidates who have registered in the 1 <sup>st</sup> /2 <sup>nd</sup> / 3 <sup>rd</sup> Round of AACCC-UG counseling are eligible to participate, provided that,-		
1.	i. Candidates who have not been admitted to any of the seats through 1st and 2nd rounds AACCC-UG counseling or counseling conducted by State/UTs		
	ii. Candidates who have not been allotted any seats through 3 <sup>rd</sup> round AACCC-UG counseling		
2.	Candidates who have not registered in the AACCC-UG counseling and have not been admitted to any of the seats through State/UTs counseling are eligible to participate after registering on the AACCC-UG Portal during SVR-I.		
3.	Round-1 non-joined/joined candidate who availed of Free Exit.		
5.	Round-1 admitted candidates who did not get an upgrade during R-2/not participated in R-2 and availed of exit with forfeiture till <b>06.10.2025</b> can participate with full payment of counselling fees.		
6.	Round-2 non-joined candidates who availed of exit with forfeiture of counselling fees can participate with full payment of counselling fees.		
7.	Round 2 admitted/upgraded candidates who availed of exit with forfeiture of counseling fees till <b>06.10.2025</b> can participate with full payment of counseling fees.
