If not upgraded	R-1/R-2 admitted candidates if not upgraded during R-3	Candidate will be treated as R-3 admitted candidate from the date of announcement of R-3 final result, and <i>Rules of R-3 joined candidates</i> will apply to them.
	Candidates whose seats have not been upgraded from R-1/R-2 to R-3	Continue their study at the joined R-1/R2 institute. If the candidates withdraw the R-1/R-2 seats from the announcement of the R-3 final result, they become ineligible for any Ayush- PG Counseling (Central/State/UT) with forfeiture of counseling fees.
If not allotted	Wish to participate in the next rounds of AACCC-PG counseling	Candidates can participate in the Stray Vacancy Round by filling fresh choices.
