ORDER

Subject: Empanelment of DPR & Design Consulting Agencies for Quality Assurance in Haryana in Engineering works implemented by the State Government

Consequent upon the formation of the Quality Assurance Authority (QAA), Haryana, vide Government Notification No. 18/07/2022-3FICW/24265 dated April 4, 2023, QAA, in consultation with the executing departments of the Government of Haryana, hereby empanels the agencies/consultants for DPR & Design Consultants/Agencies (the list of category wise empanelled agencies is attached at Annexure A).

2. Other terms and conditions of the empanelment are as under:

- i) The performance of the agencies now being empanelled by QAA shall be reviewed on an Annual basis. In case the performance of any agency is found unsatisfactory, it shall be removed from the panel of the consultants.
- ii) The executing departments are further instructed to provide regular feedback on the performance of the empanelled agencies to the QAA for ongoing review and assessment. The reports submitted by the agencies, along with their performance evaluation shall also be uploaded to the Haryana Engineering Works Portal by the concerned Department.
- ii) The empaneled agencies have been technically qualified by the QAA. Financial bidding shall be undertaken separately by the respective Departments at the time of assigning individual projects as per their requirements based on the actual scope and nature of work.
- iii) A separate RFP may be floated for externally aided projects being undertaken by the State Government Department either independently or with collaboration of National or International Organizations.

Any additional terms and conditions as well as the tentative scope of work shall be governed by the RFP document, attached at Annexure B.

3. In order to ensure the healthy competition and also for continuity, to begin with, the list of these empaneled agencies would be in addition to the agencies already empaneled with QAA. The term of the empaneled agencies would be up to 31.3.2028.

The above order be brought to the notice of all the concerned, for strict compliance.
