


No. SDTE-HTE-HTE-I-0003-2017 5788 /SDTE, In continuance to this Department Order No. 5396 dated 31.10.2022, in exercise of power conferred under Section-3 (2) of the Odisha Professional Educational Institutions (Regulation of Admission and Fixation of Fee) Amendment Act, 2016, Government have been pleased to extend the last date for admission to Engineering Courses in the State of Odisha till 30.11.2022 from 20.11.2022 as per the order of the Hon'ble Supreme Court dated 17.10.2022 on Miscellaneous Application No. 1776 /2022 in C.A. No. 9048/2012. This order supersedes the clause 4 of this Department Order No. 5396 dated 31.10.2022 in respect of last date of admission in modalities issued for filling up of the remaining vacant seats in private technical institutions arising after final round of OJEE counseling for the academic year 2022-23, however, other clauses of the aforesaid order remain same.
