**Kind Attention: All candidates/institutes participating in PG-Counseling, 2024 are informed to submit following mandatory documents at the time of reporting at the allotted institute.**

i. **BHMS Certificate/Degree Certificate/Provisional Degree Certificate.**

If a candidate is not able to produce a valid Provisional Degree Certificate at the time of admission reporting for Round-1 and Round-2 of PG counseling, in that case, the candidate shall submit an undertaking stating that **he/she will submit the valid Provisional Degree Certificate at the allotted institute on or before the commencement date of PG course i.e. ( 11th November, 2024) for the academic session 2024-25** as already informed by NCH.

ii. **Permanent Registration Certificate** issued by NCH/CCH/State Homoeopathy Board:

If a candidate is not able to produce a valid **Permanent Registration Certificate** at the time of admission/ reporting for Round-1 and Round-2 of PG counseling, are instructed to submit a copy of the **Provisional Registration Certificate** at the time of reporting. Further, such candidates shall submit their original Permanent Registration Certificate **at the allotted institute on or before the commencement date of PG course i.e ( 11th November, 2024) for the academic session 2024-25** as already informed by NCH.
