# INFORMATION & INSTRUCTIONS FOR COUNSELLING & ADMISSION TO M.D./M.S.(Av.) IN

Odisha Joint Entrance Examination (OJEE) Committee, as the State Counselling Authority, will conduct counselling for admission to State Quota Seats of M.D./M.S.(Ayu.) courses in three Govt. Ayurvedic colleges of the state i.e. Gopabandhu Ayurveda Mahavidyala, Puri; Govt. Ayurvedic College, Bolangir and Kaviraj Ananta Tripathy Sharma Ayurvedic College & Hospital, Ankushpur, Ganjam. In addition, as per the new guidelines of the Ministry of Ayush, Govt. of India, "AACCC-PG counselling" conduct counselling for admission against All India Quota (AIQ) seats in M.D./M.S.(Ayu.) courses for aforesaid colleges of the state.

OJEE will also follow the Directives as issued by National Commission for Indian System of Medicine & National Commission for Homeopathy, New Delhi.

#### A. ELIGIBILITY CRITERIA

- 1. Candidates interested to participate in the M.D./M.S.(Ay.) counselling must have qualified in the AIAPGET 2025 with a valid rank.
  - (In order to be eligible for admission to M.D./M.S.(Ay.) courses for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50<sup>th</sup> percentile in the 'AIAPGET 2025 for the M.D./M.S.(Ay.) courses' held for the said academic year:

Provided that in respect of-

- (a) Candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at the 40<sup>th</sup> percentile;
- (b) Candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45<sup>th</sup> percentile in the case of the General category and 40<sup>th</sup> percentile in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.) The PC/PwD should be as per the guidelines issued by NCISM (available on Counselling website (www.aaccc.gov.in).

Odisha. Every candidate must produce Resident / Nativity certificate (Form No.-III, See Rule-3 of Govt. of Odisha) during certificate verification.

In respect of persons with disability as specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum qualifying marks in the said qualifying examination as follows: a) shall be 45<sup>th</sup> percentile in case of the general category. b) 40<sup>th</sup> percentile in the case of Scheduled Castes, Scheduled Tribes and Other Backward Classes.

For State Quota seats, the parents of the candidate must be permanent natives of

- 3. Candidates must possess BAMS (Bachelor of Ayurvedic Medicine and Surgery) of not less than four and half years duration/ Degree or Provisional Degree certificate recognized as per the provision of CCIM 1973 / NCISM Act 2020 and possesses permanent / provisional registration certificate issued by the CCIM / NCISM / State Board and must have completed a satisfactorily one-year compulsory rotating internship training by 31st July 2025 as per the NCISM notification for the academic year 2025-26 only.
- Counselling will be conducted by the OJEE based on the applicable rules, regulations, reservation policy and other criteria specified by the Govt. of Odisha / NCISM.

## B. <u>STEP- BY-STEP PROCEDURE OF COUNSELLING</u>

2.

- Step 1: All the candidates, who are interested to take part in the M.D./M.S.(Ay.) Counselling-cum-Admission process and who satisfies the above-mentioned eligibility criteria, must register online in the website of OJEE i.e.www.ojee.nic.in by creating their own Username and Password by paying registration fees of Rs.1000/- (Non-Refundable) through online mode at user's login portal.

  Only registered candidates will be considered for allotment / admission. There is a provision of choice filling and choice locking for the student in each round of counseling.
- Step 2: The candidates, who get provisional allotment in this round, have to deposit, as admission fee, an amount of Rs. 24,730/- (excluding hostel fees and Including OUHS Registration fees @Rs.3,500/-) online in the candidate's login portal or by DD drawn in favor of OJEE and payable at Bhubaneswar during document verification and reporting at their allotted college respectively. Candidates have to pay the differential amount if any during admission at their allotted college.

Step – 3: The candidates, who get provisional allotment, have to report at the allotted colleges as per the schedule date and time for document verification and provisional admission. List of Documents required to be verified during document verification is mentioned below. In case the candidate does not report to their allotted college for verification of documents and provisional admission, the allotted seat will be cancelled and the candidate may participate in subsequent round provided vacancy exists.

## **C. LIST OF DOCUMENTS**

Candidates must bring the following original certificates / documents during reporting at Gopabandhu Ayurveda Mahavidyala, Puri/ Govt. Ayurvedic College, Balangir / K.A.T.S. Ayurvedic College & Hospital, Ankushpur, Ganjam for document verification and provisional admission. Along with original set, one set photocopy must be produced during document verification.

- i) Admit Card of the AIAPGET 2025.
- ii) Rank card of the AIAPGET 2025.
- iii) Provisional Allotment letter of OJEE.
- iv) Medical Fitness Certificate.
- v) Board of Secondary Education Certificate or equivalent certificate.
- vi) Pass Certificate and Mark sheet of +2 Science or equivalent examination certificates.
- vii) B.A.M.S. certificate.
- viii) Mark sheet of Final B.A.M.S.
- ix) College / School leaving certificate
- x) Internship Training completion Certificate.
- xi) Nativity/Resident certificate of Odisha (Form–III, See Rule-3 of Govt. of Odisha.
- xii) SC/ST Certificate by birth issued by competent authority, Government of Odisha (See Rule-8(I)) (if applicable).
- xiii) License for practice of Ayurvedic Medicine issued by **Odisha State Council of Ayurvedic Medicine** or by Central Council of Ayurveda along with updated renewal.
- xiv) "No Objection Certificate from the employer in case of in-service candidates.
- xv) EWS Certificate issued by competent authority (if applicable) for 2025-26 financial year will only be accepted.

<u>N.B.</u> For availing admission under any types of quota, one should possess Nativity/ Resident Certificate of Odisha and relevant Quota Certificate. Inability to produce the relevant documents during the period of document verification will lead to cancellation of the allotted seat under that claimed quota.

## D. RESERVATIONS

#### 1. State Quota Seats

The reservation policy of the Government of Odisha will be followed for selection. The reservations for different categories shall be as follows:

Scheduled Tribe (ST) 12%, Scheduled Caste (SC) 8%, Physically Challenged (PC) 5%, and Economically Weaker Section (EWS) (10 %), wherever applicable.

#### Note:

- The ST/SC candidates must produce caste certificates from Odisha State only to get the privilege of reservation in the category in Odisha. (Vide Gol letter No. BC/16014/1/82 /SC & BCD/ Dated 22.02.1985) and they must be permanent natives of Odisha.
- ii. Candidates who wish to claim seats under Economically Weaker Sections (EWS) category have to mention the same during registration and have to produce valid EWS Certificates as per relevant Government notification.
- iii. If sufficient number of candidates are not available in any Reserved category, the vacant seats of the category will merge with that in the Un-reserved category. This will be done following proper procedure as per the Government guidelines.
- iv. The benefit of additional weightage of marks to the extent of 05% in the qualifying examination to in service Candidates only, who have rendered minimum 03 years of service in the Tribal / backward area as notified by Govt. order No.22839/H, dt.01.07.1998 of Health & FW Department, Govt. of Odisha. Candidates must obtain No Objection Certificate from competent authority and deposit during counseling/ admission. No seat is reserved for in service candidates.

#### **E. PROCEDURE FOR ONLINE ALLOTMENT**

#### **ALLOTMENT**

- 1. In this round, all registered candidates are provisionally allotted seats basing on their merit (AIAPGET-2025 Rank). Reservations shall be considered as per candidate's declaration during registration.
- 2. After provisional allotment, these candidates have to deposit an amount of Rs.24,730/- (Rupees Twenty four thousand seven hundred thirty only) (Excluding hostel fees & Including OUHS Registration fees @Rs.3,500/- (Rupees three thousand five hundred only) online in the candidate's login portal as admission fee and report at Gopabandhu Ayurveda Mahavidyala, Puri / Govt. Ayurvedic College, Balangir / K.A.T.S. Ayurvedic College & Hospital, Ankushpur, Ganjam for document verification and provisional admission. Detail document required are listed in Section C: List of Documents.
- 3. Candidates, who have paid the admission fees, and successfully get their documents verified, are considered for provisional admission as per their allotted category.
- 4. Candidates, who do not complete the steps as defined in (2) above, are disqualified and will not be considered for admission process.
- 5. Candidates who fail to produce relevant documents for their category they have claimed, will be disqualified of their temporary allotment and will be considered as general candidate in the subsequent round of allotment and the candidate have to fill choice fresh in 2<sup>nd</sup> round provided as vacancy exists.

#### WITHDRAWAL

Any candidate, who, for any reason, wants to withdraw from the process or wants to resign from the allotted seat, can do so within the stipulated date for 'withdrawal' as notified in the schedule.

#### **SPOT ADMISSION**

If any vacancy arises after reporting of candidates at their allotted college, Spot Counseling will be conducted. Procedure and schedule for spot counseling will be notified later.
