- 5) On confirmation of payment and order, animals should be procured on the given date and time. Order confirmed will not be cancelled neither refunds will be made.
- 6) Healthy animals will be supplied. Animals should be transported as per CCSEA norms and the due certificate will be issued at the time of delivery.
