NOTIFICATION

Maharashtra Bovine Breeding (Regulation) Act, 2023.

- No. LVS 2024/CR No. 51/PADUM-4.— In exercise of the powers conferred by sub-section (1) of the section 34 read with clause (a) of sub-section (2) of section 4, clause (a) of sub-section (2) of section 5, section 6, sub-section (2) of section 9, sub-section (1) of section 21, sub-section (1) of section 25, sub-section (1) of section 26 and section 29 of the Maharashtra Bovine Breeding (Regulation) Act, 2023 (Mah. V of 2024) and of all other powers enabling it in that behalf, the Government of Maharashtra hereby makes the following rules, the same having been previously published as required by sub-section (1) of section 34 of the said Act, namely:
- **1.** Short title.— These rules may be called the Maharashtra Bovine Breeding (Regulation) Rules, 2024.
 - **2.** *Definitions.* (1) In these rules, unless the context otherwise requires,—
 - (a) "Act" means the Maharashtra Bovine Breeding (Regulation) Act, 2023(Mah. V of 2024);
 - (b) "District Deputy Commissioner of Animal Husbandry" means for Mumbai and Mumbai Sub-urban District, Deputy Commissioner, Quality Control Laboratory, Mumbai and in all other cases the officer in charge of the office of District Deputy Commissioner of Animal Husbandry and Dairying;
 - (c) "Fees" means registration fee for registration under section 4 and section 5, and renewal of registration under section 7 and for issue of duplicate registration certificate under section 9 of the Act;
 - (*d*) "Form" means the Form appended to these rules.
- (2) Words and expressions used but not defined in these rules shall have the same meanings assigned to them in the Maharashtra Bovine Breeding (Regulation) Act, 2023.
- **3.** Qualification, experience and training required for registration as assisted reproductive technology (ART) expert.— A person shall be eligible for registration as assisted reproductive technology (ART) expert if he possesses the following qualifications, namely:—
 - (i) Master's degree in Animal Reproduction or Animal Reproduction and Gynecology or Animal Reproduction, Gynecology and Obstetrics or Veterinary Biotechnology;
 - (ii) having at least two years' experience in the field of assisted reproductive technology; and
 - (iii) has successfully completed training of assisted reproductive technique conducted by the Government of India or Universities imparting Veterinary Science education.
- **4.** Qualification, experience and training required for registration as artificial insemination (AI) technician.— A person shall be eligible for registration as artificial insemination (AI) technician if he possess the following qualifications, namely:—
 - $(i)\;$ Bachelor's Degree in Veterinary Science from the University recognized by the Veterinary Council of India; or
 - (ii) undergone training of MAITRI (Multipurpose Artificial Insemination Technician in Rural India) of the Government of India; or

- (iii) who has passed 10th standard examination (Secondary School Certificate) or has passed the examination equivalent thereto and successfully completed training of artificial insemination technique from the registered artificial insemination training institute in the State of Maharashtra and having at least one year experience in the field of Animal Husbandry; or
 - (iv) Pashusakhi who has undergone a training of artificial insemination;

Explanation.— *Pashusakhi* means a community animal healthcare worker selected by the Maharashtra State Rural Livelihood Mission (MSRLM) of the State of Maharashtra, who provides services to livestock farmers.

5. Registration or Renewal.—

- (1) Registration of semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute (AITI), assisted reproductive technology (ART) service provider, assisted reproductive technology (ART) expert shall be made as follows, namely:—
 - (a) An application for registration of semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute (AITI), assisted reproductive technology (ART) service provider or assisted reproductive technology (ART) expert, shall be made to the Authority in duplicate, in Form A.
 - (b) Every application for registration or renewal of registration shall be made along with requisite fees, as follows:—

- (c) On receipt of an application for registration, the Authority shall verify the particulars of the application.
- (d) The Authority shall, after verifying particulars of the application and after satisfying itself that the applicant is eligible for registration then the Authority may grant a certificate of registration to assisted reproductive technology expert in Form B or may after recording the reasons thereof, reject the application.
- (e) The Authority or Officers authorized in this behalf shall after giving notice make an enquiry including inspection at the premises of the semen station, embryo transfer or invitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider.
- (f) The Authority after verifying particulars given in the application and after inspection and after satisfying itself that the applicant is eligible for its registration then the Authority may grant a certificate of registration, to semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute or assisted reproductive technology service provider in Form C, in duplicate, or may after recording the reasons thereof, reject the application.
- (g) The Authority shall maintain a permanent record of applications for grant or renewal of certificate of registration in Form I.

- (2) Registration of semen bank, artificial insemination (AI) service provider and artificial insemination (AI) technician shall be made as follows, namely:—
 - (a) An application for registration of semen bank, artificial insemination (AI) service provider and artificial insemination (AI) technician shall be made to the District Deputy Commissioner of Animal Husbandry, in duplicate, in Form D;
 - (b) Every application for registration or renewal of registration shall be made along with requisite fees, as follows:—

- (c) On receipt of an application for registration, the District Deputy Commissioner of Animal Husbandry shall verify the particulars of the application.
- (d) The District Deputy Commissioner of Animal Husbandry after verifying particulars of the application and after satisfying himself that the applicant is eligible for registration then the may grant a certificate of registration to artificial insemination technician in Form E or may after recording the reasons thereof, reject the application.
- (e) The District Deputy Commissioner of Animal Husbandry or Officers authorized in this behalf shall after giving notice make an enquiry including inspection at the premises of the semen bank, artificial insemination service provider.
- (f) The District Deputy Commissioner of Animal Husbandry after verifying particulars given in the application and after inspection and after satisfying itself that the applicant is eligible for its registration then grant a certificate of registration to semen bank, artificial insemination service provider in Form F, in duplicate, or may after recording the reasons thereof, reject the application.
- (g) The District Deputy Commissioner of Animal Husbandry shall maintain a permanent record of applications for grant or renewal of certificate of registration in Form I.
- **6.** Terms and conditions for registration.—
- (1) A separate application for registration shall be made for more than one bovine breeding activity.
 - (2) Application fee once paid shall not be refunded.
- (3) One copy of the certificate of registration shall be displayed by the registered semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, semen bank, artificial insemination service provider at a conspicuous place at its place of business.
- (4) The certificate of registration for assisted reproductive technology expert and artificial insemination technician shall be non-transferable.
- (5) No change of ownership or change of management of semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, semen bank, artificial insemination service provider shall be done without the prior permission of Authority or District Deputy Commissioner of Animal Husbandry, as the case may be.
- (6) In the event of change of ownership or change of management or on ceasing to function as semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, semen bank, artificial insemination

service provider, both copies of the certificate of registration shall be surrendered to the Authority or District Deputy Commissioner of Animal Husbandry, as the case may be.

- (7) On receipt of the renewed certificate of registration in duplicate or on receipt of communication of rejection of application for renewal, both copies of the earlier certificate of registration shall be surrendered immediately to the Authority or District Deputy Commissioner of Animal Husbandry, as the case may be, by the applicant.
- (8) Grant of certificate of registration or rejection of application for registration of assisted reproductive technology expert and artificial insemination technician shall be communicated to the applicant within a period of thirty days from the date of receipt of application for registration.
- (9) Grant of certificate of registration or rejection of application for registration of semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, semen bank, artificial insemination service provider shall be communicated to the applicant within a period of ninety days from the date of receipt of application for registration.
- **7.** Certification of Bull.— (1) An application for certification of Bull shall be made to the Authority, in duplicate, in Form G.
- (2) The Authority may after verifying particulars of the application and after satisfying itself that the Bull may be certified, then the Authority may certify the Bull or may after recording the reasons thereof, reject the application for certification of Bull.
 - (3) The Authority shall certify the Bull, in Form H.
- 8. Terms and Conditions for Certification of Bull.—(1) The Bull used for semen production, in the semen stations, shall be selected for induction as per the specifications and standards mentioned in Minimum Standard Protocol for semen production notified by the Government of India, from time to time.
- (2) The concerned semen station shall carry out the Bull Soundness Examination (BSE) of the Bull, before proceeding for certification of the Bull.
- (3) The concerned semen station shall ensure that the Bull used for semen production for artificial insemination shall be registered on the online mechanism, available for the purpose. It shall be mandatory for the semen stations to tag unique identification number securely and permanently to the Bull at all times.
- (4) It is mandatory for the semen station to carry out the karyotyping of the Bull before induction in semen station or any breeding programme.
- (5) The semen station shall ensure that the Bull shall be tested against genetic diseases as specified in Minimum Standard Protocol for semen production from the reputed Labs of the Central Government or the State Government.
- (6) The Bull procured for semen production in the semen station shall have Progeny Testing (PT) or Pedigree Selection (PS) record in accordance to the breeding policy of the State.
- **9.** Duplicate Registration Certificate.—(1) Every application for duplicate registration certificate of semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, assisted reproductive technology expert, semen bank, artificial insemination service provider and artificial insemination technician shall be submitted alongwith fee of rupees one thousand.
- (2) The Authority or District Deputy Commissioner of Animal Husbandry, as the case may be, shall maintain a permanent record of applications for duplicate certificate of registration in Form I.
- 10. Operation of Funds.—(1) The financial transaction of the Authority shall be governed by the State Financial Rules and Regulations. The Bombay Finance Rules, 1959, the Maharashtra Treasury Rules, 1968, the Maharashtra Contingency Expenses Rules, 1965, the Financials Powers Regulations,

1978 and any other Rules and Regulations as applicable to the Government of Maharashtra shall apply mutatis mutandis to the Authority.

- (2) Member Secretary, Maharashtra Bovine Breeding Regulatory Authority shall be responsible for maintaining accounts books, relevant subsidiary registers, vouchers, and other related documents in the same manner as are maintained in the transaction of Government business under control and supervision of the Chairperson of the Authority.
- (3) The details of income received and the expenditure incurred during every quarter shall be submitted in the meeting before the Authority for approval.
 - (4) No expenditure shall be incurred without the approval of the Authority.
- **11.** *Annual Report of Authority.-* (1) The Authority shall prepare, the annual report along with the annual financial statements during the previous financial year.
- (2) The annual report shall be submitted to the State Government by the 31st July of the following year.
- 12. Maintenance of Records.- (1) The record to be maintained by every semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, assisted reproductive technology expert, semen bank, artificial insemination service provider and artificial insemination technician on the line of general principles of Book Keeping and Accountancy:

Provided that, artificial insemination technicians employed in the State Department of Animal Husbandry are not required to maintain the record of artificial insemination separately.

- (2) Every semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, assisted reproductive technology expert, semen bank, artificial insemination service provider and artificial insemination technician shall furnish the records annually and half yearly returns in duplicate before 31st July of the same year and 31st January of the next year to the Authority or District Deputy Commissioner of Animal Husbandry, as the case may be.
- (3) The Authority or District Deputy Commissioner of Animal Husbandry, as the case may be, may inspect any registered semen station, embryo transfer or in-vitro fertilization laboratory, artificial insemination training institute, assisted reproductive technology service provider, assisted reproductive technology expert, semen bank, artificial insemination service provider and artificial insemination technician at any time.
- **13.** Compounding of offences.- (1) Accused person may, either before or after the institution of any prosecution, make an application under section 21 of the Act for compounding of an offence.
- (2) On receipt of an application under sub-rule (1), after verification of it, the Authority may call for a report from the concerned Deputy Commissioner, Animal Husbandry with reference to the particulars of offence furnished in the application or any other information which may be considered relevant for the examination of such application.
- (3) The Authority or the member or the officer appointed by Authority in this behalf, after taking into account the contents of the said application, may, by order, on being satisfied that the applicant has co-operated in the proceedings before him and has made full and true disclosure of facts relating to the case, allow the application indicating the compounding amount and grant him immunity from prosecution or reject such application with its reasons, within ninety days of the receipt of the application.
- (4) The application shall not be decided under sub-rule (3) without giving an opportunity of being heard to the applicant.
- (5) The applicant shall, within a period of seven days from the date of the receipt of the order under sub-rule (3), pay the compounding amount as ordered by the Authority or the member or the officer appointed by Authority, as the case may be and shall furnish the proof of such payment to him.

- (6) In case the applicant fails to pay the compounding amount within the time specified in subrule (5), the order made under sub-rule (3) shall be vitiated and be void.
- (7) Immunity granted to a person under sub-rule (3) may, at any time, be withdrawn by the Authority or the member or the officer appointed by Authority, if he is satisfied that such person had, in the course of the compounding proceedings, concealed any material particulars or had given false evidence. Thereupon such person may be tried for the offence with respect to which immunity was granted or for any other offence that appears to have been committed by him in connection with the compounding proceedings and the provisions of the Act shall apply as if no such immunity had been granted.
