OFFICE MEMORANDUM

Subject: Constitution of Committees for administration of National Digital Livestock Mission (NDLM) at State, District and Block Level.

The Department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India, has established the National Digital Livestock Mission (NDLM) portal - Bharat Pashudan as unified, transparent, and accountable digital infrastructure for livestock data management across the country. The vaccination and delivery of other health and breeding services for the livestock is being monitored through NDLM;

2. Coordination between various departments at State, District, Block level is essential for successful and effective implementation of NDLM - Bharat Pashudan.
3. Therefore State/UT Governments are requested to constitute following committees at State, District and Block level:
4. The State Level Steering Committee (SLSC):

vii.	MD, State Milk Federation -	Member
viii.	Director (AH&VS) of the State/UT -	Member Secretary

(b) The Roles and Responsibilities:

- i. Provide overall policy guidance for implementation of NDLM in the state.
- ii. Guide the District level NDLM Committees through directives or guidelines.
- iii. Monitor the implementation and outcomes of the programme across the state.
- iv. Recommend corrective measures for effective implementation.

The Committee will hold its meetings at least once in six months.

(a) The composition:

v.	MD, State Milk Federation -	Member
vi.	Director (AH&VS) of the State/UT -	Member Secretary

(b) Roles and Responsibilities:

- i. Provide overall guidance for implementation of NDLM in the District.
- ii. Guide the Block level NDLM Committees in implementation of the programme.
- iii. Monitor the implementation and outcomes of the programme in the district.
- iv. Recommend corrective measures for effective implementation.

The DLIC will hold meeting at least once in a month.

(b) Roles and Responsibilities:

- i. Monitoring the implementation of the NDLM in all the village panchayats and urban areas of the blocks.
- ii. Monitor the implementation and outcomes of the programme in the district.
- iii. Recommend corrective measures for effective implementation.

The Committee will hold its meetings at least once in a month.
