No. RTR. 1088/1896-(197)-II -In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Maharashtra is hereby pleased to make the following rules for regulating recruitment to the post of the Secretary to the Government of Maharashtra. Law and Judiciary Department, and Comembrancer of Legal Affairs, namely:-
