C. P. WHEREAS it is expedient to repeal the Central Provinces and Berar State Aid to
and Industries Act, 1933 in its application to the Vidarbha region of the State of Bombay
Berar and the Hyderabad State Aid to (Small-Scale and Cottage) Industries Act, 1956 in so

1. This Act may be called the Central Provinces and Berar State Aid to Industries and the Hyderabad State Aid to (Small-Scale and Cottage) Industries (Partial Repeal) Act, 1959. Short title.

C. P. **2.** The Central Provinces and Berar State Aid to Industries Act, 1933 and the Hyderabad State Aid to (Small-Scale and Cottage) Industries Act, 1956 (hereinafter referred to as "the said Acts") in so far as the said Acts relate to the State aid given in the form of loans are hereby repealed. Partial repeal of C. P. and Berar Act XII of 1933. and Hyd. VII of 1956.

3. Notwithstanding such repeal of the said Acts and rules and orders made thereunder shall continue to have effect in respect of State aid given in the form of loans under the said Acts before the commencement of this Act. Savings.

4. If any difficulty arises in giving effect to the provisions of this Act, the State Government may, by order published in the *Official Gazette*, make such provision as appears to it to be necessary for removing the difficulty. Removal of difficulties.
