#### BOMBAY ACT No. LXVII OF 19591

[The Central Provinces And Berar State Aid to Industries and the Hyderabad State Aid to (Small-Scale and cottage) Industries (Partial Repeal) Act, 1959.]

This Act received assent of the Governor on the 21st December 1959; assent was first published in the "Bombay Government Gazette", Part IV Extraordinary on the 24th December 1959.]

An Act to repeal the Central Provinces and Berar State Aid to Industries Act, 1933. and the Hyderabad State Aid to (Small-Scale and Cottage) Industries Act, 1956 in so far as the said Acts relate to State aid given in the form of loans.

C. P. WHEREAS it is expedient to repeal the Central Provinces and Berar State Aid to Industries Act, 1933 in its application to the Vidarbha region of the State of Bombay and the Hyderabad State Aid to (Small-Scale and Cottage) Industries Act, 1956 in so far as the said Acts relate to State aid given in the form of loans; It is hereby enacted in the Tenth Year of the Republic of India, as follows:—

- **1.** This Act may be called the Central Provinces and Berar State Aid to Industries Short title. and the Hyderabad State Aid to (Small-Scale and Cottage) Industries (Partial Repeal) Act, 1959.
- C. P. and Berar Act Hyderabad State Aid to (Small-Scale and Cottage) Industries Act, 1933 and the Hyderabad State Aid to (Small-Scale and Cottage) Industries Act, 1956 (hereinafter referred to as "the said Acts") in so far as the said Acts relate to the State aid given in the form of loans are hereby repealed.

  Partial repeal of C. P. and Berar Act XII of 1933. and Hyd. VII of 1933. Hyd.
  - 3. Notwithstanding such repeal of the said Acts and rules and orders made Savings. thereunder shall continue to have effect in respect of State aid given in the form of loans under the said Acts before the commencement of this Act.
  - **4.** If any difficulty arises in giving effect to the provisions of this Act, the State Removal of Government may, by order published in the *Official Gazette*, make such provision as difficulties. appears to it to be necessary for removing the difficulty.
