An Act to amend the Symbiosis Skills and Open University Act, 2017

WHEREAS, it is expedient to amend the Symbiosis Skills and Open Mah. University Act, 2017, for the purposes hereinafter appearing; it is hereby XXXVII enacted in the Seventy-first year of the Republic of India as follows: of 2017.

- 1. This Act may be called the Symbiosis Skills and Open University Short title. (Amendment) Act, 2020.
- 2. In the long title of the Symbiosis Skills and Open University Act, Amendment Mah. XXXVII 2017 (hereinafter referred to as "the principal Act"), for the word "Open" the of long title of word "Professional" shall be substituted.

3. In the preamble to the principal Act, for the word "Open" the word of preamble of "Professional" shall be substituted.

4. In section 1 of the principal Act, in sub-section (1), for the word of section 1 of "Open" the word "Professional" shall be substituted.

Amendment of section 2 of of 2017.

5. In section 2 of the principal Act, in clause (xxix), for the word "Open" Mah. XXXVII the word "Professional" shall be substituted.

Amendment of section 3 of Mah. XXXVII of 2017.

- In section 3 of the principal Act,—
- (1) in sub-section (1) for the word "Open" the word "Professional" shall be substituted;
- (2) in sub-section (2), for the word "Open" the word "Professional" shall be substituted;
- (3) in sub-section (5), for the word "Open" the word "Professional" shall be substituted.
