An Act to provide for the levy of fees for the use of 2*14 inding places.

WHEREAS it is expedient to provide for the levy of fees for the use of 2*landing Preamble. Places in certain ports in the 3[State of Bombay]; It is hereby enacted as follows:—

- 1. This Act shall be called the Bombay Landing and Wharfage Fees Act, 1882. Short title.
- 2. 4[() 5[It shall extend to any ports] in the 6[Bombay area of the State of Local extent. Maharashtra] to which '[Government] may from time to time. by notification in the * Official Gazette.] extend the Act :

⁹[Provided that on the commencement of the Bombay Landing and Wharfage LV of Fees (Unification and Amendment) Act, 1959, it shall extend at once to the port 1959 in which the Okha Port Rules as continued in force by the Bombay Merged States Bom. (Laws) Act, 1950 were in force immediately before such commencement.]

4[(2) It shall extend to any ports in the rest of the 10[State of Maharashtra] to which Government may, from time to time by notification in the Official Greate extend the Act:

Provided that on the commencement of the Bombay Landing and Wharfage LV of Fees (Unification and Amendment) Act, 1959, it shall extend at once to those 1959, ports in which the Saurashtra Ports (Administration) Ordinance, 1950 and the Sau. Bombay Landing and Wharfage Fees Act, 1882, as applied to the Kutch area were IX of in force immediately before such commencement.1

7. The officers and persons whose duty it may be to levy fees under this Act Powers. privileges shall have the same powers for collecting and enforcing payment of the same and liabi-ities of as are exercisable under the provisions of any law, for the time being in force, in officers respect of duties of sea-customs by the Collector of Customs and his subwho collect ordinates, and shall have the same privileges and be subject to the same liabilities fees. in respect of anything done by them in collecting and enforcing payment of the said fees as the said Collector of Customs and his subordinates have, or are liable to, under the provisions of any such law,

- 9. 3[The Chief Ports Officer, 4[Maharashtra State]] may, with the previous make sanction of Government, from time to time make, and from time to time alter or Laws. repeal. bye-laws not inconsistent with the provisions of this Act:
 - (a) regulating the use of every landing-place to which this Act applies;
 - (b) providing for the management of the traffic over, on or about and to and from every such landing-place;
 - ⁵[(c) regulating the collection and remittance of the fees leviable under all or any of the provisions of this Act; and
 - $oldsymbol{old}[(d)]$ generally for the guidance of all persons in matters connected with the enforcement of this Act.

The bye-laws so made, and every alteration of same and every order repealing the same or any portion thereof, shall be published in the [Official Gazette]
