further to amend the Maharashtra Prohibition Act.

WHEREAS, both Houses of the State Legislature were not in session;

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action further to amend the Maharashtra Prohibition Act, for the purposes hereinafter appearing; and therefore, promulgated the Maharashtra Mah. Ord. Prohibition (Amendment) Ordinance, 2017 on the 17th July 2017;

AND WHEREAS it is expedient to replace the said Ordinance, by an Act of the State Legislature; it is hereby enacted in the Sixty-eighth Year of the Republic of India as follows:—

Short title and commencement.

- (1) This Act may be called the Maharashtra Prohibition (Amendment) Act, 2017.
 - (2) It shall be deemed to have come into force on the 17th July 2017.

Amendment of 1949.

2. In section 134A of the Maharashtra Prohibition Act, in sub-section XXV of section 134A of XXV of (2), in clause (c), for the words "Tahsildar of the area" the following shall be 1949 . substituted, namely:

> "Tahsildar or any officer not below the rank of Group-B Officer of the State Government authorised by the Tahsildar of the area".

Repeal of Mah. Ord. XV saving.

- 3. (1) The Maharashtra Prohibition (Amendment) Ordinance, 2017 is Mah. of 2017 and hereby repealed. of 2017.
 - (2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the corresponding provisions of the Maharashtra Prohibition Act, as amended by the said XXV of Ordinance, shall be deemed to have been done, taken or, as the case may be, issued under the corresponding provisions of the said Act, as amended by this Act.
